APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE FINAL SENIORITY LISTS OF DEPUTY DIRECTOR/DISTRICT OFFICER (BS-18) OFFICERS/TREASURY ACCOUNTS OF TREASURY ESTABLISHMENT KHYBER PAKHTUNKHWA AS IT STOOD ON 31.12.2021 ISSUED VIDE FINANCE DEPARTMENT KHYBER PAKHTUNKHWA NOTIFICATION NO.SO(ESTT)FD/1-45/2020 DATED 12-07-2023 FOLLOWED BY ANOTHER SENIORITY LIST BEARING NO. SO(ESTT-I)FD/1-45/S.LIST/2022 DATED 07.09.2023 WHEREBY AN OFFICER JUNIOR THAN APPELLANT WAS DECLARED SENIOR.

PRAYER IN APPEAL.

ON ACCEPTANCE OF THIS SERVICE APPEAL THE RESPONDENTS MAY VERY GRACIOUSLY BE DIRECTED THAT THE IMPUGNED SENIORITY LISTS MAY BE REVISED AND SENIORITY POSITION OF THE APPELLANT BE KEPT INTACT/ MAINTAINED AS PER THOSE UNDISPUTED SENIORITY LISTS ISSUED/ REMAINED DURING THE LAST 10 YEARS.

FACTS OF THE APPEAL:

RESPECTFULLY SHEWETH:

- That the Public Service Commission, Khyber Pakhtunkhwa separately advertised 01 post of Female Assistant Treasury Officer (BPS-17) and 04 Posts of Assistant Treasury Officers BPS-17 (both Sexes) vide S. No 35 & 36 of the advertisement No 06/2008 dated 18.08.2008 and after necessary process, appointments of 5 successful candidates were made, who accordingly taken the charge. Copy of advertisement is attached at Annexure-A.
- 2. That the Finance Department issued first Tentative Seniority List of Assistant Treasury Officer's (BPS-17) as it stood on 28.02.2011, wherein the appellant was placed at S. No 38 of the list i.e at 4th position of seniority amongst the 05 newly appointed Assistant Treasury Officers. The said Seniority list was duly circulated and representations invited, if any, but not objected by any of the 05 newly appointed Assistant Treasury Officers, therefore, a Final Seniority List was issued, wherein the appellant was again placed at the same seniority position. Thereafter Tentative/final seniority lists were issued for 10 consecutive years till 2020 with no any objection by anyone about seniority position of the newly appointed 05 Assistant Treasury Officers. Copies of the Tentative/ Final Seniority lists as it stood on 28.02.2011 and 31.12.2020 are enclosed at Annexure- B, C, D and E.

- **3.** That after a lapse of 10 years, one Mr. Qaisar Imad, junior than the appellant in all the seniority lists issued during the last 10 years, made an application dated 25.03.2021 to the Secretary Finance Department, which was forwarded by the Director, Treasuries & Accounts Khyber Pakhtunkhwa, with the remarks that under section 22 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 read with Khyber Pakhtunkhwa Civil Servants (Appeal) Rules 1986, an appeal relating to the term and conditions of Service can only be filed within a period of 30 days therefore appeal was time barred and leaned to have been filed. Copy of the Directorate of Treasuries and Accounts letter dated 11.06.2021 is enclosed at Annexure-F.
- 4. That on the basis of final & undisputed Seniority lists of Assistant Treasury Officer's, 12 officers including the appellant was promoted as District Accounts Officers (BPS-18) on the same Inter-se-seniority position as maintained against the lower post of Assistant Treasury Officers. Copy of the promotion order dated 09.08.2021 enclosed at Annexure G.
- 5. That during 02/2022, a tentative seniority list of Deputy Director/District Accounts Officers/Treasury Officer (BPS-18) as it stood on 31.12.2021 was issued, against which the said officer who was junior than the appellant again made a representation i.e after lapse of ten years, which was badly time barred and not entertain able. In this seniority list, the appellant was also enjoying the same seniority position at its proper place. Copies of the Tentative Seniority List as it stood on 31.12.2021 are enclosed at Annexure H.
- 6. That the appellant intended to be a party to the case and as such applied for provision of related documents of the appeal so as to defend her case but was informed that the said application was premature and cannot be provided, hence become unable to defend her case. Copies of the application dated 13.01.2023 and Finance Department letter dated 09.02.2023 are enclosed at Annexure at I and J.
- 7. That in spite of terming the application as time barred, a final Seniority list of Deputy Director/District Accounts Officers/Treasury Officer (BPS-18) as it stood on 31.12.2021, was Issued vide Finance Department Khyber Pakhtunkhwa letter No. SO (Estt-I)FD1- 45/2020 dated 12.07.2023 wherein the above named officer Junior to the appellant was placed/ declared senior than appellant, without showing any reason or providing any opportunity of hearing to the appellant. As per remarks column of the impugned Seniority List, the decision has been made on the basis of advice of Establishment and Law Departments Khyber Pakhtunkhwa but no copies of the same were provided to the appellant, hence an application dated 14.07.2023 was made by the appellant for provision of the said documents but declined to provide vide Finance Department letter dated 08.08.2023. Copies of the seniority List as it stood on 31.12.2021, application dated 14.07.2023 and Finance Department letter dated 08.08.2023 are enclosed at Annexure-K, L and M.
- 8. That in the meantime another seniority list of Deputy Director/District Accounts Officers/Treasury Officer (BPS-18) as it stood on 31.12.2022 was issued with the same modified seniority position of the appellant which has also been objected vide Appeal dated 20.09.2023 which has also not been responded till yet. Copy of the seniority List as it stood on 31.12.2022 is enclosed at Annexure N.
- **9.** That having aggrieved with the decision/order of affecting/ modifying seniority position of the appellant, a Departmental Appeal dated 10.08.2023 was filed before the appellate authority. Copies of the Departmental Appeal dated 10.08.2023 followed by another one dated 21.09.2023 are enclosed at Annexure O.

10. That the Departmental Appeal, so filed, was not responded during the statutory period of 90 days, hence the instant Service Appeal inter alia on the following grounds:-

GROUNDS FOR APPEAL

- **A.** That the Final & undisputed Seniority position of the appellant maintained towards the lower post of Assistant Treasury Officer's during the long period of 10 years from 2011 to 2020 was never challenged or objected therefore any such application or appeal for modification of Seniority position at much belated stage was badly time barred and cannot be entertained in any way.
- **B.** That on the basis of above mentioned final & undisputed Seniority lists of Assistant Treasury Officer's, 12 officers including the appellant was promoted as District Accounts Officers (BPS-18) on the same Inter-se-seniority position as maintained against the lower post of Assistant Treasury Officers.
- **C.** That there is no provision in the laws/Rules to modify or change seniority position of the appellant when she has already been promoted and holding higher post of District Accounts Officer BPS-18.
- D. That in the instant case, a unilateral decision has been made without giving the appellant the desired relevant documents and opportunity of personal hearing, therefore condemned unheard. Such type of decisions has no value in the eyes of Law. In this connection, certain Judgments of the Supreme Court of Pakistan, clearly indicate that non-provision of relevant documents and chance of hearing to the affected person will lead the decision in-valid.
- E. That the decision made by the Respondent No. 4 regarding modifying the seniority position, has no legal value, as in case of BPS 18 officers, he was not the competent authority to do so and that also on a time barred application.
- **F.** That under section 22 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 read with Khyber Pakhtunkhwa Civil Servants (Appeal) Rules 1986, an appeal relating to the term and conditions of Service can only be filed within a period of 30 days therefore the appeal was badly time barred and not entertain able.
- **G.** That as appears from the Seniority Lists, the same have been issued under Section 8(!) of the Khyber Pakhtunkhwa Civil Servant Act, 1973 where there is no provision in this particular section of Law to revise, modify or re-call the Final Seniority lists when issued.
- **H.** That as per Judgment of the Punjab Service Tribunal, contained in 1983 PLC (C.S.) 200 seniority position in 6 consecutive Seniority Lists not challenged in the past-Civil Servant, in circumstances, held, estopped to claim new seniority position.
- I. That as per judgments of the Honorable Supreme Court of Pakistan, when the right to sue a person from or through whom the plaintiff derives his right to sue has become time barred, no fresh period of limitation can start for such plaintiff in the same manner. Period of limitation runs even in void orders and appeal is to be made within the period of limitation, whereas in the instant case application/appeal has been made after issuance of 10 consecutive Seniority lists.
- **J.** That as per section 21 of the General Clauses Act, 1987, once an order has been issued in good faith and without any fault or bad intention of the person concerned, the same can't be withdrawn, reversed or recalled.
- K. That the order for modifying seniority position of the appellant in remarks columns of seniority list, without issuing proper speaking and reasoned order has no legal value.

Further all the Final seniority lists issued during 2011 to 2020 have already attained finality and promotion to the higher post of District Accounts Officer BPS-18 also made on the basis of those final and undisputed Seniority lists, therefore the same cannot be disputed, in any way.

In view of the above, it is prayed that on acceptance of this service appeal, the decision about modifying/ disturbing Seniority Position of the appellant in violation of all Laws, Rules and Judgments of the Superior Courts, may very kindly be set aside and previous seniority position maintained for the last 10 consecutive years, restored.







With due respect, it is state that a final Seniority list of Deputy Director/District Accounts Officers/Treasury Officer (BPS-18) as it stood on 31.12.2021, has been issued vide Finance Department letter No. SO(Estt-I)FD1-45/2020 dated 12.07.2023 received on 14.07.2023 wherein one Mr. Qaisar Imad, Junior to me has been placed/ declared senior than me, after issuance of 10 consecutive seniority lists without providing any opportunity of hearing. Copies of the letter dated 12.07.2023 along with Seniority list is enclosed at Annexure-I.

2. In this connection, it is submitted:-

Sir,

That the Public Service Commission, Khyber Pakhtunkhwa separately advertised 01 post of i. Female Assistant Treasury Officer (BPS-17) and 04 Posts of Assistant Treasury Officers BPS-17 (both Sexes) vide S.No 35 & 36 of advertisement No 06/2008 dated 18.08.2008 and after necessary process, appointments made and charge taken.

That, the Finance Department issued first Tentative Seniority List 2011 of Assistant ii. Treasury Officer's (BPS-17) as it stood on 28.02.2011, wherein I was placed senior to Mr. Qaisar Imad. The said Seniority list was duly circulated and representations invited, if any but not objected by any of the 05 newly appointed Assistant Treasury Officers, therefore, a Final Seniority List was issued, wherein I was again placed senior than Mr. Qaisar Imad vide S.No 37 and 38 of the list and thereafter 10 consecutive Seniority Lists were issued till 2020 with no any objection on tentative or final Seniority Lists and as such I constantly remained senior than Mr. Qaisar Imad. Copies of the letter and Tentative/ Final Seniority lists as it stood on 28.02.2011 and 31,12.2020 are enclosed at Annexure II and III.

That after a lapse of 10 years, Mr. Qaisar Imad made an application dated 25.03.2021 to iii. L

the Secretary Finance Department, which was forwarded by the Director, Treasuries & Accounts Khyber Fakhtunkhwa, with the remarks that under section 22 of the Khyber

Pakhtunkhwa Civil Servant Act, 1973 read with Khyber Pakhtunkhwa Civil Servants (Appeal) 1× ·

Rules 1986, an appeal relating to the term and conditions of Service can only be filed within a period of 30 days therefore appeal was time barred. Copy of the Directorate of Treasuries

- and Accounts letter dated 11.06.2021 is enclosed at Annexure IV. 1
- That on the basis of above mentioned final & undisputed Seniority lists of Assistant Treasury iv. Officer's, 12 officers including we both were promoted as District Accounts Officers (BPS-18) on the same Inter-se-seniority position as maintained in the lower post of Assistant Treasury Officers. Gopy of the promotion order dated 09.08.2021 is enclosed at Annexure

During 2022, when the tentative seniority list of District Accounts Officers was 3. circulated, he made objection which was not entertainable on the following grounds:-

- a. That the Final & undisputed Seniority position maintained for the lower post of Assistant Treasury Officer's during the long period of 10 years was never challenged therefore appeal of Mr. Qaisar Imad at this belated stage was badly time barred and cannot be entertained in any way.
- b. That the Seniority Lists have been issued under Section 8(I) of the Khyber Pakhtunkhwa Civil Servant Act, 1973 where there is no provision in this section of Law to revise, modify or re-call the Final Seniority list when issued.
- c. That when Mr. Qa sar Imad made appeal for modification of Seniority list, I intended to be a party of the case and as such applied for provision of related documents of the appeal so as to defend my case but was informed that the said application was premature, hence become unable to defend my case. Copies of application and Finance Department reply are enclosed at Annexure at VI and VII.
- d. That as per remarks column of the impugned Seniority List, the decision has been made on the basis of advice of Establishment and Law Departments but no copies of the same were provided to me, hence an application dated 14.07.2023 was also made for the purpose but decline to provide vide Finance Department letter date 08.08.2023. Copy of letter is enclosed at Annexure VIII.
- e. That as Per Judgment of the Punjab Service Tribunal, contained in 1983 PLC (C.S.) 200 seniority position in 6 consecutive Seniority Lists not challenged in the past-Civil Servant, in circumstances, held, estopped to claim new seniority position. Copy of the Judgment is enclosed at Annexure-IX.
- f. That as per judgment of the Honorable Supreme Court of Pakistan, contained in Judgment 2022 SCMR 1282 when the right to sue a person from or through whom the plaintiff derives his right to sue has become time barred, no fresh period of limitation can start for such plaintiff in the same manner. **Period of limitation runs even in void orders and appeal is to be made within the period of limitation**, whereas in the instant case appeal has been made after issuance of 10 consecutive Seniority lists. Copy of the Judgment is enclosed at Annexure X.
- 9. That as per Judgment of the august Supreme Court of Pakistan contained in 2020 SCMR 2046 period of Limitation would run even against void order affecting rights of any person –no one could seek condonation of delay by challenging solely on the said ground—Aggrieved person who filed a belated claim against an allegedly void order would have to first plead his knowledge thereof, and then prove the same by cogent and reliable evidence, so as to legally justify his claim to be within the period of limitation from the date of his knowledge. Copy of the Judgment is at Annexure- XI.
- h. That the applications were invited through separate advertisement No 35 and 36, processed as such and appointments made accordingly. Nothing intimated as to how both the merit lists were amalgamated and the candidates of a particular quota is to be given seniority over the 2nd one. Furthermore the merit list of Public Service Commission clearly shows that it has been issued for male candidate under advertisement No 06/2008 S. No 36 but my name was also inserted in the same at S. No 05 with no justification. Copy of merit list is attached at Annexure XII.
- i. That as per section 21 of the General Clauses Act, 1987, once an order has been issued in good faith and without any fault or bad intention of the person concerned, the same can't be withdrawn, reversed or recalled.

- That on the appeal of Mr. Qaisar Imad a unilateral decision has been made without giving me reasonable opportunity of personal hearing, therefore condemned unheard. Such order has no value in the eyes of Law. In this connection, certain Judgments of the Supreme Court of Pakistan, contained in 2009 PLC (C.S) 161 and 2022 SCMR 1387 clearly say that non-provision of chance of hearing to the affected person will lead the decision invalid. Copy of the judgments are enclosed at Annexure XIII and XIV.
- k. That the order for modifying my seniority position has no legal value as all the Final seniority lists issued during 2011 to 2020 have already attained finality and promotion to the higher post of District Accounts Officer BPS-18 also made on the basis of those Final and undisputed Seniority lists.

In view of the above, it is prayed that the decision about modifying my Seniority Position in violation of all Laws, Rules and Judgments of the Superior Courts, may very kindly be set aside and my previous seniority position restored.

2. In this connection, it is humbly stated that I have already preferred a Departmental Appeal dated 10.08.2023 against the disputed Seniority List of the same cadre as it stood on 31.12.2021 to your good offices containing detailed reservations/objections supported by relevant authorities of the superior courts and rules etc., copy of which is enclosed at Annexure B.

In view of the above, it is humbly prayed that my instant Departmental Appeal may very kindly be considered along with my earlier appeal dated 10.08.2023 (Annexure B) and seniority position illegally disturbed/revised on a time barred application may kindly be reversed and the previous seniority position held for continues 10 years from 2011 to 2020 may be restored.
