The appellant appeared in a special/Supplementary Exam arranged for the failed/compart Inspectors and passed the said Exam (Annex-II) by the end of January 2023 and subsequently he got retired from Government service on attaining the age of superannuation in February, 2023.

The DPC meeting is normally arranged for the promotion of all eligible employees, but not individually, for which participation of various departments including Finance & Establishment is required. Detailed Working Papers along-with supporting documents need to be prepared and thoroughly examined well before the DPC meeting. Hence, it is a time taking process.
