That the appellant has filed this service appeal under section 4 of the Services Tribunal Act, 1974 against the impugned Seniority List Dated: 12-10-2021 etc., which needs reply and the same as under.

Preliminary Objections:

- 1. The appellant has no cause of action to file the present service appeal against the respondent.
- 2. The appellant's seniority was determined in 2012.
- 3. The service appeal is time barred.
- 4. The appellant has hidden important information from the honorable Tribunal in the service appeal.
- 5. The Seniority List-2012 of management cadre officers was kept intact by the Peshawar
 High Court in WP No 362/2013 and WP No 2049/2014, which were filed by an officer selected against Category A (Open Market Quota).
- 6. The service appeal and material placed at file are against law and facts.
- 7. The appellant has not come to the honorable Tribunal with clean hands.
- 8. The appellant has suppressed some important material and facts from the honorable Tribunal.
- 9. The appellant is estopped by his own conduct to bring the present service appeal against the respondents.

- 8. Incorrect. The KP Public Service Commission communicated revised merit of EDOs (BS-19), separately for Category A and B selectees of advertisement No 05/2009 vide consolidated letter No.5575 Dated: 10-02-2012 (ANNEX-A). All selected officers under Category A (Open Market Quota) were declared junior to officers selected against Category B (Teaching Cadre Quota) in the Seniority List notified in 2012 (ANNEX-B).
- 9. Incorrect. Para No. 8 above contains contradictory statement to that of Para No. 9. How come the seniority be notified on 08-05-2012 based on a letter issued by the KP Public Service Commission on 02-12-2013?

The Para-9 of the appeal is correct to the extent that the name of the appellant was not mentioned by the time the seniority was notified in 2012 but the order of seniority would not change even inclusion of name on the later stage.

- 10. Incorrect. The appellant's appeal on the seniority was rejected by Department (ANNEX-C) and the appellant kept this fact hidden from the honorable Services Tribunal.
- 11. Need no comments.
- 12. Incorrect. The impugned tentative seniority list of BS-19 Management Cadre Officers as it stood on 12-10-2021 (ANNEX-D) is a defective document, as not issued by the competent authority. Anyhow, the seniority order of serial No 1-5 is correct being based on the seniority notified in 2012.
- **13.** Incorrect. The appellant is referring to some document of the Public Service Commission dated 02-12-2013 as Seniority List which is totally incorrect.

It is pertinent to mention that only 05 officers of BS-19 are left in service today from the Seniority List 2012 of EDOs (BS-19). The 22 officers are no more part of the seniority List 2012 as per detail below:

- i) 05 officers were promoted to BS-20 in three different meetings of Provincial Selection Boards (PSB).
- ii) 16 retired on superannuation.
- One officer excluded due to in-service death. So, there are only 05 serving BS-19 officers left, out of 27 selected EDOs (BS-19), including the appellant and both the Respondent No. 6 & 7. The fact is that the appellant's seniority was determined in 2012 and he would fall to Serial No.25 of the Seniority List 2012.
- 14. The impugned tentative seniority list 12-10-2021 is a defective document, as not issued by the competent authority. Recently, a tentative seniority of BS-19 officers of management cadre has been issued (ANNEX- E) by the E&SE Department, being competent authority.
- 15. Need no comments.
- 16. Correct.
- 17. Need no comments.
- 18. Incorrect, the authority notified the seniority list vide Notification SO(S/M) SED/4-25/2012/Final Seniority list of MC(BS-19) dated 08-05-2012, whereas the appellant has concealed the fact from this honorable Tribunal regarding rejection of his departmental appeal in 2019.
- 19. Incorrect. The seniority of the appellant and the Respondent No. 6 & 7 had already been determined and accordingly notified in 2012. The appellant was selected in 2010, appointed in 2011, seniority notified in 2012, departmental appeal rejected in 2019, and filing service appeal in 2023 is beyond logic and understanding.

The service appeal of the appellant is not maintainable on the following grounds that:

i) The Peshawar High Court rejected the claim, made through WP NO 362/2013 and WP 2049/2014, filed by Mr. Ghulam Qasim, an officer selected as EDO (BS-19) under Category A (Open Market Quota), the category of selection to which the appellant belongs too.





- ii) 05 Officers of the Seniority List 2012 were promoted to BS-20, and 16 officers got retired.
- iii) Twelve years have elapsed to the approved & notified Seniority List 2012 of BS-19 Management Cadre Officers, thus making it time barred.
- iv) The appellant made the same plea as was taken up in WP. 362/2013 and 2049/2014.
- v) The appellant's appeal to the Govt. was rejected in 2019.
- vi) The appellant files appeal to all new Secretaries and Chief Secretaries to avail benefit of doubt.
- vii) Seniority of Respondent No. 6 is final & undisputed as per seniority list 2012.
- viii) The impugned seniority has no legal binding, as not issued by the competent authority.

Thus, the only reason for the instant service appeal is to delay the process of law and to deny the valuable right of the Respondent No.6. It is very humbly requested that the instant service appeal should be dismissed at special cost.
