The appellant alongwith twenty three other persons were appointed in the earstwhile FATA Tribunal who was removed from service vide order dated 17.01.2022. The appeal of twenty other similarly placed employees was decided by the Tribunal on 03.03.2023. Operating Para of the judgment is reproduced below;

For what has been discussed above, we hold that the appellants have not been treated in accordance with law and thus the impugned orders are not sustainable. On acceptance of all theses appeals we set aside the impugned orders and direct reinstatement of all the appellants with back benefits. Costs shall follow the event. Consign.

- 03. Since respondents in the instant appeal, facts and legal points raised are the same, therefore, the instant appeal is also accepted and the impugned orders are set aside directing the respondents to reinstate the appellant with back benefits. Costs shall follow the event. Consign.
