



Now he regain health and is fit for performing his duties. Therefore, he requested DPO Mansehra by filing departmental request/representation on 02.03.2023 for constitution of medical board and reinstatement which is not responded till 27.06.2023, therefore, he filed instant appeal under Section 4 of Khyber Pakhtunkhwa Service Tribunal Act, 1974. He further argued that under CRS 519 a civil servant if regain his health could apply for reinstatement and for constitution of medical board to determine his fitness for performance of duties. Points raised need consideration. Therefore, appeal in hand is admitted for regular hearing subject to all legal objections. The appellant is directed to deposit security fee within 10 days. Thereafter, notices be issued to respondents for submission of written reply/comments. Respondents be summoned through TCS the expenses of which be deposited by the appellant. Adjourned.
