2. That the appellant has been discriminated against many times since then till 2008, when the services of the appellant were regularized and till date.
3. That various people have been appointed on regular basis in the Respondents' department since the year 1999 till 30 June, 2001 and up-till the year 2008. Due to their regular appointment in the department they became illegible for annual increment, special additional allowance, GP Fund, Pension, Gratuity etc. However, the appellant was initially appointed on contract basis in the year 1999 due to which was kept bereft of all these benefits.
4. That during this period, 1999 till 2008, various correspondences was made between the Directorate and the District Offices regarding the vacant posts. However, no information was exchanged regarding the availability of regular posts and contract posts among the total available posts. Neither any data was assimilated regarding the number of regular employees and contract employees working in district offices, nor the district offices sent any information to the Directorate in this regard. But, the district offices submitted to the Directorate only the list of vacant posts in their offices, and due to this anomaly the Directorate recruited employees on contract basis against the clear vacant regular posts.
5. That after the 18th amendment in 2010 the Population Welfare Department was devolved onto provinces. Since then, all the appointments have been made in the light of the Provincial Government Policy letter No: ED/(505R -11)12-1/2002 Dated 26 - 10 - 2002.
6. That the appellant was initially appointed on contract basis for two (02) years and thereafter got extension few times for various length of periods from time to time the contract of the appellant was renewed which also includes contract that were assigned in the period during 2001 to 2005 (Copy Attached)..
7. That after the expiry of the contract was never renewed but the service of the appellant was never discontinued. This means that at the end of these three years the services of the appellant were automatically regularized. Thus, due to the said reason the seniority of the appellant shall be reckoned from the date of initial appointment that was made in the year 1999. However, due to the attitude of the Respondents the appellant never received any order of regularization. The appellant started receiving her annual increments from the year 2001 which the employees working on regular posts are availing since their initial appointments.
8. That in the government stunt of MMA, the provincial government issued a policy dated 10 - 08 - 2005 under the letter No: 50R-VI(E&AD)2-06/2004 VOL -111. According to this policy notification all employees who were appointed on contract basis during the period 01 - 07 - 2001 to 23 - 07 - 2005 were regularized. It was also incorporated in the statute. It was also directed to make all appointments in the province on regular basis in the future. However, instead of pension and gratuity, CP Fund was made available to them. Though, the appellant who was appointed on contract basis in the year 1999 against a regular post remained on contract since 2008. However, the appellant was also given contract in the period between 2001-2005 under the government policy dated 26 - 10 - 2002 and all the terms and conditions of the 2005 policy are also applicable on us. But, due to the discrimination of the respondents the appellant was not regularized on 23 - 07 - 2005. Copy of the policy notification dated 20 - 08 - 2005 is attached as Annexure - 4
9. That, all the other employees in BPS-01 To BPS-15 who were employed on contract basis against the regular posts in the year 1998 to 30 - 06 - 2001 remained on contract basis till 01 - 07 - 2008 when their services were regularized under the government notification 4(35)97-2006/Admn Vol-X111 dated 26 - 05 - 2009. This means that the appellant deserved the regularization of her services from 2005 as per the Contract Employees Policy 2005. Due to this reason the seniority of the appellant-has to be reckoned from the date of her initial appointment in the year 1999, which was made, though, on contract basis but was against the regular post and she was also to be made regularized in the year 2005.

10. That, the respondents issued a final seniority list dated 01/02/2016, wherein the appellant has been held junior to those appointed later in time but on the basis of their regularization in the year 2005. Thus, the appellant also deserve the same treatment and she can't be discriminated against others on the basis of illegality committed by the respondents.
11. That no seniority list has been ever circulated / intimated to the appellant, thus, appellant never knew about the above illegalities since very recently.
12. That this latest final seniority list came to the knowledge of the appellant on 20/03/2016, and feeling aggrieved by the said list the appellant made a departmental appeal on 22/03/2016.
13. That the appellant waited for the reply of the respondents for 90 days but no reply was received from them and hence, this current further representation in your learned court, which is in time and jurisdiction of this Tribunal Court.

PRAYER:

One acceptance of this appeal, the respondents may please be ordered to make amendments in the final seniority list dated 01/02/2016 and to reckon the seniority of the appellant from her initial appointment in the year 1994 and she may be deemed regularized since 23 - 07 - 2005 and be made senior to those who were appointed later in time than the appellant.

- (1) یہ کہ من سائلہ بطور FWA(F)BPS-5 ڈیوٹی سرانجام دے رہی ہے۔ جس کی تعیناتی مورخہ 10/05/1999 بطور FWA(F) کنٹریکٹ کی بنیاد پر ضلع ڈیرہ اسماعیل خان میں ہوئی تھی۔ اور من سائلہ کے ساتھ تاریخ تعیناتی سے لیکر سال 2008ء تک متعدد بار نا انصافی ہوئی ہے۔ اور بارہا من سائلہ کی حق تلفی ہوئی ہے۔
- (2) یہ کہ سال 1999ء تا 30 جون 2001ء و جون 2001ء تا 2008ء تک اس ڈیپارٹمنٹ کی مختلف ڈسٹرکٹ پولیشن و پبلسٹیٹی آفسز میں باقاعدہ ریگولر تقرریاں کی جا چکی ہیں۔ جس کی وجہ سے وہ ملازمین ہائیر کوالیفیکیشن، انکریمنٹ، سپیشل ایڈیشنل الاؤنس، GP فنڈ، سالانہ انکریمنٹ، پنشن، گریجویٹی جیسے مراعات سے مستفید ہو رہے ہیں۔ جبکہ دوسری طرف اسی دور میں من سائلہ کو کنٹریکٹ پر تقرری کی گئی ہے۔ اور جملہ مراعات سے محروم رکھا گیا ہے۔
- (3) یہ کہ ڈائریکٹوریٹ نے اسی دور میں ڈسٹرکٹ آفسز کو اپنے ڈسٹرکٹ آفس میں خالی آسامیوں کی تعداد کے بارے میں لیٹرز ارسال کئے۔ جبکہ مذکورہ خالی آسامیوں کے بارے میں وقتاً فوقتاً لیٹرز ارسال کئے۔ جبکہ مذکورہ خالی آسامیوں کے بارے میں یہ تفصیل نہیں مانگی ان میں کتنے ریگولر اور کتنے کنٹریکٹ آسامیاں موجود ہیں اور یہ تفصیل بھی نہیں مانگی کہ مذکورہ آفسز میں کتنے

ریگولر اور کتنے کنٹریکٹ پر ملازمین کام کر رہے ہیں۔ اور ڈسٹرکٹ آفسز نے بھی اس بابت کوئی تفصیل ڈائریکٹوریٹ نہیں بھیجی۔ بلکہ ڈسٹرکٹ آفسز نے ڈائریکٹوریٹ کو صرف خالی آسامیوں کے بارے میں تفصیل فراہم کی۔ اور اسی بے قاعدگی کی وجہ سے ڈائریکٹوریٹ نے ریگولر پوسٹوں پر کنٹریکٹ اشتہار کر کے تقرریاں کیں۔

یہ کہ اس کے بعد محکمہ ہذا فیڈرل گورنمنٹ سے پرنشل گورنمنٹ کی تحویل میں آیا۔ اور تمام تر تقرریاں صوبائی گورنمنٹ کی کنٹریکٹ پالیسی بحوالہ نمبر ED/(505R-II)12-1/2002 مورخہ 26/10/2002 کے تحت ہوتی رہیں۔ من ساٹھ کو ابتدائی میں یعنی سروس کے آغاز پر دو سالہ کنٹریکٹ ملا۔ اس کے بعد کبھی ایک سال اور کبھی دو سال کا کنٹریکٹ ملتا رہا۔ اور آخر میں سال 2003-04ء کو تین سال کے کنٹریکٹ صوبائی گورنمنٹ کی 26 اکتوبر 2002ء کی کنٹریکٹ پالیسی کے تحت کنٹریکٹ ملا۔ اور تین سال مکمل ہونے یا کنٹریکٹ ختم ہونے کے بعد کسی قسم کا کوئی کنٹریکٹ نہیں ملا اور سروس بغیر کنٹریکٹ کے چلتی رہی۔ اس کا مطلب یہ ہے کہ تین سال مکمل ہونے کے بعد ساٹھ خود بخود ریگولر ہو گئی۔ اور جس کی وجہ سے Seniority من ساٹھ سال 1999ء سے حقدار ہے جو کہ ساٹھ کا Date of appointment ہے۔

یہ کہ اس کے بعد (MMA) کی صوبائی گورنمنٹ وجود میں آئی تو انہوں نے باقاعدہ مورخہ 10/08/2005 کو اعلان کر کے پالیسی کی نوٹیفیکیشن نمبر VOI-III-50R-VI(E&AD)/2-6/2004 جاری کی، جس میں یکم جولائی 2001ء سے لیکر 25 اگست 2005ء تک تمام کنٹریکٹ ملازمین کو 23 جولائی 2005ء سے ریگولر کر دیا گیا۔ اور اس کے بعد بھی صوبہ خیبر پختونخواہ میں تمام تر تقرریاں ریگولر بنیاد پر کی جانے کی ہدایت کی۔ لیکن پنشن و گریجویٹی کی بجائے CP فنڈ کے حقدار قرار دیئے۔ جبکہ من ساٹھ کنٹریکٹ ملازمہ جو کہ سال 1999 کو باقاعدہ ریگولر پوسٹ پر کنٹریکٹ تعیناتی ہوئی تھی بدستور کنٹریکٹ پر رہی۔ اور ریگولیریٹی سے محروم رہ گئی۔ ہمیں بھی سال 2003-04ء میں تین سالوں کا کنٹریکٹ صوبائی گورنمنٹ کی کنٹریکٹ پالیسی 26 اکتوبر 2002ء کے تحت ملی۔ اور جملہ تمام Terms & conditions ہم پر بھی لاگو ہوتے ہیں۔ لیکن محکمہ کی غفلت کی وجہ سے

Preliminary Objections

1. The Appellant has got no cause of action to file the instant service appeal.
2. The Appeal in hand is filed with malafide intention.
3. The Appellant has no locus standi to file the instant service appeal.
4. The Appellant has not approached this Hon'able Tribunal with clean hands.
5. The present service appeal is based upon malicious / vexatious and frivolous grounds.


On Grounds.


1. Pertains to Office record.
2. Incorrect. Verbatim based on distortion of facts.
3. Incorrect. The appellant being a contract employee cannot claim the benefits of regular civil servant under the rules as mentioned in her appointment order (Annex-A).
4. Pertains to office record.
5. Incorrect. In the year 1999 the department was Federal which was later on De-federalized on 1/7/2002 alongwith the incumbents (Annex-B).
6. Correct to the extent that the appellant was initially appointed on contract basis and got extensions/renewal of contract as per govt. contract policy. This does not mean that the services of the appellant were automatically regularized. In his Appointment Letter (on contract basis) it was mentioned at section-9 of Terms & Condition i.e "Seniority: Contract appointment will neither confer any right for regular appointment to the same post not the service will be counted towards seniority (Annex-A).
7. Incorrect. In regularization of services Act, 2005 there was bar with time period specification i.e. the services of those contract employees were regularized who were appointed on or after 1/7/2001 till the commencement of the said Act (Annex-C). Later on the services of left over contract employees were regularized w.e.f. 1/7/2008 under the rules / provisions contained in Establishment Division, Cabinet Secretariat, Govt. of Pakistan office memorandum No.10/30/2008-R.II dated:29/8/2008 received vide Section Officer (Establishment), Population Welfare Department, Govt. of K.P(the then NWFP) letter No. SOE (PWD)4-34/07/PC/Vol-II dated:07/10/2008 followed by instructions received from Ministry of Population Welfare, Islamabad vide letter No.10-9/2008-Establishment dated:07/04/2009. The department acted accordingly and issued Office Order No.4(35)/97-2006/Admn/Vol-XIII dated:26/5/2009 for regularization of the left over employees (Annex-D).
8. Incorrect. As explained in para-7 above.


- Incorrect. The seniority of the appellant must be counted/calculated from the date of her regular appointment. As explained in Para-6 & 7 above.

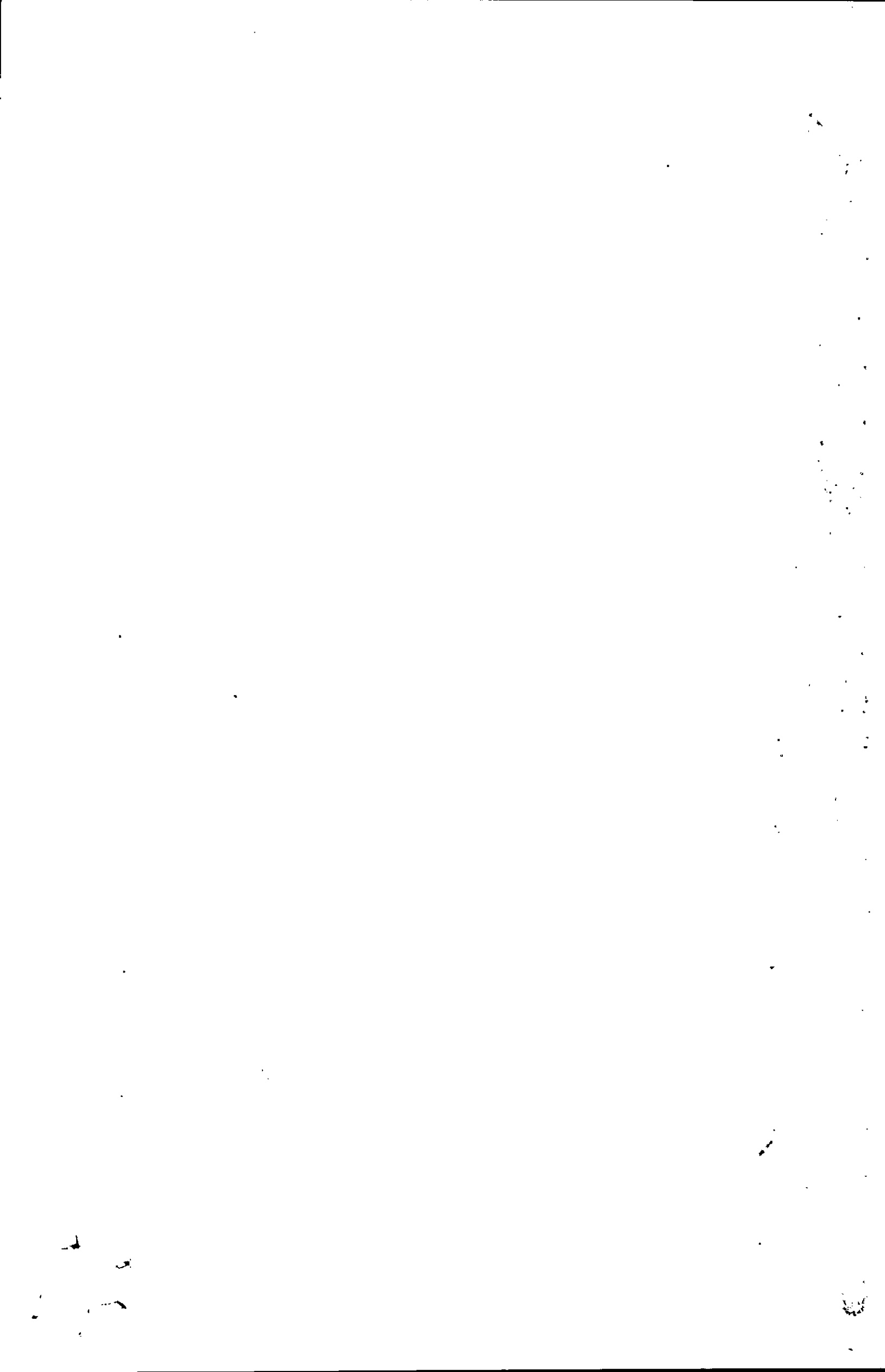

[First published after having received the assent of the Governor of the North-West Frontier Province in the Gazette of the N.-W.F.P. (Extraordinary), dated the 23rd July, 2005]

*further to amend the North-West Frontier Province
Civil Servants Act, 1973.*

Preamble.—WHEREAS it is expedient further to amend the North-West Frontier Province Civil Servants Act, 1973 (N.-W.F.P. Act No. XVIII of 1973), for the purpose hereinafter appearing;

It is hereby enacted as follows:

1. **Short title and commencement.**—(1) This Act may be called the North-West Frontier Province Civil Servants (Amendment) Act, 2005.

(2) It shall come into force at once.

2. Amendment of section 19 of N.-W.F.P. Act No. XVIII of 1973.—In the North-West Frontier Province Civil Servants Act, 1973 (N.-W.F.P. Act No. XVIII of 1973), for section 19, the following shall substituted, namely:

“(1) Pension and gratuity.—(1) On retirement from service, a civil servant appointed on regular basis in the prescribed manner before the commencement of the North-West Frontier Province Civil Servants (Amendment) Act, 2005 (hereinafter referred to as the said Act), shall be entitled to receive such pension or gratuity as are admissible to him under the West Pakistan Civil Service Pension Rules:

Provided that in the event of death of such a civil servant, whether before or after retirement, his family shall be entitled to receive such pension, or gratuity, or both, as admissible under the said rules.

(2) A person though selected for appointment in the prescribed manner to a service or post on or after the 1st day of July, 2001, till the commencement of the said Act, but appointed on contract basis, shall, with effect from the commencement of the said Act, be deemed to have been appointed on regular basis. All such persons and the persons appointed on regular basis to a service or post in the prescribed manner after the commencement of the said Act shall, for all intents and purposes be civil servant, except for the purpose of pension or gratuity. Such a civil servant shall, in lieu of pension and gratuity, be entitled to receive such amount contributed by him towards the Contributory Provident Fund, along with the contributions made by Government to his account in the said Fund, in the prescribed manner:

Provided that in the event of death of such a civil servant, whether before or after retirement, his family shall be entitled to receive the said amount, if it has already not been received by such deceased civil servant.

(3) No pension to a civil servant, who is otherwise entitled to it, shall be admissible to him, if he is dismissed or removed from service for reasons of discipline, but Government may sanction compassionate allowance to such civil servants, not exceeding two-third of the pension or gratuity which would have been admissible to him had he been invalided from service on the date of such dismissal or removal:

Provided that a civil servant referred to in sub-section (2), in case of such dismissal or removal, may, in addition to his own contributions to the Contributory Provident Fund, be allowed, on account of such compassionate allowance, a sum not exceeding two-third of Government contributions in his account.

(4) If the determination of the amount of pension or gratuity admissible to a civil servant is delayed beyond one month of the date of his retirement or death, he or his family, as the case may be, shall be paid provisionally such anticipatory pension or gratuity as may be determined by the prescribed authority, according to the length of service of the civil servant which qualified for pension or gratuity and any over payment on such provisional payment shall be adjusted against the amount of pension or gratuity finally determined as payable to such civil servant or his family.”
