#### <u>JUDGMENT</u>

### HAMID FAROOQ DURRANI, CHAIRMAN:-

The appellant is essentially aggrieved of office order dated 1. 16.03.2016 passed by Deputy Commissioner Torghar, whereby, Ageel Ahmad son of Ishfaq Ahmad and Tufail Anjum Qureshi son of Ghulam Sadig were promoted from the post of patwari (BPS-09) to the post of Kanungo (BPS-11) on regular basis. The appellant submitted departmental appeal against the order before the Commissioner Hazara Division on 28.03.2016 which could not find favour and was dismissed vide order dated 09.06.2016.

2. We have heard learned counsel for the appellant and learned Deputy District Attorney on behalf of the respondents. We have also perused the available record.

It was mainly the argument of learned counsel that the appellant was appointed as patwari on 03.05.2012 and at the relevant time, when Departmental Promotion Committee meeting for promotion of patwaris to the post of Kanungo was held on 09.03.2016, the appellant had already completed the requisite condition of minimum length of service of three years as patwari. He was, therefore, entitled for consideration for promotion as the number of vacancies available for promotion were three. In his view, the requisite promotion was wrongfully denied to the appellant.

Learned Deputy District Attorney, on the other hand, controverted the averments made on behalf of the appellant and contended that the respondents acted in accordance with law. The name of appellant was dropped from promotion being unfit as not having the requisite length of service.

3. The record transpires that the posts of Kanungo (Girdawar) BPS-11 were required to be filled in by promotion from patwaris (BPS-09) under the notification dated 30.01.2015, issued by the Revenue Department Khyber Pakhtunkhwa, Peshawar. The method of promotion was provided in the following terms:-

"By promotion, on the basis of seniority-cum-fitness, from amongst the patwaris and Naib Office Kanungos of the District concerned with three years service as such and who have passed the departmental examination of Kanungo."

Seen in juxtaposition to the above noted provision the date of appointment as a patwari was 20.09.2011 in the case of Aqeel Ahmad. Similarly, Tufail Anjum Qureshi was also appointed as Patwari on 20.09.2011. In the said manner, both of them had completed the minimum length of service as patwaris and have also passed the departmental examination of Kanungo. On the other hand, the appellant although had also passed the requisite exam, his date of appointment as patwari (BPS-09) was 19.11.2014. Clearly, he had not completed a period of three years as patwari on the date the DPC meeting was held.

4. We have also attended to the argument of learned counsel for the appellant, wherein, it was claimed that the appellant was initially appointed as patwari BPS-09 on 03.05.2012. In the said context, the service of appellant was to be reckoned from the said date. We are not in agreement with the contention on behalf of appellant owing to the fact that on 03.05.2012 the appellant, amongst others, was appointed as patwari against the posts in Tehsil Settlement Operation Mansehra. The said appointment was contract based and against a project post which was created for a specific period. The claimed appointment was for a period of one year and was to expire in May, 2013. There is nothing on record to suggest that the appellant continued thereafter till his appointment as patwari BPS-09 on

19.11.2014. The service of appellant in a project and against contract was rightly not considered by the respondents. The continuation in service without break was also a matter for consideration with the respondents.

5. For what has been discussed, the appellant was clearly unqualified for the impugned promotion and his name was accordingly dropped from the recommendations. The appeal in hand, therefore, is bereft of any merits and is accordingly dismissed.

Parties are left to bear their respective costs. File be consigned to the record room.

THE DEPARTMENTAL APPEAL OF APPELLANT FILED AGAINST THE, ORDER NO. 863/71, ESTT. DPSSC/DC/TC DATED 16-03-2016 PASSED BY DEPUTY COMMISSIONER TORGHAR ON THE SUBJECT OF NON-PROMOTING THE APELLANT (PATWARI BPS-09) TO THE POST OF QANUNGO/TEHSIL QANUNGO **BPS-11** IS DISMISSED AND THEREBY THE ORDER ABOVE MENTIONED PASSED BY RESPONDENT NO.3 IS MAINTAINED AND **APPELLANT** IS NOT PROMOTED FROM PATWARI BPS-11 TO THE POST OF FILED OFFICER QANUNGO BPS-14.

### PRAYER:-

ON ACCEPTANCE OF THE PRESENT APPEAL THE Appellant may graciously be held entitled for the promotion for the post of field office Qanungo (BPS-14), as fully qualified in the light of the seniority mentioned in the seniority list, educational & departmental / experience qualifications, experience of length of service more than 3 years, as serving the department as Patwari **BPS-09** (Tehsil Settlement operation, Mansehra) in the light of the order bearing no. 1087-1113 /LRO dated 03-05-2012 passed by Director land record. Settlement Officer KPK Peshawar (respondent no-04) and accordingly any otherwise codal and procedural lacunae and hurdle allegedly showing the breakage of the continuity of length of experience/period of service, bifurcating the services of Patwari of settlement operation and Patwari at district Torghar may please be set aside, strucked

down, as being void ab-initio, unlawful, against the rights of the appellant, result of haste, beyond to the law, reasons thus orders passed by respondents No.2 & 3 are not speaking and good orders, therefore not sustainable, and any other order whichever is deemed appropriate leading to the proper redressal of the appellant may also graciously be passed in the interest of good administration of justice.

### **FACTS:**

- 1. That, Respondent no 4, being Director land record and Chief Settlement Officer of the KPK Province vide letter no 1087-1113/LRO dated 03-05-2012 appointed appellant as Patwari, BPS-09, against newly created posts in Tehsil settlement operation Mansehra. On 04-05-2012 the appellant put arrival on duty, and appellant also obtained NOC from respondent no 7. (Copy of letter No.1087-1113/LRO dated 03-05-2012 is attached as annexure "A" Arrival report of Appellant dated 04-05-2012 is annexed as "B", NOC dated 05-08-2011 from DOR & E Haripur (respondent no 7) is annexed as annexure "C")
- 2. That, the respondent no 4 (Director land record) vide letter dated 12-11-2014, issued transfer letter of appellant( on mutual basis) from Mansehra to District Abbottabad, and on 19-11-2014. the appellant vide letter 2626-33 no DPSC/Estab/Tag by respondent no 3 (DC Torghar) was appointed Patwari at District Torghar and thereafter the appellant obtained NOC from respondent no 9, (Settlement Officer ATD) and also relieving order on 04-12-2014, (Copy of the mutual transfer order dated 12-11-2014 is annexed as "D", copy of appointment as Patwari, district Torghar is

annexed as "E", copy of NOC from respondent no 9 is annexed as "F", copy of relieving order dated 04-12-2014 by respondent no 9 is annexed as "G", copy of service record is annexed as "H", copy of last pay certificate dated 01-12-2014 issued by respondent no 10 (settlement officer Mansehra) is annexed as annexure "I", copy of arrival report as Patwari district Torghar, dated 02/12/2014 is annexed as annexure "J").

- 3. That, the respondent no 3, (DC Torghar) issued Permanent Seniority List of Patwaris, TRA, of District Torghar. (Copy of seniority list of Patwaris, TRA, District Torghar is annexed as annexure "K")
- 4. That, the appellant sought permission for appearance in the Qanungo (Girdawar) examination from respondent No.3 (DC Torghar), and respondent no 3 (DC Torghar) vide letter no 2481/DC/RE (2015/TG dated 20-10-2015 issued permission letter and the appellant appeared in the exam and qualified and passed the same exam. (Copy of application of appellant for permission to appear in the exam is annexed as annexure "L", copy of the permission issued by respondent no 3, (DC Torghar) is annexed as "M", copy of the result of the examination of Qanun Go and at serial no 198 the appellant has been shown as passed, the result is annexed as "N").
- 5. That, Government of KPK, Board of Revenue /Revenue Estate department, respondent no 6 issued and passed notification Peshawar, dated23-10-2015, no/942/Estt-1/135/SSRC under concerned rules, laid down the method of recruitment, qualification and other conditions specified in Column 3 to 7 of appendix to this (serial) notification and at page 9, the officer, posts etc for administration etc of Deputy Commissioner Torghar 2 posts for the officer of Qanun go BPS-11, meaning thereby 3 posts of Qanungos in District

Torghar are created within the following conditions (mentioned in the column no 6, for the .office of Qanungo is specified.

BPS-11	District Collector,	By promotion, on the basis is seniority cum fitness from amongst the Patwaris and Naib office Qanungos of the district concerned, with three(3) years service as such and who have passed the departmental examination of Qanungo.

(Copies of the notification dated 23.01.2015 with creation of post of Qanungo and Tehsil Office Qanungo for District Torghar are annexed as annexure "O").

- 6. That, the appellant got the knowledge about the convening of district promotion committee meeting for approval of promotion for the office of Qanungos, (3 posts) therefore, submitted an application to the respondent no 3 (DC Torghar, Appointing authority) on 16-02-2016, and on receipt of the application same respondent no 3 asked for report from Tehsildar/DK Torghar (respondents no 12 & 13), Accordingly, the respondent no 12 submitted his report, containing clear words favouring the version of the appellant, that appellant's promotion for Qanungo is proper, however, advice from the respondents no 5 & 6 may be taken and till then the meeting of DPC may be adjourned. (Copies of the application dated 16-02-2016 are annexed as annexure "P" and report of Tehsildar dated 24-02-2016 is annexed as annexure "Q").
- 7. That, working paper dated 19-02-2016 for agenda of DPC meeting likely to be held on 09-03-2016, notice for DPC meeting for participation in meeting, in the name of respondent no 6, history of candidates about promotion and order passed by respondent no 3 (DC Torghar) bearing no 863-7/Estt: DPSC / AE/ DC/TG dated Torghar the 16-03-2016, vide which 2 Patwaries namely Mr. Aqeel Ahmed S/o

Ishfaq Ahmed and Mr. Tufail Anjum Qureshi S/o Ghulam Sadiq were promoted, however such letter reveals trial neither that the appellant was considered nor promoted as Tehsil office Qanungo. Further all proceedings shows that, promotion for the office of the Tehsil Qanungo has been badly ignored and never taken into consideration. (Copies of the letter no 552-55/DC/TGL dated 19-02-2016 and working paper is annexed as annexure "R", letter no 552-53/DC/TGL dated 19-02-2016, letter for participation addressed to respondent no 6 is annexed as "S", letter /history of candidates likely to be promoted is annexed as "T", minutes and office order no 863-71/EStt; DPSC/AE/DC/G dated 16-03-2016 with regard to promotions of other 2 Patwaries namely Ageel Ahmed and Tufail Anjum Qureshi is annexed as annexure "U").

- 8. That, inspite of all above mentioned conduct of respondents the appellant has been appointed and posted as Qanungo but in his own pay scale. (minutes and office order no 863-71/EStt; DPSC/AE/DC/G dated 16-03-2016 with regard to promotions of other 2 Patwaries namely Aqeel Ahmed and Tufail Anjum Qureshi is annexed as annexure "(17).
- 9. That, the appellant being aggrieved of the order dated 16-03-2016, passed by respondent no 3 (DC Torghar) through which appellant was neither considered for promotion for Qanungo nor the promotion for Tehsil Qanun Go (having similar qualification with Qanungos) was ever considered, submitted and preferred departmental appeal/representation to the Commissioner Hazara (respondent no 2), but the respondent no 2 (Commissioner) vide letter no Appeal-Estab/9415-17 dated Abbottabad 09-06-2016, without any reasons and without any offering of opportunity of hearing to the appellant, dismissed the appeal beyond to the law and rules (copies of the departmental appeal of appellant and

order of dismissal of appeal dated 09-06-2016 are annexed as annexure "\vec{\psi}" & "\vec{\psi}" respectively).

10. That ,appellant assails the impugned order dated 09-06-2016 passed by respondent no 2, (Commissioner) alongwith order dated 16-03-2016 passed by respondent no 3 (DC Torghar) on the following Grounds:-

### **GROUNDS:**

- i. That, impugned order alongwith the order passed by respondent no 3 (DC Torghar) are void ab-initio, unlawful, beyond to the scope and authority, result of nepotism, malafide, non exercise of the proper authority, biased and against the valuable rights of the appellant, thus not sustainable hence, bound to be set aside and strucked down.
- That, the appellant joined the service as Patwari BPSii. 09, on 03-05-2012 by the respondent no 4, (Director land record) in Tehsil settlement operation Mansehra, and Submitted arrival report as such on 04-05-2012, and obtained NOC from respondent no 7 (DOR & E Haripur) and all record annexed with appeal reveals that the appellant continued in service as Patwari, till the appointment as Patwari at district Torghar, on 19-11-2014, accordingly the respondent no 3 (DC Torghar) issued himself the seniority list and maintained other record clearly showing the service of appellant, till the passing of promotion order of other through letter dated 16-03-2016, meaning thereby that the appellant as Patwari, is in service since 03-05-2012 till 16-03-2016, therefore appellant services comes to the period of 3

years, 10 months and 13 days, therefore, the appellant was well qualified for the promotion.

- iii. That, it is important to mention that, the appellant obtained the proper NOCs from concerned respondents, for the appointment, transfers and posting from all stations, it means that, there is no breakup of the service of the appellant,.
- iv. That, it is also worth to mention that the respondent no 3 (DC Torghar) has allowed and permitted the appellant for the appearance in the examination of the Qanungo examination and the same examination was diligently passed by the appellant, s when the respondent no 3 himself allowed the appearances in relevant examination therefore, could not refuse the fruit of such passing of examination.
  - v. That, the appellant submitted an application for the consideration for promotion as Qanungo and the respondent no 3 after receipt of the application of appellant himself asked for report to the Tehsildar, and same Tehsildar vide his report clearly mentioned that the appellant is the proper candidate for the promotion, and otherwise it was reported that respondent no 3 may obtain the concerned advice from the Board of Revenue but the respondent no 3 neither acted according to the report of Tehsildar concerning the promotion of appellant nor obtained the advice from the Board of Revenue. This all amounts to the biased, malafide conduct of the respondent no 3, leading to the violation of the rights of the appellant.
- vi. That, the respondent no 3 was reported by Tehsildar that till the receipt of the advice from Board of Revenue, the

DPC meeting may be adjourned, but the respondent neither opted for obtaining this advice on the subject nor adjourned the DPC meeting. This all suggest that the respondent no 3 was bent upon to ignore the promotion of appellant.

vii. That, the respondents no 3 and others, being members of the DPC were not in the knowledge of accurate vacancies as per the notification of the Government which admitted /revealed that, there are 3 vacancies, 2 for Qanungos and 1 for Tehsil Qanungo, all said vacancies were having same and similar qualification, but all the documents of proceedings i.e. agenda of meeting, history etc reveals that only two vacancies were considered and 3 seat, post were altogether ignored without any plausible reason.

viii. That, the respondent no.3 after promoting the other 2 candidates as Qanungo, has himself passed his order for the appointment of appellant as Qanungo for 3<sup>rd</sup> seat and post, but on the same pay, it Means that, the respondents no 3 & 2 were quite in knowledge that there is a vacancy of 3<sup>rd</sup> seat, but to the extent promotion of appellant as Qanungo, the appellant has been badly ignored.

ix. That, the respondent no 2, while dealing with the appeal/representation of appellant, has violated the all good principles concerning the valuable rights of the appellant as he restricted himself only to the question of this promotion of 2 others as this was not the case of the appellant as the appellant is not challenging the promotion of 2 other colleagues, but the appellant feels himself aggrieved of the conduct of respondents no 2 & 3 to the extent that, the appellant has not been promoted

for the post of 3<sup>rd</sup> vacancy of Qanungo, as two vacancies of Qanungos and 3<sup>rd</sup> one is Tehsil Qanungo, the appellant or any one of his colleagues, who are promoted should have been considered for the promotion as Tehsil Qanungo as qualification for all vacancies is same and similar for all three posts attracting same grade of BPS-11.

- x. That, non consideration for promotion of appellant for 3<sup>rd</sup> vacancy, amounts to the violation of law, rules and good administration of justice.
- xi. That, in the presence of the alleged stance of the respondents about the alleged non completion of the service as Patwari at district Torghar, should have not stopped the appellant from passing the order of appellant's promotions as Qanungo BPS-11, they may have passed the order subject to the board in the light of the Tehsildar report.
- xii. That, the appellant always served with all his commitment, dedications, zeal and satisfaction of the concerned public & respondents, therefore, deserves for the due appreciations, including he redressal in shape of the promotion as prayed for.
- xiii. That, as per law and practice, the enlistment in the Patwaris candidates registering the basic criteria for counting appointment, seniority and period of service etc, as no register of Patwari candidates was maintained in District Torghar by the respondents concerned, therefore period of service on the basis of such register maintained by respondent no 7 DOR & E Haripur would requires to be kept in view.

xiv. That, the present appeal is well within time as the respondent no 3 (DC Torghar) passed his order of promotions by ignoring the appellant on 16-03-2016 (annexure E) while the appellant submitted his departmental appeal/ representation, annex "V" after of the order and departmental appeal/representation is dismissed 09-06on 2016(Annexure "W") by the respondent no 2 (Commissioner Hazara Division Abbottabad).

It is therefore prayed that on acceptance of present appeal the order as prayed for in the title of the present appeal may graciously be passed.
