



APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER, DATED 18.02.2016 OF RESPONDENT NO.4 WHEREBY SERVICES OF THE PETITIONER HAVE BEEN DISMISSED AND AGAINST THE INACTION OF THE RESPONDENT NO.3 IN RESPONSE TO HIS APPEAL DATED 24.02.2016.

PRAYER IN APPEAL:

On acceptance of the instant appeal, the impugned order of dismissal dated 18.02.2016 of respondent No.3 may kindly be set aside and petitioner may kindly be re-instated in service with all back benefits.

Respectfully Sheweth;

- 1) That the petitioner is a permanent residence of Mian Kalli Bajaur Agency.
- 2) That respondent No.4 invited applications for appointments against posts of various categories of teachers on 31.10.2012. (Copy of advertisement is annexed)
- 3) That the petitioner having the requisite qualification for the post of T.T. also made an application for appointment against the post of T.T. BPS-15.
- 4) That after passing through the procedure for appointment against the said post, the petitioner/appellant was lucky enough to be appointed against the said post of T.T. vide order No.4365-70 dated 24.05.2013 of respondent No.4. (Copy of appointment letter is annexed)
- 5) That the petitioner/appellant took over charge of the said post vide arrival report dated 25.05.2013. (Copy of charge report is annexed)

- 6) That, services of the petitioner/appellant were also verified in the year 2013 and 2014. (Copy of service book is annexed)
- 7) That in the meanwhile the services of the petitioner/appellant were dismissed by respondent No.4 vide his order No.1571-78 dated 02.10.2015, without giving him any show cause notice, charge sheet and statement of allegations, as well as, no opportunity of hearing. (Copy of impugned dismissal order is annexed)
- 8) That the petitioner/appellant approached to the respondent No.3 through a departmental appeal but the same was referred to respondent No.4 for providing information and real facts. (Copy of the letter is annexed)
- 9) That the petitioner/appellant alongwith other such affectees also moved joint application on 07.11.2015, to respondent No.4 for withdrawal of said dismissal order till disposal of the appeal, which application of the petitioners/appellants was accepted and respondent No.4 was kind enough to withdraw the instant dismissal order vide his order No.2054-60 dated 11.11.2015. (Copy of withdrawal of dismissal order is annexed)
- 10) That astonishingly, another dismissal order of the petitioner/appellant was issued by respondent No.4 vide dated 18.02.2016 whereby services of the petitioner/appellant were again dismissed on the directions of respondent No.3 without observing the codal formalities. (Copy of impugned order is annexed)

- 11) That the petitioner/appellant approached to respondent No.3 through a departmental appeal dated 24.02.2016 but of no avail, hence the instant service appeal on the following grounds inter alia;

GROUNDS:


- A. That the said acts of the respondent by dismissing the petitioner/appellant from service is against law, facts and material available on record.
- B. That the services of the petitioner/appellant have been dismissed without observing the codal formalities and without providing the petitioner/appellant opportunity of being heard.
- C. That the educational degrees of the petitioner/appellant required for appointment against T.T. Post are valid and verified and not fake at all, but even then, the petitioner/appellant has been dismissed from service without any just and legal cause for ulterior motives.
- D. That the petitioner/appellant has not been dealt in accordance with the law as against Article 4 of the Constitution of the Islamic Republic of Pakistan.
- E. That the order of the respondent No.4 dismissing the petitioner/appellant from service is itself violation of the terms and conditions given in the appointment letter as salary has been received by the petitioner/appellant after due verification of documents.

F. That other ground with be raised at the time of arguments before this august Tribunal.

It is therefore most humbly prayed that on acceptance of this application, the impugned order of respondent No.4, dated 18.02.2016 may kindly be set aside and the petitioner may kindly be reinstated in service with all back benefits.

Any other remedy which this Hon'ble Tribunal deems fit and appropriate in the circumstances of the case may also be granted to the petitioner/appellant.
