1. That petitioner is civil servant and worked as PSHT BPS 16 in Education department since long and a fully devoted and hardworking teacher of the department.
2. That vide notification Endst No. 3570-4102/Ajd(PSHT) dated 6/2/2013 the appellant was transferred and posted in GPS Badhber which was faraway from the union council of the appellant.

3. That after objection the said notification was modified through a corrigendum Endst No. 6721-29Adj Peshawar dated 25/2/2013 whereunder the appellant was posted in GPS Sard Chah Peshawar City.

4. That again in violation of rules and policy the appellant has been transferred faraway from his union council through notification/order dated 22/2/2016.

(Copy attached as Annex C)

5. That since transfer and posting of the appellant beyond the territorial limits of U/C is wrong, illegal, without authority and rules/policy on the subject, hence a departmental representation was preferred before respondent No.1 but he till date has not disposed off the same rather kept appellant awaiting on different pretext.

6. That act, attitude and conduct of respondent No.1 is extremely illegal, discriminatory, biased and politically motivated against the appellant, hence the instant appeal is hereby preferred on the following grounds amongst others:

GROUNDS:



- A. That transfer order of the appellant beyond the local limits of his union council is illegal, unlawful and in violation of the rules and policy on the subject.
- B. That the impugned order is discriminatory, biased and politically motivated.
- C. That vide impugned order of transfer and posting, the respondent No.1 while awarding his near and dear ones has set the worst example of nepotism.
- D. That vide impugned notification/order all laws, rules and policies have been violated, hence the same needs to be set aside and modified.
- E. That appellant has been transferred far away from his union council, hence has to travel in public transport while changing three public transportations which causes not only unnecessary inconvenience but also physical and mental fatigue as well as extra monetary Burden which is causing continuance disturbance in faculty and capability of the appellant.
- F. That other grounds will be raised at the bar at the time of arguments.

It is therefore, most humbly prayed that on the acceptance of this appeal the appellant may kindly be ordered to be posted in the same union council or near to the union council by modifying the impugned notification. Any other remedy deems fit may kindly be awarded to the appellant in the circumstances of the case.







The Respondents submit below:-

Preliminary objections:-

- 1.** That the Appellant has got no cause of action/ locus standi.
- 2.** That the instant appeal is badly time barred.
- 3.** That the instant Appeal is not maintainable in its present form.
- 4.** That the instant Appeal is bad for mis- joinder and non- joinder of the necessary parties.
- 5.** That the Appellant has not come with clean hands to this Hon, able Tribunal.
- 6.** That the instant appeal is barred by law.

3. That Para-3 is correct.
4. That in reply to Para-4, it is submitted that the Appellant has been transferred and adjusted according to the needs in public interest, therefore, the Appellant has to serve where his services are needed to

the Department, hence the Respondents have acted under the law and there in no violation of any law.

5. That Para-5 is incorrect and misleading. Detail reply has been given in Para-2.
6. That Para-6 is incorrect, misleading and against the facts, hence denied. Being a Govt: Servant, the Appellant has to serve where his services are required in the best interest of public.


Grounds.
