SERVICE APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICES TRIBUNAL ACT, 1974, AGAINST THE IMPUGNED NOTIFICATION DATED 12.06.2023, WHEREBY THE APPELLANT WAS PROMOTED AGAINST THE POST OF SENIOR T.T (BPS-16) WITH IMMEDIATE EFFECT INSTEAD OF PROMOTING HIM w.e.f 20.02.2013 AND

AGAINST THE IMPUGNED ORDER DATED 26.09.2023, WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT WAS REJECTED.

Prayer-In-Appeal

By accepting this Service Appeal, the impugned rejection order dated 27.09.2023 may kindly be set aside and the respondents may further be directed to consider the appellant for promotion against the post of Sr. T.T (BPS-16) with effect from 20.02.2013 with all back benefits by modifying the notification dated 12.06.2023 to that extent.

Respectfully Sheweth:

1. That vide notification No. (B&A)/1-18/E&SE/ 2012 dated 11.07.2012, sanction of the Government of Khyber Pakhtunkhwa was accorded to the upgradation of one third of the total posts to different categories/ cadres of teachers (including upgradation of posts of one third of the total T.T Posts to Sr.T.T BPS-16) in Elementary & Secondary Education department w.e.f 01.07.2012. (Copy of the Notification dated 11.07.2012 is attached as Annexure-A).

- That there were 268 sanctioned posts of male Theology Teacher (BPS-15) and the respondents were required to promote 89 T.Ts (Male) against the post of Sr.T.T (BPS-16). (Copy of sanctioned posts is attached as Annexure-B).
- to consider the promotion cases of different categories/cadres of teachers including cases of promotion of T.T (Male) BPS-15 to senior T.T BPS-16 as the appellant was considered and recommended for promotion against senior T.T (BPS-16). (Copy of the Minutes of DPC dated 17.03.2014 is attached as Annexure-C).
- 4. That in pursuance of notification dated 11.07.2012 and consequent upon recommendation of Departmental Promotion Committee (DPC) dated 17.03.2014 one third of T.Ts (BPS-15) including the appellant were promoted against the post of senior T.T (BPS-16) on 23.04.2014. (Copy of the Notification dated 23.04.2014 is attached as Annexure-D).

- That the appellant assumed the charge against 5. the post of Sr.T.T (BPS-16), performed his duty, received salaries in the promoted posts and entries were also made in his service book as cancelled/held thereafter respondents abeyance the aforesaid promotion order and stopped the salary of the appellant against promoted post. (Copies of service book and a attached as 03.10.2014 are letter dated Annexures E & F) respectfully.
- 6. That a letter dated 13.05.2016 was issued to Directorate Education that SAFRON Division was having no objection to the upgradation of 20196 posts in different categories in the education sector of FATA w.e.f 1st July, 2012 as respondents were directed to proceed regarding the upgradation of posts in education sector of FATA without delay. (Copy of a letter dated 13.05.2016 is attached as Annexure-G)
- 7. That thereafter a notification dated 10.02.2017 was issued whereby seventy three TT (M) BPS-15 were promoted against the posts of Sr. T.T (M) BPS-16 on regular basis w.e.f 20.02.2013 as the

appellant was deprived from promotion against the post of Sr.T.T (M) BPS-16. It is pertinent to mention here that the respondents were required to promote one third of total TT (BPS-15) posts to Sr.TT (BPS-16) (Copy of the Notification dated 10.02.2017 is attached as annexure-H)

That the appellant along with his other colleagues 8. approached the respondents for the redressal of their grievances, the number correspondence were taken place among the respondents regarding the grievance of appellant alongwith colleague and it was relized by the respondents that the appellant was entitled to be promoted against the post of Sr. T.T (BPS-16) but he was deprived from the same as in view of matter in hand, a letter dated 24.02.2023 was issued regarding fixation of date of DPC for the promotion of appellant alongwith with his colleague against the posts of Sr. T.T (BPS-16). (Copies of a letter dated 27.12.2022, a letter dated 30.12.2022, a letter dated 04.01.2023, a letter dated 08.02.2023, a

letter dated 22.02.2023, a letter dated 24.02.2023 are attached as Annexure-I).

- 9. That thereafter correspondence were taken place regarding working paper alongwith service books regarding promotion of T.T (BPS-15) to Sr.T.Ts (BPS-16) to be arranged for DPC. (Copies of a letter dated 07.03.2023, a letter dated 21.03.2023, a letter dated 12.04.2023 and a letter dated 12.04.2023 are attached as Annexure-J).
- appellant was recommended for promotion against the post of Sr. T.T (BPS-16) and thereafter a notification dated 12.06.2023 was issued whereby the appellant was promoted against the post of Sr. T.T (BPS-16) with immediate effect instead of retrospective effect from 20.02.2013, like notification dated 12.06.2023. (Copy of the notification dated 12.06.2023 is attached as Annexure-K).
- 11. That being mortally aggrieved from the impugned notification dated 12.06.2023. The appellant then filed departmental appeal dated

27.07.2023. (Copy of the departmental appeal dated 27.07.2023 is attached as Annexure-L).

- aforementioned liaht of the 12. That in the dated 27.07.2023, departmental appeal correspondence were made through a letter dated 27.07.2023 a letter dated 15.08.2023 and a letter dated 26.08.2023 and then finally the departmental appeal of the appellant was rejected through order dated 27.09.2023 as the same was communicated to the appellant through an application dated 16.11.2023. (Copies of a letter dated 27.07.2023, letter dated 15.08.2023, a letter dated 26.08.2023 an application dated 16.11.2023 and order dated 27.09.2023 are attached as Annexure-M, N, O, P & Q respectively).
- 13. That the Appellant now prefers this Service Appeal for the following amongst other grounds:

GROUNDS:

A. That as stated in the body of the service appeal, that the appellant was entitled to be promoted against the post of Sr. T.T (BPS-16)

with retrospective effect from 20.02.2013 but he was deprived from the same which is prima facie, illegal, unlawful and thus ineffective upon the rights of the appellant.

- B. That the respondents were legally bound to promote the appellant w.e.f 20.02.2013 but he was deprived from his due right which necessitated the interference of this Hon'ble Tribunal.
- c. That similarly placed employees have been granted retrospective promotion w.e.f 20.02.2013 but the appellant was badly discriminated by violating Article 4 and 25 of the constitution of Pakistan, 1973.
- D. That the appellant has not been treated in accordance with law and he has also been deprived of equal protection of law.
- E. That any other ground, not specifically mentioned, may be raised at the time of arguments, with the prior permission of this Hon'ble Tribunal.

It is, therefore, most humbly prayed that by accepting this Service Appeal, the impugned rejection order dated 27.09.2023 may kindly be set aside and the respondents may further be directed to consider the appellant for promotion against the post of Sr. T.T (BPS-16) with effect from 20.02.2013 with all back benefits by modifying the notification dated 12.06.2023 to that extent.

Any other relief deems fit and appropriate in the circumstances of the instant appeal may also be passed in favour of the appellant.




