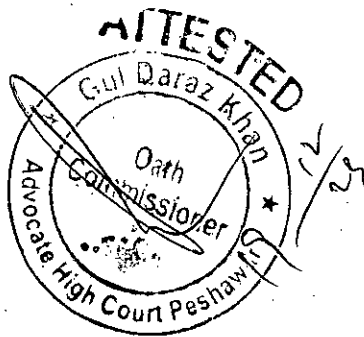

AT AGENDA ITEM NO-IV DATED 7TH JULY 2023 WHEREBY THE
APPELLANT BEING AN IN-SERVICE B-TECH DEGREE HOLDER
POSSESSES 4% RESERVED QUOTA OUT OF 10% QUOTA
RESERVED FOR PROMOTION FROM AMONGST THE HOLDER
OF THE POST OF SUB ENGINEERS WHEREIN THE DPC
COMPLETELY NEGATED THE APPELLANT ALONG WITH
SIMILARLY. PLACED AND ONLY ISSUED A PANEL OF**

CANDIDATES TO BE PROMOTED FROM AMONGST THE 6% RESERVED QUOTA HOLDERS (HAVING B-TECH DEGREE DURING INITIAL APPOINTMENT) OUT OF THE 10% LEAVING THE APPELLANT (WHO ACQUIRED B-TECH (HONS) DURING SERVICE HAVING 4% RESERVED QUOTA FOR PROMOTION), BEING ILLEGAL, UNLAWFUL, VOID AB INITIO AND ULTRA VIRES TO THE NOTIFICATION NUMBER NO.SOE/C&WD/8-12/2023 DATED 20TH JANUARY 2023.

FURTHER DIRECT THAT THE RESPONDENT DEPARTMENT MAY ALSO CONSIDER CANDIDATES FROM AMONGST THE 4% RESERVED QUOTA HOLDERS OUT OF THE 10% QUOTA RESERVED FOR THE PROMOTION OF B-TECH SUB-ENGINEERS TO THE POST OF ASSISTANT ENGINEER/SDO (BPS-17) AND CONSIDER THE APPELLANT FOR PROMOTION ACCORDINGLY

PRAYER:

That on acceptance of this service appeal the impugned promotion list issued by the respondent department at Agenda Item No-IV in its Departmental Promotion Committee dated 7th July, 2023 wherein they completely over-looked and negated the Promotion Rules of 2023 whereby the appellant along with other similarly placed have a reserved quota of 4% being in-Service B-Tech Degree holder out of 10% quota reserved for B-Tech Sub Engineers for their promotion as Assistant Engineers (BPS-17) and short-listing the candidates only from amongst the 6% quota holders having their B-Tech Degree during their initial appointment, be declared as unreasonable, ultra-vires of law as well as contrary to the recently promulgated and in-field Promotion Rules, 2023. Further direct the respondent department to consider candidates from amongst the 4% reserved quota holders out of the 10% quota reserved for the promotion of B-Tech Sub-Engineers to the post of Assistant Engineer/SDO (BPS-17) and consider the appellant for promotion accordingly.
