
1. That the above service appeal is pending before this Hon'ble Tribunal and fixed for 11.01.2024.



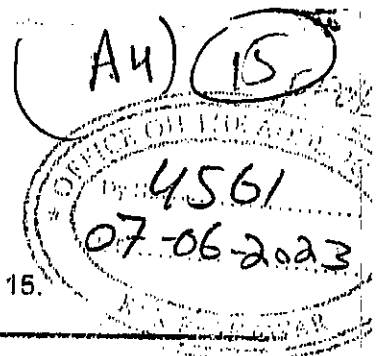
