**JOINT PARA-WISE COMMENTS OF RESPONDENTS (NO. 1 TO 5)**

**Preliminary Objections**

1. That the applicant has no cause of action/locus standi to file the instant application.
2. That the application is incompetent and is not maintainable in its present form.
3. That the instant application is not maintainable and liable to be dismissed.
4. That the applicant has not come to this Honorable Court with clean hands.

**ON FACTS**

- 1 Pertains to record, hence no comments.
- 2 Pertains to record, hence no comments.
- 3 Para-3 is correct to the extent that the appellant had served as Assistant Registrar (BS-16) for 31 years. It is important to add here that the provincial government in 2015, in order to compensate such employees, granted special compensatory allowance equal to difference of notional up-gradation of BS-16 to BS-17 to all Provincial Government employees in BS-16 in lieu of up-gradation (**Annex-I**).  
Likewise, the post of Assistant Registrar was upgraded from BPS-16 to BPS-17 w.e.f 07.05.2020 vide Secretary to Government of Khyber Pakhtunkhwa Agriculture, Livestock, Fisheries and Cooperative Department order No. SO (LFC) AD-4 (12)/2019/Vol-II dated 02.09.2020 (**Annex-II**).
- 4 Para 4 is correct to the extent that owing to shortage of officers at Head office Peshawar, the additional / look after charges of the posts of Deputy Registrar (Technical) and Deputy Registrar (Admn) (BPS-18) were entrusted to the petitioner vide Notifications (**Annex-III**).
- 5 Para 5 is misleading, hence denied. It is submitted that the tentative seniority list of Assistant Registrar (BPS-17) was prepared by the Cooperative Societies, Khyber Pakhtunkhwa vide Notification No. 07/RCS/E-10 dated 05.01.2023 (**Annex-IV**) and the same was circulated amongst all concerned for the purpose of rectification vide letter No. 10/RCS/E-10 dated 05.01.2023 (**Annex-V**).

Since no objection upon the tentative seniority list was received therefore, the Seniority list was forwarded to the Administrative Department for issuance of final seniority list vide letter bearing No. 212/RCS/E-10 dated 31.01.2023 (**Annex-VI**). The Administrative department vide letter No. SO (LD)/ 4-26/202-23 dated 27.03.2023 (**Annex-VII**) directed the Registrar, Cooperative Societies, Khyber Pakhtunkhwa (Respondent No.2) to sign all the certificates for further course of action. The Respondent No.2 submitted the same to administrative department through letter bearing No. 379/ RCS/E-10 dated 28.03.2023 (**Annex-VIII**).

The Administrative Department through letter No. SO (E)/LF&CD/ 4-4/2023/585 dated 23.05.2023 (**Annex-IX**) communicated the observations raised by the Establishment Department over the seniority of Assistant Registrar for clarification. Accordingly, Respondent No. 2 addressed the said observations and submitted the same again to the Administrative department for onward submission to Establishment Department vide letter No. 569/RCS /E-10 dated 07.06.2023 (**Annex-X**).

The Establishment department, Khyber Pakhtunkhwa again observed the seniority list of Assistant Registrar, which was conveyed to the office of the Registrar, Cooperative Societies, Khyber Pakhtunkhwa (Respondent No.2) vide letter No. SO (E)LFC/ 4-28/2023/1172 dated 02.08.2023 (**Annex-XI**). The seniority list was again submitted after addressing the observation through letter No. 740/ RCS/E-10 dated 09.08.2023 (**Annex-XII**).

Finally, the Final Seniority list of Assistant Registrars was notified by the Administrative Department vide Notification No. SO(E) 4-26/2020/136 dated 28.09.2023 (**Annex-XIII**).

- 6 Para 6 is misleading. The Final Seniority list of Assistant Registrar was notified on 28.09.2023 whereas the appellant retired on 09.04.2023 on attaining the age of superannuation (**Annex-XIV**).
- 7 No comments as explained in Para-5 and 6 above
- 8 Para 8 is Incorrect and misleading. The appellant was the senior most in the seniority of Assistant Registrars (BPS-17) whereas, Mr. Waseem Ullah has been appointed as Instructor (BPS-17) by Khyber Pakhtunkhwa Public Service Commission on 18.05.2022. They are two different posts and their seniority is maintained independently thus the appellant is not senior to Mr. Waseem Ullah, Instructor (BPS-17) (**Annex-XV**).

**GROUNDS:**

- A. The Department has always acted in accordance with the law and rules framed by the Provincial Government.
- B. Correct. As stated in Para-6 above.
- C. No comments. As explained in above para-5 & 6
- D. The Department has always acted in accordance with the law and rules framed by the Provincial Government.
- E. No comments. As stated in Para-5 above
- F. Pertains to record.
- G. That further grounds will be agitated at the time of arguments with kind permission of the Hon'ble Tribunal.

It is, therefore, humbly prayed that on acceptance of the above noted submissions, the instant appeal may graciously be dismissed with no cost.

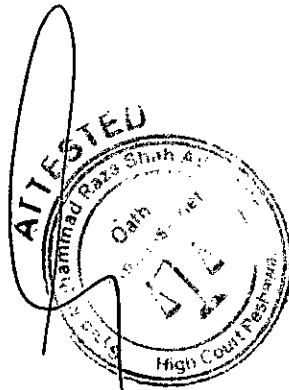

NO.FD/SO(FR)7-20/2015 The competent authority has been pleased to accord approval to the upgradation of pay scales of the following provincial government employees with effect from 01-07-2015:

- a) Two pay scale upgradation will be allowed to all provincial government employees from BS-01 to BS-05.
- b) One pay scale upgradation will be allowed to all provincial government employees from BS-06 to BS-15
- c) Special Compensatory Allowance equal to difference of notional upgradation of BS-16 to BS-17 will be allowed to all provincial government employees in BS-16 in lieu of upgradation.
- d) Upgradation will be applicable to both pay and allowances with freezing limits and other conditions currently in vogue unless revised by the government.
- e) Pay fixation on upgradation will be applicable w.e.f. 01-07-2015 or 01-12-2015 on the option to be given by the concerned employee.
- f) All provincial government employees who have been upgraded en-block or individually in last five years starting from 01-07-2010 or have been granted special allowance / pay equal to 40 % or more of their normal pay shall not be entitled for the instant upgradation.

2. Pay of existing incumbents of the posts shall be fixed in higher pay scales at a stage next above the pay in the lower pay scale.

3. All the concerned Departments will amend their respective service rules to the same effect in the prescribed manner.

4. The above upgradation scheme shall not be applicable to employees of Autonomous Bodies, Semi Autonomous Bodies and Public Sector Companies.

5. Explanatory note and subsidiary instructions on the subject will be issued separately.

- II. His service will be liable for termination on one month notice from either side. In case of resignation without notice, two months' pay/allowances shall be refund to Government. Till acceptance of resignation, he will continue to dispense his duties usually.
- III. The appointee should join duties within thirty (30) days of the issue of this notification. The Registrar Cooperative Societies, Khyber Pakhtunkhwa (Research Wing) would furnish a certificate to the effect that the candidate has joined the post or otherwise. - VI. His service can be terminated at any time, in case his performance is found unsatisfactory during probation period. In case of misconduct, he will be proceeded against the Khyber Pakhtunkhwa Government Services (E&D) Rules, 2011 and the rules framed there under from time to time.
- VII. Charge report should be submitted by the officer concerned.
- VIII. No TA/DA will be allowed to the appointee for joining his duty.
