- 1 Pertains to record, hence no comments.
- 2 Pertains to record, hence no comments.
- **3** Para-3 is correct to the extent that the appellant had served as Assistant Registrar (BS-16) for 31 years. It is important to add here that the provincial government in 2015, in order to compensate such employees, granted special compensatory allowance equal to difference of notional up-gradation of BS-16 to BS-17 to all Provincial Government employees in BS-16 in lieu of up-gradation (Annex-I).

Likewise, the post of Assistant Registrar was upgraded from BPS-16 to BPS-17 w.e.f 07.05.2020 vide Secretary to Government of Khyber Pakhtunkhwa Agriculture, Livestock, Fisheries and Cooperative Department order No. SO (LFC) AD-4 (12)/2019/Vol-II dated 02.09.2020 (Annex-II).

- **4** Para 4 is correct to the extent that owing to shortage of officers at Head office Peshawar, the additional / look after charges of the posts of Deputy Registrar (Technical) and Deputy Registrar (Admn) (BPS-18) were entrusted to the petitioner vide Notifications (Annex-III).
- **5** Para 5 is misleading, hence denied. It is submitted that the tentative seniority list of Assistant Registrar (BPS-17) was prepared by the Cooperative Societies, Khyber Pakhtunkhwa vide Notification No. 07/RCS/E-10 dated 05.01.2023 (Annex-IV) and the same was circulated amongst all concerned for the purpose of rectification vide letter No. 10/RCS/E-10 dated 05.01.2023 (Annex-V).

Knyber Pakhtukhw Service Tribunal Since no objection upon the tentative seniority list was received therefore, the Seniority list was forwarded to the Administrative Department for issuance of final seniority list vide letter bearing No. 212/RCS/E-10 dated 31.01.2023 (Annex-VI). The Administrative department vide letter No. SO (LD)/ 4-26/202-23 dated 27.03.2023 (Annex-VII) directed the Registrar, Cooperative Societies, Khyber Pakhtunkhwa (Respondent No.2) to sign all the certificates for further course of action. The Respondent No.2 submitted the same to administrative department through letter bearing No. 379/ RCS/E-10 dated 28.03.2023 (Annex-VIII).

The Administrative Department through letter No. SO (E)/LF&CD/ 4-4/2023/585 dated 23.05.2023 (Annex-IX) communicated the observations raised by the Establishment Department over the seniority of Assistant Registrar for clarification. Accordingly, Respondent No. 2 addressed the said observations and submitted the same again to the Administrative department for onward submission to Establishment Department vide letter No. 569/RCS /E-10 dated 07.06.2023 (Annex-X).

The Establishment department, Khyber Pakhtunkhwa again observed the seniority list of Assistant Registrar, which was conveyed to the office of the Registrar, Cooperative Societies, Khyber Pakhtunkhwa (Respondent No.2) vide letter No. SO (E)LFC/ 4-28/2023/1172 dated 02.08.2023 (Annex-XI). The seniority list was again submitted after addressing the observation through letter No. 740/ RCS/E-10 dated 09.08.2023 (Annex-XII).

Finally, the Final Seniority list of Assistant Registrars was notified by the Administrative Department vide Notification No. SO(E) 4-26/2020/136 dated 28.09.2023 (Annex-XIII).

- **6** Para 6 is misleading. The Final Seniority list of Assistant Registrar was notified on 28.09.2023 whereas the appellant retired on 09.04.2023 on attaining the age of superannuation (Annex-XIV).
- **7** No comments as explained in Para-5 and 6 above
- **8** Para 8 is Incorrect and misleading. The appellant was the senior most in the seniority of Assistant Registrars (BPS-17) whereas, Mr. Waseem Ullah has been appointed as Instructor (BPS-17) by Khyber Pakhtunkhwa Public Service Commission on 18.05.2022. They are two different posts and their seniority is maintained independently thus the appellant is not senior to Mr. Waseem Ullah, Instructor (BPS-17) (Annex-XV).






