# PARAWISE COMMENTS BY RESPONDENTS NO. 1 TO 3.

### RESPECTFULLY SHEWETH:

## PRELIMINARY OBJECTIONS:-

- a) That the appeal is not based on facts.
- b) That the appeal is barred by law and limitation.
- c) That the appeal is not maintainable in the present form.
- d) That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
- e) That the appellant is stopped to file the instant appeal by his own conduct.
- f) That the instant Service Appeal is badly time barred.
- g) That the appellant has not come to this Honorable Tribunal with clean hands.
- h) That the appellant has got no cause of action and locus standi to file the instant Service Appeal.

## FACTS:-

- 1. Pertains to record, needs no comments.
- 2. In correct. Constable Tariq Aziz was under command of the appellant he committed in disciplined conduct by sharing frivolous video on social media in the wake of bomb blast. Being immediate senior of his subordinate, he knew the emotional anger of his junior but he did not try to de-escalate his anger nor reported the matter to high ups. Resultantly his junior posted a video maligning the image of Police Force.
- 3. Correct to the extent of showcase notice issued to the appellant for his weak supervision and command over his subordinates.
- 4. Pertain to reply of the showcase notice. However, the appellant failed to satisfy the competent authority despite the fact that an ample opportunity of defense was given to him. The appellant having loose command led to violation of policy issued by the competent authority from time to time that no police officer / official will create social media group and will not be part of any such group. In the instant case appellant being incharge of the Platoon No. 57 failed to keep himself inform of the activities of his subordinates staff which caused spread of unconfirmed, baseless and unfounded information on social media. This indiscipline act tarnished image of the entire force.

- 5. Para is incorrect and misleading; in fact appellant was issued Show Cause Notice u/s 5(3) under the police disciplinary rules 1975. Pursuance to which authority is competent to exercise power to dispose of the enquiry on its own merit.
- 6. Para is incorrect, departmental appeal of the appellant was thoroughly processed which will be decided on its own merit but the appellant without waiting its decision filed the instant appeal.

#### **GROUNDS:-**

- A. Incorrect. As explained in the preceding paras. Appellant being incharge of the platoon is duty bound to keep close watch over subordinates staff, restrain them from involvement in indiscipline and unlawful acts but the appellant failed to do so, which speaks, volume of his slackness, negligence and lack of coordination with subordinate staff.
- B. Para is incorrect as explained in Para 'A' above.
- C. Para is incorrect. Message based on unconfirmed information viraled on social media created unrest and frustration among the police copes.
- D. Para is incorrect. Appellant started to manage paper work after knowing sensitivity of the situation just to save his skin.
- E. Para is incorrect order passed by the competent authority is in accordance with law and existing rules.
- F. Para is incorrect, order passed by the competent authority is lawful and justified.
- G. Para is incorrect as explained in the preceding paras.
- H. The responding sick leave to raise additional grounds at the time of arguments.

Prayer:

It is, therefore, humbly prayed that the Appeal of the appellant may kindly be dismissed with cost.

#### ORDER.

After that One of the constables namely Tariq Aziz posted under his direct command viral an unofficial, frivolous and unconfirmed audio message on social media which created unrest in the police force and also tarnished its image.
- b) His act is highly objectionable and liable him to be proceeded departmentally.
  He was issued Show Cause Notice under 5(3) of the Khyber Pakhtunkhwa Police Rules
  1975 and was served upon him.

He was thoroughly heard in person and was apprised about the allegations framed against birm in the show cause Notice. He failed to forward teply to the show cause notice based on plausible / cogent grounds

Foregoing in view, I Deputy Commandant, Elite Force, khyber Pakhtunkhwa, being competent authority have reached to the conclusion that his retention in force is not suitable therefore. <u>S.I. Mohammad Kifavatullah No. 760/M</u> posted to platoon No.111 deployed at district Chitral is hereby awarded the major punishment of Dismissal from Service under the Police Rules 1975.

### SHOW CAUSE NOTICE

Under Rules 5(3) of Klayber Pakhtunkhwa Police Rules 1975(Amenden 2014)

That you Mohammad Kifavatuliah SI of Elite Force have rendered yourself to be proceeded against departmentally under Rule 5(3)(c) of the Khyber Pakhtunkhwa Police Rules 1975 (Amended 2014) for the commission of misconduct and negligence in duty enumerated below:-

- a) That you while posted as incharge of platoon No.57 at Police Station Khall Dir Lower failed to keep close watch over subordinate staff and showed high negligence in performance of your official duty. As an ugly incident of bomb blast was occurred in CTD Police Station at Kabal Swat in which number of officials were martyred and severely injured. After that One of the constables namely Tariq Aziz posted under your direct command viral an unofficial, frivolous and unconfirmed audio message on social media which created unrest in the police force and also tarnished its image.
- b) Your act is highly objectionable and liable you to be proceeded departmentally.
- That by reason of the above and sufficient material placed before the competent authority: it is decided to proceed against in General Police proceedings without aid of enquiry officer as contemplated in rule 5(3)(c) of Police Rules 1975(Amended 2014)
- That your retention in the police force will amount to encourage of anti-social elements, inefficient.
- 5. That by taking cognizance of the matter under enquiry, the undersigned as competent authority under the said rules, proposes stern action against you by imposing on you one or more of the major punishments as provided in the rules
- 6. You are therefore, called upon to show cause as to why you should not be dealt strictly in accordance with the Khyber Pakhtunkhwa Police Rules, 1975(Amended 2014) for the commission of misconduct mentioned above.
- You should submit reply to the show cause notice within 07 days of its receipt failing which an ex-parte action shall be taken against you.

8. You are further directed to inform the undersigned that you wish to be heard in person or not.
