- ii. He will have all the rights/ privileges contained in Khyber Pakhtunkhwa, Civil Servants Act, 1973 with all amendments made therein including Khyber. Pakhtunkhwa, Civil Servants (Amendment) Act, 2013 and Rules made there under.
- iii. In case of resignation, the appointee will have to give one month prior notice. In lieu of such notice his one month pay/ allowances shall be forfeited. to Government.
- iv. He will be governed by such Rules & Regulations as may be issued from time to time by Government.
- v. The appointee should join his post within 30 days of the issuance of this Notification failing which it shall be presumed that he is not interested to join the same.
- vi. Charge reports should be submitted to all concerned.
