**Respectfully sheweth:-**

**Preliminary objections:-**

- 1- The appeal is barred by time.
- 2- The appellant has got no locus standi and no cause of action to file the instant appeal.
- 3- The appellant has not come to this Honorable court with clear hands.
- 4- This honorable Tribunal has no jurisdiction to entertain the instant appeal.
- 5- That the appeal is liable to be dismissed on the ground of mis-joinder/non-joinder of necessary parties.
- 6- That the appellant is stopped by his own conduct to file the instant appeal.
- 7- The appellant had never challenged the order dated 01-06-1998

**FACTS**

1. Yes & Correct
2. Correct
3. Incorrect & denied.

Mr. Ihsan Ullah Dawar & Ihsan Ullah Wazir (Respondent No.4 & 5) were appointed as Forester vide DFO FATA-III Bannu Office Order No. 108 dated 20/6/1996 against the vacant post of SNE posts. (Annex-I)

In due course of time, M/S Wali Khan and Aqal Jan Forest Guards has been promoted to the rank of Forester against the available vacancies in Developmental Scheme vide DFO FATA-III BANNU office Order No. 41 dated 3/11/1994 and Office Order No.46 dated 13/11/1994. (Annex-II & III)

On expiry of mentioned schemes, the DFO FATA-III Bannu converted the services of M/S Ihsan Ullah Dawar & Ihsan Ullah Wazir Foresters to the contractual position; by

adjusting the newly promoted Foresters against SNE post vide Office Order No. 116 dated 1/6/1998, (Annex-IV) which was further regularized vide DFO FATA-III Bannu Office Order No.18 dated 15/12/2000 with effect from 1/7/2000. (Annex-V)

After passage of time Mr. Ihsan Ullah Dawar and Ihsan Ullah Wazir Forester has preferred an appeal before the Conservator of Forests Circle Merged Areas Peshawar against the above Orders, which was accordingly accepted vide his Office Order No.47 dated 24/01/2022 and regularized the contractual period of their service. (Annex-VI)

- 4. As per record, the service of Mr. Zar Gula Jan Forester was terminated vide Office order No. 116 dated 1/6/1998 and his service was converted to contractual service. No appeal was preferred by him against the said Office Order and again his service were regularized vide Office Order No. 18 dated 5/12/2000. In the light of the said Office Order No. 18 his seniority has been fixed with effect from 01/7/2000. (Annex-VII & VIII)
- 5. Incorrect & denied. The appeal of appellant was rejected in the light of existence available record pertaining to the subject appeal. (Office order No. 42 dated 3/11/1994 office order No. 51 dated 27/11/1994). (Annex-IX, X XI & XII)
- 6. Incorrect and misconceived As per record, the service of M/S Ihsan Ullah Dawar and Ihsan Ullah Wazir Forester has already explained in para-3 above, while the service history of respondent No.6 & 7(Muhammad Ishaq Shah and Muhammad Iqbal ) Forester is clarified as under:-

**Muhammad Ishaq Shah Forester.**

The official has been appointed vide DFO FATA-III Bannu Office Order No:42 dated 3/11/1994 against "Afforestation in South Waziristan Scheme (SNE) and served upto 30/6/1995. (Annex-XIII).

Later on the service of official was regularized to Non-Developmental side vide DFO FATA-III Bannu Office Order No.09 dated 22/8/1995 with effect from 01/7/1995, therefore, his seniority has been fixed with effect from 01/7/1995. (Annex-XIV).

**Muhammad Iqbal Forester**

The official was originally maintained in the Seniority List of Conservator of Forests Southern Circle Peshawar.

Soon after creation and subsequent bifurcation of Conservator of Forests Southern Circle Bannu, during 2022, the official has been retired from service vide DFO D.I.Khan Office Order No.23 dated 2/10/2023, therefore, his name will be deleted from the Seniority list during next time. (Annex-XV)

- 7. Incorrect. As explained in Para-3, 4 &6 above.
- 8. Incorrect and denied. The other persons were regular employees but inadvertently shown in project.
- 9. The appeal as time barred. There for,instent service appeal as also barred by time

10. Incorrect. The appeal is not maintainable and as laibel to be dismissed being barred by time and devoid of merit.

**Ground:**

- H. Incorrect as explained in Para-G above.
- I. Incorrect as explained in Para-G above.
- J. Incorrect the Appellant has been treated as per law and rules.
- K. No comments.

In view of the above ex-position, it is therefore most humbly prayed that on acceptance of this Para wise reply the instant service appeal may kindly be dismissed with cost.
