#### FACTS:-

- Correct, Pertains to record.
- 2. In-correct. The appellant has never been senior most as evident from seniority list stood on 31/12/2022(Annexure-A). As per existing Service Rules for the post of Junior Clerk notified by Govt of Khyber Pakhtunkhwa Forest Department vide Notification No. SO(FT:II)/AD/I-465/88/Vol-IV, dated 26-01-1993 (Annexure-B) the promotion quota is 20%, wherein the cadre of Mali is not included for promotion to the post of Junior clerk.
- 3. Correct.
- 4. Since Khyber Forest Division had been part of FATA Circle under the Administrative Control of FATA Secretariat and at that time the promotion of M/S Syed Muyasir Shah



cleaner and Mr. Khalil Khan Badraga were made on the rules of Establishment Department issued vide Notification No. SOE-IVE&AD/1-35/2012, dated 06/12/2012 (Annexure-C), where in all the cadres of class-IV were included to be considered for promotion to the post of Junior Clerk. Upon the merger of FATA into Khyber Pakhtunkhwa province and with the abolishing of FATA Secretariat, the Forest staff of Khyber and other districts of Newly Merged Areas (NMDs) came under the main stream of Khyber Pakhtunkhwa Forest Department where the Forest Department has its own Service Rules for the promotion to the rank of Junior Clerk from NaibQasid and Daftari only.

- In-correct. No such amendment in the Service Rules for promotion of Class-IV to rank of Junior Clerk has been notified in the year 2019.
- 6. In the year 2021, promotion of Class-IV to the post of Junior Clerk on circle basis were made under the existingService Rules of Forest Department notified vide Notification No. SO(FT:II)/AD/I-465/88/Vol-IV dated 26-01-1993 (Annexure-B). As per existing Service Rules the cadre of Mali Is not entitled for promotion to the post of Junior Clerk, therefore the appellant being serving as Mali in Khyber Forest Division has not been considered for promotion. No promotion of Class-IV to the post of Junior Clerk has been made in Khyber Forest Division and Central Forest Circle during the year-2022.
- 7. Correct to the extent that the appellant has filed an appeal for his promotion to the post of Junior Clerk, which was not considered keeping in view the existing Service Rules of Junior clerk, however his case for promotion will be considered as and when the necessary amendment in the Service Rules for the rank of Junior Clerk is notified.


