The last order impugned before the Tribunal is a notification issued by the Director, Elementary and Secondary Education Khyber Pakhtunkhwa on 30.09.2022, wherein, the appointment of the appellant as PST was admitted and the allegation against the appellant was that he had left his station of duty without formal approval/NOC of the authority concerned and got appointed himself as CT Teacher vide fake, forged and even unlawful order dated 01.10.2007 and as a result thereof, his services as CT Teacher were terminated vide order dated 08.02.2012 by the then EDO (E&SE) D.I.Khan in the light of the recommendations of the scrutiny committee constituted on the directions of the Service Tribunal vide judgment dated 27.10.2011. The learned District Attorney has also contended that the appellant was in his probation period as PST and had quitted the job of his own and got appointment as CT Teacher, which appointment was ultimately fake and bogus. Besides, the appellant contends that there were similarly placed people, who were given different treatment by reinstating/reverting them to the posts from where they were allegedly appointed vide the fake/forged orders of 1613 teachers. We have also been informed that apart from the PSTs there were some employees of other departments including the Police and Agriculture Department, who were reportedly reverted back and
