## SUBJECT: PROPER REPLY IN EXECUTION PETITION NO. 128/2021 TITLE AMIR BAYAN VERSUS SENIOR MEMBER BOARD OF REVENUE AND OTHERS

With reference to your order dated 12.10.2022 passed by the Tribunal in Execution petition No. 128/2021 proper reply is as under:-

It is submitted that during the discussion in Departmental Promotion Committee Meeting held on 13.06.2022 (Annex-A), it was observed that as per Tehsildari Rules 2015, 15% quota was reserved for Senior Clerk to the post of Naib Tehsildar at Divisional level. One Mr. Mohammad Khan Senior Clerk office of the Commissioner Bannu Division, was promoted to the post of Naib Tehsildar as per joint Seniority List from Bannu Division. In the year 2016, rules were ammended and 12% quota was reserved for Senior Clerks and Junior Scale Stenographers offices of the Commissioner and Deputy Commissioners of the province, while 03% quota was reserved for Senior Clerk and Junior Scale Stenographers office of the Board of Revenue. Under 12% quota reserved for JSS/Senior Clerks offices of the Commissioner and Deputy Commissioners in Bannu Division 02 posts were falling in their share against total 17 posts reserved for Senior Clerks/ Junior Scale Stenographer offices of the Commissioner and Deputy Commissioners in Bannu Division. One Mr. Muhammad Khan Senior Clerk office of Commissioner Bannu has already been promoted to the post of Naib Tehsildar leaving behind only one post of Naib Tehsildar under 12% quota reserved for Junior Scale Stenographers/Senior Clerks of Bannu Division. Even if the DPC meeting was convened, the appellant could not be promoted to the post of Naib Tehsildar being at S. No 3 of the joint seniority list (Annex-B).

Furthermore, at present there is no provision in Service Rules for promotion of Junior Scale Stenographer to the post Naib Tehsildar, therefore the request of the petitioner for promotion as Naib Tehsildar does not cover the rules and cannot be acceded to as the appellant does not fulfill the criteria for promotion. The order/judgment dated 19.01.2019 also clearly speaks that "Whenever the applicant fulfills the criteria and right is vested in him for promotion, his case be considered in the prescribed manner, for promotion to the post of Naib Tehsildar". Since the appellant/petitioner does not fulfill the criteria, therefore he cannot be considered for promotion as Naib Tehsildar.

After detailed discussion in the meeting it was unanimously decided that the official was not eligible for appointment to the post of Naib Tehsildar as he was at serial No. 03

of the Joint Seniority list of Junior Scale Stenographers and Senior Clerks for the year 2018 of Bannu Division at that time.

Keeping in view the above, the Execution petition of the petitioner having no legal ground may be dismissed with costs.



### WORKING PAPER

SUBJECT: PROMOTION OF MR. BAYAN STENOGRAPHER (BPS-14) OFFICE OF THE COMMISSIONER LAKKI MARWAT TO THE POST OF TEHSILDAR (BPS-14) AS PER JUDGMENT OF THE SERVICE TRIBUNAL 19.01.2021 IN SERVICE APPEAL NO. 1026/2011 AND EXECUTION PETITION NO. 128/2020.

Facts of the case that the appellant namely Amir Bayan initially appointed at Junior Scale Stenographer in the office of Deputy Commissioner Lakki Marwat on 18.11.1992 and was promoted as Naib Tehsildar Tajori (OPS) on 10.05.2010. Commissioner Bannu Division Bannu, issued repatriation order of the appellant to his parent office. Felling aggrieved, the appellant filed appeal before the Service Tribunal which was partially accepted on 09.01.2019 and it has been held in the said judgment that "Respondent are directed that whenever, the appellant fulfills the criteria and right is vested in him for promotion, his case be considered, in the prescribed manner, for promotion to the post of Naib Tehsildar" (Annex-A).

The appellant also filed execution petition. This office filed comments in light of execution petition, but the Service Tribunal directed as per order sheet dated 07.06.2022 that:- keeping in view the judgment of this Tribunal coupled with the material available on the file, representative of respondents is strictly directed to make sure submission of implementation report. Moreover, respondent No. 3 As(E) be also put on the notice with direction to attend Service Tribunal in person in order to apprise this Tribunal in respect of implementation of judgment "the case is now fixed for 18.07.2022 (Annex-B).

In the last order sheet dated 23.05.2023 the Chairman Service Tribunal held that:-

There is no proper report but a misguiding report was submitted. There is no representation of the department in utter disregard of the standing instruction of the Establishment Department. No well conversant officer of Grade-17 was present before the Tribunal. There is no assistance from the department side, therefore, the Tribunal is constrained to attach the salaries of the respondents till final implementation of the judgment. Copy of this order sheet be sent to the Senior Member Board of Revenue (SMBR) to look into the conduct of his subordinates. To come up for proper implementation report on 20.06.2023 before S.B.P.P given to the parties (Annex-C).

As per Tehsildar/ Naib Tehsildar Rules 2015, 15% quota was reserved for Senior Clerks offices of the Deputy Commissioners and Commissioner of the concerned Division to the post of Naib Tehsildar. M/S Abdus Salam Senior Clerk Board of Revenue, and Mohammad Khan Senior Clerk office of the Commissioner Bannu

In the year 2016, Rules were again amended and 12% quota was reserved for Senior Clerks and Junior Scale Stenographers offices of the Commissioner and Deputy Commissioner, while 03% quota was reserved for Senior Clerks and Junior Scale Stenographers of Board of Revenue (Annex-E).

Under 12% quota reserved for JSS/Senior Clerks offices of the Deputy Commissioners Commissioner of the concerned Division 2.4 post were fallen in their share against which one Mr. Muhammad Khan has already been promoted as Naib Tehsildar on 27.05.2015, leaving behind only one post of Naib Tehsildar. even if the DPC meeting was convened the appellant could not be promoted to the post of Naib Tehsildar being at S.No. 2 of the joint seniority list (Annex-F). On 1305.2019 Rules were amended and 12% quota reserved for Senior Clerk/Junior Scale Stenographer offices of Deputy Commissioner and Commissioners of the concerned Division and omitted/deleted (Annex-G) Now rules has been amended and 06 % quota has been reserved for S/Clerks and Junior Scale Stenographers (BS-14) of the offices of the Deputy Commissioners and Commissioner of the concerned Division for promotion to the post of Naib Tehsildar (BS-14) (Annex-H). It is pertinent to mention here that there are total 23 sanctioned posts of Naib Tehsildars in Bannu Division. Under 06 % reserved quota, 1.38 post comes in the share of Senior Clerk/Junior Scale Stenographer. At present there is no post of Naib Tehsildar (BS-14) is laying vacant in Bannu Division to accommodate the appellant. However, 12 posts of Naib Tehsildars under direct quota are laying vacant. The process of Public Service Commission will take sufficient time. To implement the order/Judgment of Khyber Pakhtunkhwa Service Tribunal Acting Charge appointment could be made against the initial quota till the arrival of recommendees of the Public Service Commission.

Case is placed before the Departmental Promotion Committee to determine the suitability of Mr. Amir Bayan Junior Scale Stenographer office of the Deputy Commissioner Lakki Marwat to the post of Naib Tehsildar in light of Service Tribunal judgment dated 19.01.2021 and order sheet dated 23.05.2023.
