



Preliminary objections:

1. That the appellant has got no cause of action locus standi.
2. That the instant Service appeal is badly time barred.
3. That the appellant has concealed material facts from the Hon'able Tribunal in the instant service appeal.
4. That the instant service appeal is against the relevant provisions of law.
5. That the appellant has not come to this Hon'able Tribunal with clean hands.
6. That the instant appeal is liable to be dismissed for mis-joinder & non-joinder of the necessary parties to the present appeal.
7. That the appellant is estopped by his own conduct to file the instant appeal.
8. That the instant service appeal is not maintainable in the present form & circumstances of the case.

FACTS

1. That Para No: 1 of the fact is pertains to record.
2. That Para No: 2 of the fact is pertains to record.
3. That Para No: 3 of the fact is incorrect, the appellant has been appointed on the domicile of Ex FR Kohat and served there up to 04.11.2021 on his own request the appellant was transferred from GHS Turki Ismail Khel NMD Kohat to GCHS Kohat. Before filing the instant Service appeal before this Hon'able Service Tribunal Khyber Pakhtunkhwa, the appellant had requested for including his name in the CT/SCT Cadre Seniority list the respondent department honoured his appeal for inclusion his name into Seniority list (**Copy annexed as annexure A**), a committee was constituted (**Notification annexed as annexure B**) and in the recommendation of the Committee (**Copy annexed as annexure C**) his name was included in CT/SCT Seniority list in the light of APT Rules 1989 Rules 8 (2) (**Copy of seniority list annexed as annexure D**). As the present plea of the appellant before this Hon'able Service Tribunal has already been decided of by the respondent department as accordingly.
4. That Para No: 4 of the fact is correct only to the extent that the appellant was transferred as per written statement/application.


5. That Para No: 5 of the fact is incorrect, the name of the appellant has been incorporated on his own request in CT/SCT Cadre seniority list issued.(Copy of Revised Final seniority is already annexed as annexed D)
6. That Para No: 6 of the fact is incorrect, the appellant has already been treated in accordance with law by the respondent Department and replied the representation in shape of even minutes with official circular copy **annexed as annexure E**)

GROUND:-

- A. That Para No: A of the ground is incorrect the respondent Department according & It is worth mentioning here as the appellant instance so taken has already been redressed by inclusion of his name in the CT/SCT seniority list according to law has gain the finality, but so far as the rest of the claim regarding promotion is unjustifiable as he was after merger at the disposal of EX FATA, so from the date of his transfer i.e. 04.11.2021. He would be treated according to seniority rules for promotion in which his status is not legible. Hence denied so the factum of the violation of the article of constitution not in vogue.
- B. That Para No: B of the ground is incorrect the appellant request has already been redressed by the respondent department as stated vide Para No: 3 of the fact above.
- C. That Para No: C of the ground is incorrect, the present plea before this Hon'able Service Tribunal Khyber Pakhtunkhwa has already been disposed off by the respondent Department.
- D. That Para No: D of the ground is incorrect the respondent department is still not clear about the Para D as to whether the Rules 17(5) so referred in appeal is still not made in Appointment Promotion Transfer Rule s and as per record 17(5) is not been drafted by the subordinate legislation till to date but the appellant should provide 17(5) rules before the tribunal otherwise the entire Para is totally incorrect.
- E. That the respondent Department has never ever violated the APT rules 1989 and amendment made therein APT rules 1989.
- F. That the respondent Department will adduce some other ground at the time of arguments with the gracious permission of this Hon'able Tribunal.

PRAYED

It is therefore humble prayed that on acceptance of this reply instant appeal may very kindly be dismissed with cost.







As far the teacher (Mahmood Shah S/O Surat Shah) at serial 63, highlighted by the appellant, is concerned, he was appointed at serial 11 in the merit order of initial appointment against the post of CT, thus stands senior to Mr. Muhammad Ismail. As per APT Rules 1989, "If a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted the person promoted first shall rank senior to the person promoted subsequently; provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for time being for want of certain information or for complete record or for any other reason not attributing to his fault or demerit". The clauses of the order issued by the Directorate of E&SE KP vide Notification Endst No. 1834-40/File No. 1/Promotion Senior CT B-16: Dated Peshawar the 12/01/2015 vividly depict that his promotion order was not issued in continuation to the previous order in which he was superseded, rather stands as 'separate order' after the earlier one. If the appellant felt aggrieved from the order issued earlier in which he was superseded, he should have filed a departmental appeal, and if rejected or not responded within three months, he should have suited a case in the court of law. Since, he didn't demand any remedy in due course of time, therefore, the appellate committee deems his case 'superseded' and hence dismisses his appeal.</p> <p style="text-align: right;"><i>Pls. 
