Parawise Comments are submitted as under:-

PRELIMINARY OBJECTIONS

1. That the appellant has got no cause of action.

2. That the appeal is bad for misjoinder/non-joinder of necessary parties, because the affectee officials are not arrayed in the column of respondents.

3. That the appeal is badly time barred.

4. That the appellant has not come with clean hands.

5. That the appellant is estopped due to his own conduct.

6. That the appellant has concealed the material facts from Honourable Tribunal.

REPLY ON FACTS

- 1. Pertains to record.
- 2. Pertains to record.
- 3. That appellant appeared in training in the term ending 20.09.2011, but was declared to reappear in few subjects. *Copy is Annexure "A"*

4. Pertains to record. However, he was declared pass in lower college course in the term ending 20.03.2012. *Copy is Annexure "B"*

- 5. Incorrect. That the appellant appeared in the lower course term ending dated 20.11.2011 but unfortunately due to failure in a few subjects reappeared in the next term and after passing was placed in the same term ending 20.03.2012 and the seniority was fixed with his colleague alongwith those who were passed the examination in term ending 2012 as per merit list of PTC Hangu.
- 6. Incorrect. Correction would have been made, if there had been any mistake on the part of the department. In fact, the appellant was unable to qualify the term ending 2011 due to failure in a few subjects and while he passed in the next term 2012, he was placed with colleagues who failed and passed with him in 2012 as well as all passed candidates of the same term 2012.

7. Pertains to record. The selection for intermediate college course is as per merit of lower college course/List C-I.

8. That the appellant was treated in accordance with law/rules. In fact, the petitioner could not qualify for the term ending on 20.09.2011 due to failure in a few subjects and re-appeared for the next term ending on 20.03.2012, where he was placed in the same term and his seniority was fixed alongwith other colleagues who were passed lower college course in term 2012, as per to law/rules.

- 9. Correct to the extent that on the request of the appellant, his seniority was revised on the directions of Worthy RPO DIKhan in need of time, which was subsequently challenged by other employees on this out-of-turn promotion. After adequate guidance was sought from the CPO, the appellant got out of turn seniority which is the clear violation of Apex Supreme Court of Pakistan Ruling vide SCMR 2013-1752 and SCMR 2017-206 titled Shahid Pervez Vs. Ijaz Ahmad and others, Intra Court Appeal 2017/2018 dated 13.05.2018 and judgment in Civil Petiton No. 1996, 2026, 2431, 2437 to 2450, 2501 and 2502 of 2019 dated 20.06.2020 pertains to out of turn promotion of Police Official/Officers, hence, the same was withdrawn in order to safeguard the rights of other police officers being affected.
- 10. Correct to the extent that his other colleagues namely Ghazanfar Abbas, 1223, HC Saadat Khan No. 492 and HC Faiz ur Rehman who failed & passed with him challenged his out-of-turn promotion to be place in the same position. In this regard, CPO Peshawar was approached for seeking guidance. The matter was threadbare discussed and examined at CPO level. The competent authority is opined that Police Rules 1934 is silent about the fixation of seniority of Police officers who fail to qualify the promotion occurs with their batch-mates. Therefore, the general principle of fixation of seniority with batch mates in accordance with merit of training institution will follow. Hence, their seniority with batch/trainees of lower course of the year 2012 has rightly been fixed. The appellant actually got out of turn seniority which is the clear violation of Apex Supreme Court ruling (mentioned above), hence the same was withdrawn in order to protect the rights of other police officers being affected.
- 11. Incorrect. The other colleagues of appellant challenged his out-of-turn promotion to be place in the same position. In this regard, CPO Peshawar was approached for seeking guidance and their seniority with batch/trainees of lower course of the year 2012 has rightly been fixed. The appellant actually got out of turn seniority which is the clear violation of Apex Supreme Court of Pakistan Ruling, hence the same was withdrawn.
- 12. Correct to the extent that against the out of turn promotion of appellant his other namely Ghazanfar Abbas, 1223, HC Saadat Khan No. 492 and HC Faiz ur Rehman who failed & passed with the appellant, challenged his out of turn promotion to be placed in the same position, which is the clear violation of Apex Supreme Court of Pakistan ruling. Hence, their combined application was denied in order to preserve the rights of other police officers.
- 13. Incorrect. The matter was threadbare discussed and examined at CPO level. The competent authority is opined that Police Rules 1934 is silent about the fixation of seniority of Police officers who fail to qualify the promotion occurs with their batch-mates. Therefore, the general principle of fixation of seniority with batch mates in accordance with merit of training institution will follow. Hence, their seniority with batch/trainees of lower course of the year 2012 has rightly been fixed. In order to ensure merit and transparency and fixation of seniority of police officers, the revised seniority to HC Abdul Waheed No. 1007 may be recalled because the same was found against the prescribing law and rules.
- 14. Incorrect. Appellant actually got out of turn seniority which is the clear violation of **Apex Supreme Court ruling (mentioned above)**, hence, the same was withdrawn in order to safeguard the right of others police officers being affected. Before withdrawal of his out of turn seniority, he was provided an opportunity of personal hearing by the competent authority on 22.06.2023.
- 15. Incorrect. Misleading and misconceived. Infact, orders of the respondents are quite competent, legal, lawful and in accordance with law/rules and norms of justice, he liable to be upheld. The appeal in hand is meritless and without lawful effect, may be dismissed on the following grounds.

REPLY ON GROUNDS

- A. Correct to the extent that the appellant appeared in the lower course term ending dated 20.11.2011 but unfortunately due to failure in a few subjects reappeared in the next term and after passing was placed in the same term ending 20.03.2012 and the seniority was fixed with his colleague.
- B. Incorrect. No such violation of laws or natural justice has been caused. In fact, the petitioner could not qualify for the term ending on 20.09.2011 due to failure in a few subjects and re-appeared for the next term ending on 20.03.2012, where he was placed in the same term and his seniority was fixed according to law/rules.
- C. Incorrect. The matter was threadbare discussed and examined at CPO level. The competent authority is opined that Police Rules 1934 is silent about the fixation of seniority of Police officers who fail to qualify the promotion occurs with their batch-mates. Therefore, the general principle of fixation of seniority with batch mates in accordance with merit of training institution will follow. Hence, their seniority with batch/trainees of lower course of the year 2012 has rightly been fixed. The appellant actually got out of turn seniority which is the clear violation of Apex Supreme Court of Pakistan Ruling vide SCMR 2013-1752 and Scmr 2017-206 titled Shahid Pervez Vs. Ijaz Ahmad and others, Intra Court Appeal 2017/2018 dated 13.05.2018 and judgment in Civil Petiton No. 1996, 2026, 2431, 2437 to 2450, 2501 and 2502 of 2019 dated 20.06.2020 pertains to out of turn promotion of Police Official/Officers, hence the same was withdrawn in order to protect the rights of other police officers being affected.
- D. Incorrect. No such injustice has been caused, the seniority of the appellant has been fixed with his other failed colleagues in the next passing term and selected for intermediate college course in time with his passing colleagues.
- E. Incorrect. Appellant actually got out of term seniority which is the clear violation of Apex Supreme Court ruling (mentioned above), hence, the same was withdrawn in order to protect the rights of other police officer being affected.
- F. Incorrect. Neither the seniority is affected nor anyone has a hand in it. Infact it is his own fault because he could not qualify the term 2011 due to failed in few subjects and reappear in a next session/term 2012.
- G. Incorrect. There has been no misconceived or wrongly understood, Infact the appellant failed in few subject and repair in next term ending 2012, therefore his seniority has been fixed with his passed colleagues.
- H. Incorrect. Infact, the appellant disqualify the term 2011 and reappear/passed in next session/term i.e. 20.03.2012 due to which he has fallen behind the previous term ending 20.09.2011 as well the officers who have passed in that term, while his seniority has been fixed with his passed colleagues' term ending 20.03.2012.
- I. Correct to the extent that nothing like that happened in this case, due to his fault could not qualify the term 2011 and reappear/passed in next session/term 2012, hence his seniority has been fixed with his passed colleagues term ending 20.03.2012.
- J. Incorrect. Appellant actually got out of term seniority, which is the clear violation of **Apex Supreme Court ruling (mentioned above)**, hence the order of Respondent No.2 has been withdrawn by the Respondent No. 1 in order to protect the rights of other police officer being affected.
- K. Incorrect. No such seniority of appellant has been revised, however, his out of turn promotion has been withdrawn and his seniority was fixed with his batch mates /traninees of lower course of the year 2012 and before passing the order an opportunity of personal hearing has already been given to the appellant.
- L. Incorrect. As stated above, Para-K.
- M. Incorrect. An opportunity of personal hearing also given to the appellant before passing the orders but the appellant failed to produce any plausible explanation in his defence.

- N. Incorrect. The matter was threadbare discussed and examined at CPO level. The competent authority is opined that Police Rules 1934 is silent about the fixation of seniority of Police officers who fail to qualify the promotion occurs with their batch-mates. Therefore, the general principle of fixation of seniority with batch mates in accordance with merit of training institution will follow. Hence, their seniority with batch/trainees of lower course of the year 2012 has rightly been fixed. In order to ensure merit and transparency and fixation of seniority of police officers, the revised seniority to HC Abdul Waheed No. 1007 may be recalled because the same was found against the prescribing law and rules. Appellant actually got out of term seniority, which is the clear violation of Apex Supreme Court ruling (mentioned above), hence the order has been withdrawn in order to protect the rights of other police officer being affected.
- O. Pertains to record.
- P. That the Respondents also seek permission to produce additional grounds/documents at the time of arguments.

PRAYER

In view of above, it is humbly prayed that on acceptance of these Parawise Comments, the instant appeal may kindly be dismissed, being meritless and not maintainable.
