ORDER:

Ex-Constable Mohiz Shahzad No.538 of this district while posted at Police Lines Abbottabad was awarded major punishment of dismissal from service vide this office OB No. 280, dated 18-12-2019, due to involvement in case FIR No.645, dated 01-09-2019 u/s 324 PPC PS City Abbottabad and case FIR No.709, dated 18-09-2019 u/s 9C-CNSA PS Sirband Peshawar. He preferred a Departmental Appeal before the then Regional Police Officer, Hazara Region Abbottabad which was filed vide Order No.16016-17/PA, dated 07-07-2020. Consequently, he instituted a Service Appeal No.9406/2020 titled Mohiz Shahzad Ex-Constable verses IGP KP and others before the Honorable Service Tribunal, Khyber Pakhunkhwa, Peshawar Camp Court Abbottabad wherein Honorable Service Tribunal set aside the Dismissal order as well as order passed by the Appellate Authority and directed to reinstate the appellant in service and remitted the case to the department with the directions to conduct proper de-novo enquiry in accordance with law within 90 days of receipt of this judgement.

On receipt of order, the case was taken up with competent authority for filing of CPLA before August Supreme Court of Pakistan against the order dated 19-06-2023 passed by Honorable Service Tribunal KPK, Peshawar, Camp Court Abbottabad in Service Appeal No.9406/2020, vide this office letter No.3601/Legal, dated 13-07-2023 but the competent authority has directed vide letter No.3524/Legal, dated 06-09-2023 received from the office of AIG, Legal, CPO, Peshawar to implement the Judgement dated 19-06-2023.

In compliance of order, dated 19-06-2023 passed by the Honorable Service. Tribunal, Khyber Pakhtunkhwa, Peshawar Camp Court Abbottabad in Service Appeal No.9406/2020 titled Mohiz Shahzad Ex-Constable verses Inspector General of Police, KP and others and directions received from the competent authority vide above quoted reference letter. Ex-Constable Mohiz Shahzad No.538 is hereby provisionally reinstated in service with effect from 19-06-2023 for the purpose of conducting de-novo enquiry. The back benefits shall be decided subject to the outcome of the de-novo enquiry proceedings.
