R.SHEWETH: ON FACTS:

- 1- That appellant was appointed as primary school teacher on the proper recommendation of Departmental selection Committee vide order dated 4.9.1984. That after appointment the appellant submitted her charge report and started performing her duty at the concerned station quite efficiently and up to the entire satisfaction of her superiors.
- 2- That right from appointment till issuance of the impugned order dated 28.7.2009 the appellant has served the respondent Department at far flung areas of District Malakand and as such no complaint whatsoever was received against the appellant.
- 3- That appellant while performing her duty at the hardest station applied for Extra Ordinary leave w.e.f. 1.9.2003 to 17.8.2004 which was allowed to appellant. That after expiry of the said leave the appellant submitted another application for the extension of her leave but no response was received from the concerned quarter.
- 4- That appellant time and again requested the concerned quarter for the extension of her leave but no response was given to the said request of appellant by the concerned authority.
- That appellant lastly received the impugned order dated 28.7.2009 on 25.2.2016 whereby she was removed from service on the allegation of absentia.
 - 6- That appellant having more than 21 years service at her credit and as such the appellant is fully entitled for her pensionary benefits but the concerned authority instead of knowing the fact has issued the impugned order dated 28.7.2009 against the appellant.

7- That appellant feeling aggrieved filed the instant Departmental appeal on the following grounds amongst the others.

GROUNDS:

- A- That the impugned order dated 28.7.2009 is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- B- That appellant has not been treated by the concerned authority in accordance with law and rules and as such the concerned authority violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That no charge sheet and statement of allegation has been served by the concerned authority on the appellant before issuing the impugned order dated 28.7.2009.
- D- That no show cause notice has been served on the appellant by the concerned authority before issuing the impugned order dated 28.7.2009.
- E- That no chance of personal hearing/defense has been provided to the appellant and as such the appellant has been condemned unheard.
- F- That no regular inquiry has been conducted before issuing the impugned order dated 28.7.2009 against the appellant which is as per Supreme Court judgments is necessary before awarding major punishment to civil servant.
- G- That no publication has been issued against the appellant prior to the impugned order dated 28.7.2009 and as such the impugned order id void ab anitio in the eye of law.
- H- That the authority acted in arbitrary and malafide manner while issuing the impugned order dated 28.7.2009 against the appellant.
- I- That appellant seeks permission to advance other grounds and roofs at the time of hearing.

That on acceptance of this appeal the impugned order dated 28.7.2009 may very kindly be set aside and the concerned authority may be directed to re-instate the appellant with all back benefits. Any other remedy which your good self deems fit that may also be awarded in favor of the appellant.
