3. That the appeal has been pending since a long time and therefore requires an early date to be fixed for hearing.

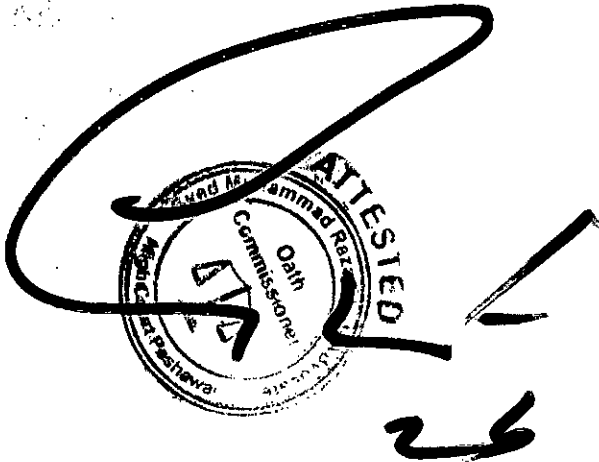
4. That it is in the best interest of justice and proprietary demands that the appeal may please be heard early.


