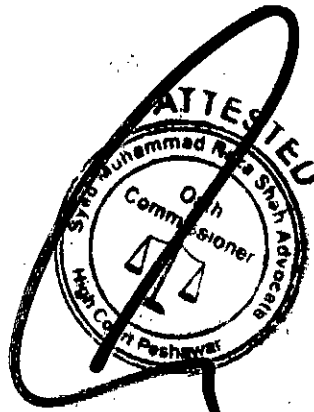
1. That the above titled case is pending adjudication before this Honourable Tribunal, and the date of hearing is 29-03-2023.
