

**PRELIMINARY OBJECTIONS:**

- That the petitioner has got no cause of action.
- That the petitioner has no locus standi against the present respondent.
- That the petitioner has not come with clean hands.
- That the petition is filed with malafide intentions.
- That the petitioner has been stopped by his own conduct.

**PARAWISE REPLY/COMMENTS ON FACTS:**

Admitted to the extent that a second tentative seniority list, circulated on 10.01.2023, in which not only the seniority position of the appellant was changed but of other employees as well, owing to the reason that two different advertisements were published for the filling in of different posts, but selection was carried out simultaneously, however there is a slight gap of 6 days for issuing appointment orders of the candidates selected in wake of the two advertisements.

- a. The appellant raised an objection to his seniority which was turned down on the basis of his date of acquiring SSC and date of birth.



6. Sufficiently commented on in Para No. 5. However, the seniority of Class-IV is based on their date of acquiring SSC and date of birth.

**PARAWISE REPLY/COMMENTS ON GROUNDS:**

- A. Admitted to the extent that the appeal of the appellant was turned down for cogent reasons. The remaining para is incorrect, therefore, denied.
- B. Admitted. The detail is mentioned above.
- C. To the extent of his appointment, admitted. The remaining para is incorrect, therefore, denied.
- D. As already pointed out, two different advertisements were published, however, selection was carried out with a gap of 6 days only. The seniority list has been issued according to rules and regulations.
- E. Already replied in the preceding Paras.
- F. Seniority has already been determined in view of date of passing SSC.
- G. No comments, as the position of the two units is different from each other.
- H. The seniority position has been explained adequately in the preceding paras.
- I. No injustice has been done to the appellant, hence denied.

Therefore, it is prayed that the para-wise comments of this administration may please be given due weightage and the appeal of the applicant may please be dismissed.
