JUDGMENT

ATIQ-UR-REMHMAN WAZIR MEMBER (E):- Brief facts of the case are that the appellant was appointed as Behishti vide order dated 12-11-2013, but such order of appointment was cancelled vide order dated 18-02-2014, against which the appellant filed a writ petition No 128-D/2014. The writ petition was allowed vide judgment dated 12-02-2015 in favor of the appellant but the respondents were also allowed to conduct a de-novo inquiry in accordance with law. The respondents conducted de-novo inquiry and as a result of de-novo proceedings, the appellant was terminated from service vide order dated 22-09-2018, against which the appellant filed departmental appeal dated 22-10-2018, which was not responded,

hence the instant service appeal with prayers that the impugned order dated 22-09-2018 may be set aside and the appellant may be re-instated with all back benefits.

- Deen treated in accordance with law and actions of the respondents are malafide besides being discriminatory and harsh; that the respondents without re-instating the appellant, initiated inquiry without associating the appellant in the disciplinary proceedings; that appointment of the appellant was in accordance with the prescribed legal procedure and after observing all the legal formalities; that the appellant has been penalized without giving him opportunity of hearing; that no show cause was issued before passing the impugned order, which is against the principles of natural justice.
- Learned Deputy District Attorney for the respondents has contended that appointment order of the appellant was not issued by the competent authority i.e. District Education Officer, rather he was appointed by Head Mistress of the school without having the authority for such appointment, without advertisement, without merit and without approval of the departmental selection committee; that appointment order of the appellant was cancelled as per law and rule; that upon directives of the honorable High Court, de-novo proceedings were conducted and upon recommendation of the inquiry report, the appellant was terminated from service vide order dated 22-09-2018 and son of the Mr. Abdul Sattar, who had retired from the post of Behishti was appointed in his place on retired son quota, which was in accordance with law;
- 04. We have heard learned counsel for the parties and have perused the record.
- 05. Record reveals that one Mr. Abdus Sattar, who was serving as Behishti in the school, retired from service on 05-11-2013. Just after his retirement, Head Mistress of the said school appointed the appellant as Behishti vide order dated 12-

11-2013, but without observing codal formalities. The head mistress also was not competent to make such appointment. On the complaint of a local MPA, an inquiry was conducted in the case and it was found that the appellant has been appointed illegally and without observing the legal formalities, hence his appointment order was cancelled vide order dated 18-02-2014 and one Mr. Fiaz Hussain S/o Abdus Sattar was appointed against 25% quota reserved for sons of retired employees. Feeling aggrieved, the appellant filed a writ petition No 128-D/2014, which was allowed in favor of the appellant vide judgment dated 12-02-2015, but the respondents were also allowed to conduct de-novo inquiry. During the course of denovo proceedings, the appellant was afforded proper opportunity of defense, but the inquiry committee found his appointment order as illegal, hence in light of recommendations of the inquiry report, the appellant was terminated from service vide order dated 22-09-2018. We have observed that appointment order of the appellant was not made in accordance with law and by an incompetent authority. Subsequently son of the retired Behishti was appointed against the vacant post against the reserved quota of retired employees, which was made in accordance with the law. As per orders of the Honorable Peshawar High Court, a proper inquiry was conducted, where ample opportunity was afforded to the appellant to defend his cause but the appellant failed to defend his case. We have not noticed any irregularities in the instant case, hence does not warrant any interference.

06. In view of the foregoing discussion, the instant appeal is dismissed being devoid of any force. Parties are left to bear their own costs. File be consigned to record room.



Counsel for the appellant Safeer Khan present. Preliminary arguments heard. It was contended by learned counsel for the appellant that the appellant was appointed as Bahishti in Education Department. His appointment order was cancelled by the competent authority vide order dated 18.02.2014. The appellant challenged the same through writ petition before the worthy High Court and the worthy High Court disposed of the writ petition, set-aside the impugned order and the department was directed to conduct fresh inquiry into the matter through another competent inquiry officer, whose report shall be well-reasoned, but the petitioner should be given his due right of hearing before passing any order keeping in view the aforesaid observations vide judgment dated 12.02.2015. The respondent-department was not implementing the judgment of the worthy High Court therefore, the appellant filed Contempt of Court Application against the respondents before the worthy High Court and the worthy High Court disposed of the Contempt of Court Application vide order dated 24.09.2018 wherein the worthy High Court observed that the respondentdepartment had stated before the court that the appellant was terminated from service by the respondent-department vide order dated 22.09.2018 therefore, on coming to know, the appellant filed departmental appeal on 22.10.2018 which was not responded hence, the present service appeal. It was further contended that the respondent-department has not conducted inquiry proceeding as per rules or as per direction of the worthy High Court nor the appellant was provided opportunity of personal hearing and defence nor any show-cause notice was issued to the appellant therefore, the impugned order is illegal and liable to be set-aside.

The contentions raised by the learned counsel for the appellant need consideration. The appeal is admitted for regular hearing subject to deposit security and process fee within 10 days, thereafter, notice be issued to the respondents for written reply/comments for 24.09.2019 before S.B at Camp Court D.I.Khan.

- 3. That the petitioner according to the rules applies for the post by submitting his application. Copy of application is annexures C.
- 4. That the petitioner after observing all codal formalities appointed by respondent NO-4 on the post on12.11.2013. Copy of appointment letter is annexure D.
- 5. That the petitioner provide medical certificate, took the charge of post and performing his duties to utmost satisfaction of his superior Copy of medical certificate and charge certificate is annexure E.

That on the complaint of javed akbar khan MPA halqa that appointment of petitioner was made by competent authority without his consent so respondent NO-3 in absence of petitioner ,conducted an inquiry and cancelled the order of petitioner. - 1. That the appellants are not treated in accordance with law and the actions of the respondents are malafide besides being discriminatory and harsh.
- 2. That the respondent without reinstating the petitioner, initiated inquiry without calling the petitioner to defend himself .according to judgment dated 12.2.2015 the petitioner was not reinstated and inquiry was held in absentia without providing any opportunity to the petitioner. It is also and the admitted law that before conducting any inquiry against the petitioner, he should be reinstated in to service.
- 3. That appellant was entered in service after observing all codal formalities and appointed bahishti as per law and rules.
- 4. That appellants are being penalized without giving them any opportunity of hearing, they were neither associated with the proceeding of inquiry nor have given any show cause notice by the department, which is against the principal of natural justice.

In view of the above, It is, therefore, most respectfully prayed that on acceptance this appeal this honorable court may pleased to declare that order dated 22-09-2018 as illegal, void, without lawful authority and of no legal effect and respondents may pleased be directed to reinstate the appellant with all back benefits.



- 3. We have heard and considered the arguments of learned counsel for the petitioner in the light of available record of the case.
- 4. Whether the petitioner was appointed

rightly and competently in accordance with the relevant rules of the Government on the subject and whether the complaint of local MPA has any legal nexus/sanctity with the matter in hand are the questions which could well be answered by the official respondents/department, but the fact is that while passing the impugned order, respondent No.3 has not given any opportunity of hearing to the petitioner and thus the order having been passed at his back being in violation of principles of natural justice is liable to be struck down.

In wake of the above, the writ petition is allowed as prayed for and the impugned order is set aside. BRIEF HISTORY OF THE CASE

The District Education Officer (Female) Dera Ismail Khan Elementary & Secondary Education Department marked an enquiry regarding appointment of Mr Safeer Hussain S/O MulazimHussain R/O Said Allian, and Mr Fiyyaz Hussain S/O Abdul Sattar R/O Jarra Tehsil Paharpure D I Khan done by the Headmistress GGHS Kot Jai and DEO (Female) D I Khan respectively.

STATEMENT OF ALLEGATIONS

1. Headmistress GGHS Kot Jai Vide her No. 199-203 dated 12-11-2013 appointed Mr Safeer Hussain S/O MulazimHussain R/O Said Allian as Bahishti BPS-01 against the post which was vacated by Mr Abdul Sattar on his retirement by attaining the age superannuation on 05-11-2013. Mr Safeer Hussain took over the charge on 13-11-2013 and served till 24-02-2014. The DEO (Female) cancelled his orders Vide Endst: No 1426-28 dated 18-02-2014 on the complaint of Halqa MPA. Resultantly, Mr Safeer Hussain filed a writ petition before Honourable Peshawar High Court D I Khan bench and the Honourable Court set aside the termination orders of DEO (female) D I Khan on 12-02-2015 (Photocopy of Appointment Order, Attendance Resister, Charge Report, Cancellation Order and Written Statements are attached).

- 2. However, the District Education Officer (Female) Dera Ismail Khan appointed one Mr Fiyyaz Hussain S/O Abdul Sattar against the said vacant post of Bahishti on employee son quota Vide Endst: No. 1436-40 dated 18-02-2014. He took over the charge on 25-02-2014 and performing his duties and regularly drawing his pay since then to till date.
- 3. Mr Safeer Hussain has been given the right of hearing and a written statement has been received from him which is also attached along with the enquiry report. He gave his defense that he came to know about the vacant post of Bahishti through unknown source and he gave simple application and was appointed by the committee of the school.

FINDINGS.

The Enquiry committee observed the following findings which are evident from the record.

- 1. It is an astonishing fact that Mr Safeer Hussair, was appointed within 07 days after the retirement of Mr Abdul-Sattar.-Hence, the Headmistress was hasty and appointed haphazardly.
- 2. Another astonishing fact is that the said Headmistress constituted a committee for appointment where there was only one applicant Mr Safeer Hussain.
- 3. The Headmistress GGHS Kot Jai D I Khan lacks jurisdiction of appointment of a Bahishti because she has no appointment powers under the rules.
- 4. The letter she refers Director E&SED KPK Vide 2027-77 dated 12-12-2013 for appointment does not cover her jurisdiction which transpires that the act of appointment on her part was tricky and fraudulent because the appointment was done one month before the issuance of the said letter.
- 5. However, if the said Headmistress had having legal jurisdiction to appoint a Bahishti, the appointment of Mr Safeer Hussain had been made by neglecting and overlooking all codal formalities i.e. advertisement, shortlisting, interviews etc.

CONCLUSION

- 1. The appointment of Mr Safeer Hussain done by Headmistress GGHS Kot Jui D I Khan was fraudulent and had malafide intention.
- 2. Obviously, the available record shows that the appointment done by said Headmistress was in violation of the prevailing laws and, thus, cannot be blessed with any legitimacy or protection under any canon of law.
- 3. The responsibility is therefore fixed on the said Headmistress for highhandedness and making fake and malafide appointment.
- 4. Mr Fiyyaz Hussain Bahishti who was appointed by the competent authority on employee son quota may be retained at GGHS Kot Jai D I Khan.
- 5. However, Mr Safeer Hussain remained Bahiishti for more than two months. Hence, being poor and down trodden, his case may please be considered sympathetically and affectionately on humanitarian ground.

The Worthy <u>Judgment</u> passed on 24.07.2017 by the Honorable Khyber Pakhtunkhwa Service Tribunal, Camp Court D.I.Khan in <u>SA No. 1041/2014</u> filed by the Appellant Muhammad Asif S/O Hasti Khan, R.O Wanda Jamal, Ex-Sweeper GHS Wanda Jamal, D.I.Khan, who was appointed by the Head Master on 2.11.2013, <u>speaks on invalidity of appointment orders passed by the Head Master</u>, being not Competent for appointment of a Class IV Employee.
- 5. That the Head Mistress GGHS Kot Jai, D.I.Khan Mrs. Saeeda Parveen has, in respect of Mr. Safeer Hussain S/o Mulazim Hussain, wrongly issued, the appointment order (On Open Merit for the vacant post of Ex-Bahishti GGHS Kot Jai, who retired on 5.11.2013) without observing formal procedures (Advertisement / merit etc.) for recruitment to the post of Class IV; though, the post of Bahishti is a dying cadre and according to the letter forwarded by Establishment Department No. SOR-VI (E&AD)1-3/2007 dated 22.3.2007, the dying cadre posts shall stand abolished as and when fall vacant.

A brief History is humbly presented in the following lines for the kind perusal of this Honorable Tribunal:

a) On 5.11.2013: Mr. Abdus Sattar Class IV, Bahishti GGHS Kot Jai proceeded for retirement on superannuation.

b) On 12.11.2013: Mr. Safeer Hussain S/O Mulazim Hussain has been appointed to the post of Bahishti GGHS Kot Jai vide Order No.199-203, dated 12.11.2013, by the Headmistress, Saeeda Begum without advertisement and

without observing other formal procedures for recruitment to the post of Bahishti, though the post of Bahishti is a dying cadre and according to the letter forwarded by Establishment Department No. SOR-VI (E&AD)1-3/2007 dated 22.3.2007, the dying cadre posts shall stand abolished as and when fall vacant.

- c) On 18.02.2014: That Mr. Safeer Hussain S/O Mulazim Hussain has merely performed his duties for only 3 and a half months from 13.11.2013 to 27.2.2014 and his appointment order was cancelled on 18.2.2014 by the DEO (Female), D.I.Khan who subsequently appointed, on 25% quota, Mr. Fiaz Hussain S/o Abdus Sattar (Ex-Bahishti GGHS Kot Jai, who retired on 5.11.2013).
- d) On 12.2.2015: That the worthy Judgment of the Honorable Peshawar High Court dated 12.2.2015 strikes down the cancellation of appointment order issued by DEO Female D.I.Khan vide letter No.1426-28, dated 18.02.2014 in Respect of Mr. Safeer Hussain, passed in W.P No. 128-D of 2014. However liberty was, therein, granted by the worthy judgment to conduct a fresh inquiry into the matter through another competent Authority.
- e) On 1.11.2016: That Appointment order of Mr. Safeer Hussain S/O Mulazim Hussain was inquired into by DEO Female, D.I.Khan by Constituting an inquiry under Chairpersonship of Principal Syeda Nau Bahar, yet this inquiry was termed as illegal and set aside being ensued by NO RESULTS by the Worthy Order of Peshawar High Tribunal D.I.Khan Bench, Passed on 1.11.2016 in CoC No. 743-D/2015.
- 6. That in compliance to the Worthy Judgment of Peshawar High Tribunal D.I.Khan Bench, Passed on 12.2.2015 in W.P No. 128-D of 2014, that grants allows the respondents to conduct a fresh inquiry into the matter through another competent Inquiry officer. This provides grounds to constitute another inquiry (this one in 2018) that may assure, in terms of results, being fruitful with all legacies.
- 7. Therefore, a fresh inquiry has been conducted vide Notification No. 14910-16 dated
 14.7.2018 where the <u>Appellant Mr. Safeer Husssain was properly personally heard</u>.
 As per recommendations of the fresh inquiry,

The post of class IV, Bahishti, GGHS Kot Jai, be considered abolished. Hence this committee finds no reason for appointment of Safeer Hussain as Bahishti, GGHS Kot Jai. Yet this committee has no objection on fresh appointment of Mr. Safeer Hussain on open merit class IV post as per policy of the Government of Khyber Pakhtunkhwa.

8. In this connection the servant issued a Notification No. 20823-29 dated, 22/9/2018, that notifies on setting aside the wrongly issued appointment order and terminates the Services of the Appellant, Mr. Safeer Hussain S/o Mulazim Hussain, with immediate effect. The same was communicated to the Honorable Peshawar High Court along with inquiry report in COC Petition No.743-d/ 2015 and the worthy Judgment dated 24.9.2018 was passed that dismissed the Petition due to No Case of COC.

Therefore, it is humbly prayed that the instant Service Appeal may graciously be dismissed.

inquiry under Chairpersonship of <u>Principal Syeda Nau Bahar</u>, yet this inquiry was termed as illegal and set aside being ensued by NO RESULTS by the Worthy Order of Peshawar High Court D.I.Khan Bench, Passed on <u>1.11.2016</u> in CoC No. 743-D/2015.

- That Mr. Safeer Hussain S/O Mulazim Hussain has performed his duties from 13.11.2013 to 27.2.2014 unless his appointment order was cancelled on 18.2.2014 by the then DEO (Female), D.I.Khan who subsequently appointed Mr. Fiaz Hussain S/O Abdus Sattai (Ex-Bahishti GGHS Kol Jai, who retired on 5.11.2013).
- 6. The Worthy ludgment of Peshawar High Court D.I.Khan Bench, Passed on 12.2.2015 in W.P. No. 128-D of 2014, however, grants liberty to conduct a fresh inquiry into the matter through another competent inquiry officer. This provides grounds to constitute another inquiry (this one) that may assure, in terms of results, being fruitful with all legacies.

RECOMMENDATION:

The Perusal or record supported by the personal statements (on personal hearing) of the Headmistress and the Class IV candidate Mr. Safeer Hussain reveals:

- 1. That the Heild Mistress GGHS Kot Jai, D.I.Khan Mrs. Saeeda Parveen has, in respect of Mr. Safeer Fussaln S/o Mulazim Hussain, wrongly issued, the appointment order (On Open Merit or the vacant post of Ex-Bahishti GGHS Kot Jai, who retired on 5.11.2013) without observing formal procedures (Advertisement / merit etc.) for recruitment to the post of lass IV; though, the post of Bahishti is a dying cadre and according to the letter forwarded by Establishment Department No. SOR-VI (E&AD)1-3/2007 dated 22,3.2007, the dying cadre posts shall stand abolished as and when fall vacant.
- 2. That the then District Education Officer (Female) D.I.Khan has, alternatively, in respect of Mr. Fayy iz Hussain S/o Abdus Sattar (Ex-Bahishti GGHS Kot Jai, who retired on 5:11.2013), wrongly issued, in piece meal, the appointment order without observing formal procedures (Advertisement / merit etc.) for recruitment to the post of Class IV, though the post of Bahishti is a dying cadre and according to the letter forwarded by Establishment Department No. SOR-VI (E&AD)1-3/2007 dated 22:3.2007, the dying cadre posts shall stand abolished as and when fall vacant.
- 3. As the appointment of Mr. Fayyaz Hussain was already repealed / cancelled by the then DEO (Femal 1), D.I.Khan (Mrs. Perveen begum Khattak) vide Letter No.dated......in the light of the Establishment Department No. SOR-VI (E&AD)1-3/2007 dated 22.3,2007, that reads, "the dying cadre posts shall stand abolished as and when fall vacant".

This committee recommends that:

THE POST OF CLASS IV, BAHISHTI, GGHS KOT JAI, BE CONSIDERED ABOLISHED HENCE THIS COMMITTEE FINDS NO REASON FOR APPOINTMENT OF SAFEER HUSSSAIN AS BAHISHNI, GGHS KOT JAI. YET THIS COMMITTEE HAS NO OBJECTION ON FRESH APPOINTM INT OF MR. SAFEER HUSSAIN ON OPEN MERIT CLASS IV POST ANYWHERE AS PER POLICY OF THE GOVERNMENT OF KHYBER PAKHTUNLKHWA.

ALSO, name of Mr. Fayyaz Hussain S/o Abdus Sattar, Ex- Bahishti GGHS Kot Jal be placed on merit list for considering his appointment on 25 % EMPLOYEE SON QUOTA Quota, ON HIS OWN TURN AS PER POLICY OF THE GOVERNMENT OF KHYBER PAKHTUNKHWA.
