

Contends, inter-alia that in the seniority list of Senior Instructor dated 31.12.2016, the appellant was at Serial No.3 while the respondents No.3 to 6 were noted against Serial No.34 to Serial No.37. The appellant as well as respondents were upgraded to BS-17 and on 31.12.2017 another final seniority list was issued wherein the name of the appellant was mentioned against Serial No.31 while private respondents were shown against Serial No.25 to 28, respectively. The appellant was senior to them by virtue of his prior date of initially joining the service on 10.08.1984. The respondents were inducted in different years between 1987 to 1992. An appeal was submitted against the impugned entries in the seniority list on 10.11.2018 which remained un-responded till date.





Respectfully Sheweth,

Brief but relevant facts of the case are as follows:

1. That the appellant was appointed as Instructor (BPS-14) vide appointment on 01-01-1986, whereas the respondents No 3 to 6 were appointed as Instructors (BPS-14) on 28-04-1987, 27-06-1987, 17-02-1991 and 23-01-1992 respectively, in the respondent Department.
2. That later on, the appellant was promoted to the post of Senior Instructor (BPS-16) on 23-04-2007, whereas the respondents No 3 to 6 were promoted to the posts of Senior Instructors (BPS-16) on 27-12-2007 in the respondent Department.

3. That later on the post of Senior Instructor is upgraded from BPS-16 to BPS-17, hence the appellant and the respondents No 3 to 6 are upgraded to BPS-17.
 4. That thereafter the respondents issued the seniority list in the year 2016 wherein the appellant has right been shown senior than the respondents No 3 to 6. (Copy of the seniority list is filed herewith and annexed as **Annex-A**)
 5. That now the respondents have notified/issued the impugned final seniority list vide Notification dated 15-08-2018, wherein the appellant is shown junior to the respondents No 3 to 6 in utter disregard of the law, rules and policy. The appellant is shown at serial No 31, whereas respondents No 3 to 6 have been shown at serial No 25, 26, 27 and 28 respectively. (Copy of impugned seniority list is filed herewith and annexed as **Annex-B**)
 6. That against the aforesaid Notification, the appellant filed departmental appeal, which has not been decided and the statutory time has lapsed. (Copy of Departmental Appeal is filed herewith and annexed as **Annex-C**)

Hence the instant Service Appeal on the following amongst other grounds:

Grounds:

- a. That, the impugned Notification is against the law, illegal, unlawful, without lawful authority, void and ineffective upon the rights of the Appellant, thus calling interference of this Honorable Tribunal.
- b. That the impugned seniority list is in utter disregard of KP Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.
- c. That the impugned seniority list is in utter disregard of KP Civil Servants Act, 1973.
- d. That the Appellant is not treated in accordance with the law, rules and policy which is his inalienable right under Article 4 of the Constitution of Islamic Republic of Pakistan, 1973 and also the same is against the principle of natural justice also.
- e. That the respondents No 3 to 6 are junior than the appellant but have been illegally shown senior than the appellant in the impugned seniority list.
- f. That, the Respondents are violating all the basic Fundamental Rights and protections given to the Appellant in the Constitution of Islamic Republic of Pakistan, 1973.
- g. That the impugned seniority list is against the principles of administrative law, based on colorful exercise of powers and against the dictums of the August Supreme Court of Pakistan.



- h. That the Appellant craves permission of this Honorable Tribunal to rely on other grounds at the time of arguments and produce any additional document if required in support of his Service Appeal.

It is, therefore, prayed that on acceptance of this Service Appeal, the impugned seniority list to the extent whereby the appellant is shown junior to the respondents No 3 to 6 be declared as against the law, illegal, unlawful and ineffective upon the rights of the appellant and respondents may kindly be directed to correct the impugned seniority list to the effect that the appellant be shown senior than the respondents No 3 to 6 by giving him his due seniority position in the seniority list.

Any other relief which has not been specifically prayed for and deemed fit and appropriate by this Honorable Tribunal in the circumstances may graciously be granted.
