Terms and Conditions

- No TA/DA is allowed.
- Charge Reports should be submitted to all concerned.
- They shall initially be on probation for a period of one year extendable to another year.
- Their services are liable to termination on one-month prior notice from either side. In case of resignation without notice their one-month salary shall be forfeited to the Government treasury.
- They should join their posts within 15 days. In case of failure to join the post within 15 days, their appointment shall automatically stand expired and no subsequent appeal etc. shall be entertained.
- They are not allowed to take over charge if their age is less than 18 years and more than 43 years (including 03 years' automatic relation).
- Principal/Head Master/SDEOs concerned shall report / verify the arrival and charge taking of the newly appointed Class-IV within the stipulated period of 15 days.
- Health and Age Certificate should be produced from Medical Superintendent before taking over charge.
- They will be governed by such rules and regulation as may be issued from time to time by the Government.
- Their services shall be terminated at any time in case their performance is found unsatisfactory during their service period. In case of misconduct they shall be proceeded against under the relevant rules issued from time to time.
- Posting/adjustment is the discretionary powers of the Appointing Authority and no one has the right to claim for adjustment at any specific school.
- Their appointment is subject to further condition that they must have Domicile of District Buner.
- Errors and omissions will be accepted for further rectification within the specified period.
