- They should join their posts within 15 days. In case of failure to join the post within 15 days, their appointment shall automatically star id expired and no subsequent appeal etc. shall be entertained. 5.
- They are not allowed to take over charge if their age is less than 18 years and more than 43 years (including 03 6.
- Principal/Head Master/SDEOs concerned shall report / verify the arrival and charge taking of the newly years' automatic relation). appointed Class-IV with in the stipulated period of 15 days. 7.
- Health and Age Certifficate should be produced from Medical Superintendent before taking over charge.

- 10. Their services shall be terminated at any time in case their performance is found unsatisfactory during their service period. In case of misconduct they shall be proceeded against under the relevant rules issued from time
