Comments on behalf of Respondents No.1, 2 & 3.

Preliminary objections.

- That the appellant has got no cause of action locos standi to file the instant appeal.
- That the appellant has not come to this honorable tribunal with clean hands.
- That appellant concealed material facts from this honorable tribunal.
- That the appellant is estopped by her own to bring the present appeal
- That the appellant is bad due to mis-joinder and non-joinder of necessary parties
- That the appeal is barred by law and limitation.

Respectfully Sheweth; That the respondent submit as under;

#### ON FACTS.

- 01. Incorrect denied. All of the teachers of the affected area schools were redeployed to other nearby schools under the proposal of assistant district education officer, and they carried out their duties. Meanwhile, the appellant was reported by the concerned officer that she has been absent and no attendance records was available in concerned school GGPS Turkistan BZK landi kotal and GGPS zulafiqar kalli Landi kotal district Khyber.
- 02. Incorrect, hence denied The DEO Khyber had come to know through the ADEO by checking the master pay roll that the appellant Mrs.Samia Begum D/O Muhammad rafique Ex-T.T P.No.50162005 was drawing pay as primary school teacher from district account office Khyber, then her pay was stopped and her name and personal number also reflected in two leading newspaper "Daily Mashriq"& Daily Express dated 27/05/2017. Copies are attached as Annexure-A &B. It reveals that the concerned so called teacher was directly inducted into the system, copy attached as Annexure-C & D.

- 03. Incorrect. Hence denied. All the ghosts' employees were informed through newspapers to reach the DEO (AEO) themselves for physical verification however, the appellant neither approach to office nor verified herself till today and as a result the appellant salary was stopped.
- 04. Incorrect denied. Despite being inducted herself fraudulently and illegally, received salary through dubious means, and never performed her duties, the appellant has the right to appeal; nevertheless, she didn't t file a departmental appeal or confirmed her service record. Rather, she caused a great loss to the government exchequer.
- 05. Incorrect, hence denied. Proper opportunity was given but she failed to prove herself legally and rightly.

### Grounds.

- A. Incorrect. H ence denied. The respondent department has treated the appellant in accordance with laws and rules. The appellant was being fraudulently inducted into the Education Department.
- B. Incorrect hence denied. As elucidated in para 2 above facts.
- C. Incorrect hence denied. The appellant was informed through various means that is daily newspaper Mashriq and Express. Thereafter, having no contact with concerned department so her salary was stopped in 2017. She did not bother to clarify her stance regarding the actions taken by competent authority directly or through the counsel. It is very much clear that her induction was made by unfair means. It is obvious from her belated appeal that her case already time barred and hence not entertainable.
- D. Subject to record. As already elucidated in para 1 above facts.
- E. Incorrect hence denied. As elucidated above that the appellant could not prove herself innocent because She was fraudulently induced in SPA system and thus she was guilty of misconduct and violation of rules.
- F. Incorrect. Hence denied. The appellant neither filed the department appeal nor performed her duty.
- G. Incorrect hence denied. As elucidated in para 1 above facts.

In light of the above stated facts it is submitted, that the case of the appellant may be ordered as dismissed with cost.






