JUDGMENTSUBHAN SHER, CHAIRMAN:-

Facts making the background of this appeal, as gathered from the record are that appellant Muhammad Sadiq was initially appointed as PST Teacher on 25.08.1977 and served for more than 39 years in the department without any complaint made against him during that long period. That in the year 2013, seniority list of SPSTs was issued by the respondents, wherein the appellant was placed at S.No. 108 in the list. Later on, 808 numbers of SPSTs were promoted,

however, the appellant was ignored. So he preferred appeal No. 1127/2014 before this Tribunal and during its pendency, he was promoted by the respondents but with immediate effect vide notification dated 20.01.2016, so he withdrew the appeal with permission to file fresh after exhausting departmental remedy. Hence he filed departmental appeal before the appellate authority against the impugned notification which was not replied, thus the appellant instituted the appeal in hand before this Tribunal.

2. Mr. Muhammad Amin Ayub, Advocate, counsel for the appellant contended that at the time of promotion, the appellant was threatened by the respondents that he will be transferred to far flung area, if he is given promotion. So under compulsion, he opted to forgo his chance of promotion. He further contended that the appellant astonished when a complete disable person and that too, junior to him and posted in his school was promoted but he was not transferred. So sensing the malafide of the respondents, the appellant started hue and cry and lodged complaint with the high-ups. That he had opted to forgo his promotion but due to above mentioned threats by the respondents. He further contended that when he filed appeal before this Tribunal, the respondents realizing their illegal and unlawful acts, promoted the appellant but with immediate effect. At the end, he requested that the appellant be given promotion w.e.f. 13.2.2013.

3. Mr. Ziaullah, Deputy District Attorney strongly opposed the contentions of the learned counsel for the appellant and argued that once the appellant opted to forgo his promotion, then he was not entitled to promotion

and so the respondents have committed no illegality while passing the promotion of the appellant w.e.f. 20.1.2016. He supported the order of the respondents and requested the Tribunal to dismiss the appeal of the appellant.

4. Parties were heard at length. From the discussion plus contentions of the parties, one thing is admitted and even quite natural as well that no employee will forgo his promotion if he have no compulsions. No doubt, at present there is no evidence to show that the respondents had threatened him to post him out to a far flung area on his promotion but from the ancillary circumstances of the case plus conduct of the appellant and respondents, it would appear that the appellant's stance has some force and it would certainly worth consideration as is evident from the discussion made below.

5. The appellant candidly admitted that he forgone his promotion as he was threatened to be transferred to a far flung area if he was promoted. But when a junior and disable teacher posted in his school was promoted but not transferred out, then the appellant agitated the matter before the high-ups but with no positive response and ultimately the matter reached to this Tribunal in first round which has been discussed in detail in the preceding paragraphs of this judgment. Similarly, the respondents took the plea of forgoing promotion by the appellant by not promoting him from the date of previous notification i.e when 808 teachers were promoted, but during pendency of the previous appeal, all of sudden, on 20.1.2016, promotion notification of the appellant was issued but with immediate effect and in this way they (respondents) violated the provisions of Section 7 of the Khyber Pakhtunkhwa Civil Servants Act, 1973

debaring an employee from promotion in the coming four years if he opted to forgo the first chance of promotion. In short, as already touched to some extent, respondents attempted to cover their past unfair practice and shut the mouth of the appellant by giving him promotion with immediate effect in clear violation of the aforementioned section of law. .


6. As discussed above, the appellant has not been given ample opportunity of hearing particularly in support of his claim that he was threatened by the respondents and secondly, on 09.06.2014, he requested the DEO Mardan in his application/departmental appeal to conduct an enquiry regarding his grievances but no order on this application/appeal has been passed so far. As already touched to some extent the claim of appellant apparently looks genuine but in absence of evidence in its support, he cannot be given relief as prayed for. In short, this Tribunal deems it appropriate to give chance of hearing to both parties so that fair and proper justice is done.

7. The crux of the foregoing discussion is that the respondents are directed to hold an enquiry (if deemed it necessary) on the application/appeal of appellant dated 09.06.2014 addressed to the DEO Mardan and then pass a speaking order after providing full opportunity of hearing to the appellant. It is further directed that the above mentioned query/enquiry (if necessary) be completed within a period of four months from the date of receipt of this judgment. Needless to mention here that if the appellant was not satisfied from the action taken by the respondents on his above mentioned application/appeal, then he will be at liberty to approach this Tribunal afresh after comply with all

the legal and procedural formalities. With these observations the appeal in hand, stands disposed off accordingly. In the circumstances of the case, parties are left to bear their own costs. File be consigned to the record room.



SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT-1974 AGAINST THE IMPUGNED NOTIFICATION DATED 20.01.2016 COMMUNICATED ON 24.02.2016 WHEREBY THE APPELLANT WAS ALTHOUGH PROMOTED TO THE POST OF PRIMARY SCHOOL HEAD TEACHER (BPS-15) BUT WITH IMMEDIATE EFFECT INSTEAD OF 13.02.2013 AGAINST WHICH THE APPELLANT PREFERRED DEPARTMENTAL REPRESENTATION ON 21.03.2016 BUT THE SAME WAS NOT DISPOSED OF WITHIN THE STATUTORY PERIOD OF 90 DAYS.

PRAYER:

On acceptance of the instant appeal, the impugned Notification dated 20.01.2016 may graciously be modified by promoting the appellant to the post of Primary School Head Teacher (BPS-15) w.e.f. 13.02.2013 with all consequential back benefits.

Respectfully Sheweth,

Facts giving rise to the present appeal are as under:-

1. That appellant joined the Education Department as PTC Teacher on 25.08.1977

and served as such till date for a period of more than 39 years and at the moment

is serving as Primary School Head Teacher (BPS-15) posted at GPS Ganjey Tehsil Takht Bhai, District Mardan.

2. **That** as per the Seniority List (*Annex:-A*) appellant was at Serial No.108 and was therefore, entitled for promotion to the post of PSHT (BPS-15) under the Policy of the Government but due to malafide reasons, the higher authorities threatened the appellant to forgo the promotion as the appellant on promotion will be transferred to a far-flung area. Thus the appellant was ignored in the promotion.
3. **That** subsequently when the promotion Notification dated 13.02.2013 (*Annex:-B*) was issued, appellant was shocked to know that instead of the appellant Mr. Nisar Ahmad a junior to the appellant who was serving in the same school where appellant was posted and who was completely disabled was promoted to the post of PSHT (BPS-15) and posted in the same school while the appellant was unlawfully deprived of his lawful right.
4. **That** appellant thereafter challenged the Notification ibid before the departmental appellate authority in the first instance and thereafter filed Service Appeal No.1127/2014 before this Hon'ble Tribunal but in the meanwhile vide impugned Notification dated 20.01.2016 (*Annex:-C*) communicated on 24.02.2016 appellant was promoted to the post of PSHT (BPS-15) but with immediate effect instead of the due date.
5. **That** the service appeal pending before the Hon'ble Service Tribunal was then withdrawn vide order dated 21.03.2016 (*Annex:-D*) with permission to file fresh one and accordingly the impugned Notification was challenged through departmental representation (*Annex:-E*) before the appellate authority on 21.03.2016 but the same was not disposed of within the statutory period of 90 days. Hence this service appeal inter-alia on the following grounds:-

Grounds:

- A. **That** Respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973 and unlawfully issued the impugned Notification which is unjust, unfair and hence not sustainable in the eye of law.
- B. **That** earlier the appellant was discriminated as juniors to him were promoted to the post of PSHT (BPS-15) while appellant being senior and entitled for the

requisite promotion under the policy was ignored which is against the principle of equality as per Article-25 of Constitution of the Islamic Republic of Pakistan, 1973 read with Rules-7(3) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.

- C. **That** the act of the higher authorities is highly condemnable and illegal as appellant was deprived of his promotion by putting him under the threat of transfer to a far-flung area but after the earlier promotion order, Mr. Nisar Ahmad: a junior and a completely disabled person was posted on his promotion to the same school where he was earlier posted i.e. GPS Ganjey, which has resulted in serious miscarriage of justice.
- D. **That** it was reported (*Annex:-E*) on 17.09.2013 by the Assistant Sub-Divisional Education Officer that the said Nisar Ahmad was weak and unable to keep the administration and therefore requested for his replacement. Similar Report (*Annex:-F*) was also earlier submitted on 21.04.2014 but inspite of the same he was posted as Primary School Head Teacher in the School. Appellant also submitted an application (*Annex:-G*) to Respondent No.1 for conducting Departmental Enquiry but no such enquiry was held.
- E. **That** subsequently the Department realized its mistake and accordingly process the promotion case of the appellant and was as such promoted vide impugned Notification but with immediate effect whereas appellant was entitled for promotion w.e.f. the due date 13.02.2013 in violation of the law ignoring the entitlement of the appellant.
- F. **That** it was not the fault of the appellant that previously he was ignored in the promotion but rather it was an error on part of the Department who without any just cause deprived the appellant from the subject promotion. It follows that the appellant cannot be made to suffer for the faults on the part of the Department.
- G. **That** appellant would like to offer some other grounds during the course of arguments.

It is, therefore, humbly prayed that the instant appeal may graciously be accepted as prayed for above.

Any other relief as deemed appropriate in the circumstances of case not specifically asked for, may also be granted to appellant.



PRELIMINARY OBJECTIONS:

1. That the appellant has got no cause of action as well as locus standi to file the instant appeal.
2. That the instant appeal is incompetent in its present form, hence liable to be dismissed.
3. That the instant appeal is badly time barred.
4. That the appeal is not maintainable in its present form.
5. That the appellant has not come to this Honourable Tribunal with clean hands.
6. That the appellant is estopped by his own conduct.
7. That the appellant has concealed the material facts from this Honourable Tribunal hence liable to be dismissed.
8. That the instant appeal is liable to be dismissed for non-joinder / mis-joinder of unnecessary parties.
9. That the instant appeal is based on malafide intention, hence liable to be dismissed.
10. That the instant appeal is against the prevailing law and rules.
11. That the appellant failed to submit file for upgradation in time and later on verbally refused the up-gradation to the post of PHST BPS-15.
12. That the respondents in the next DPC on the recommendation of Departmental Promotion Committee the answering Respondent promoted the appellant to the post of PSHT vide Order No 421-G dated 20-01-2016 accordingly. (Copy of Promotion Order is attached as Annex-A)
13. That the respondents being the responsible government officers acted in accordance with the law, followed the rules & regulation for selection and promotions of the appellant and others PSHTs.

FACT:


1. Para No 1 pertains to record, hence need no comments.

- 2. Para No 2 pertains to record, however incorrect to the extent that the appellant on promotion to be transferred to far flung area, now on the promotion of the appellant he has been promoted to the same school which shows fair attitude of the respondent towards the appellant, hence denied.
- 3. Para No 3 pertains to record, as thoroughly explained supra in the preliminary objection, hence need no comments.
- 4. 

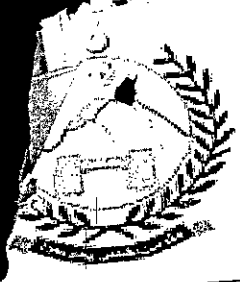



Preliminary Objections:

Preliminary objections raised by answering respondents are erroneous and frivolous, the detailed replies thereof are as under:-

1. That appellant has got cause of action as well as locus standi to file the instant appeal.
2. That the instant appeal is competent in its present form and shape hence liable to be accepted.
3. That the instant appeal has been filed well within time.
4. That the appeal is very much maintainable in its present form.
5. That the appellant has come to this Hon'ble Tribunal with clean hands.

6. That the case of appellant does not hit by the principle of estoppel and has rightly filed the present appeal.
7. That all the facts relevant for the disposal of the instant appeal concisely have been incorporated in the appeal and nothing has been concealed from the Hon'ble Tribunal.
8. That all necessary and proper parties have been arrayed as Respondents in the instant appeal, hence the question of mis-joinder and non-joinder is misconceived.
9. That the instant appeal has been filed with fair intention and hence liable to be accepted.
10. That the instant appeal has been filed in accordance with the prevailing law and rules
11. That the appellant submitted the file for upgradation well within time before the competent authority and refusal of the upgradation on behalf of the competent authorities is unjust and not according to law.
12. That the Respondents issued the said Notification of promotion during pendency of Service Appeal No.1127/2014 before the Hon'ble Tribunal and this Notification was issued with immediate effect instead of due date so it also does not cover the purpose of the appellant.
13. That the Respondents have clearly violated the law on the subject and the appellant has been denied of his right. All codal formalities as per the Khyber Pakhtunkhwa Service Tribunal Act, 1974 have been complied with and therefore the appeal is

in its correct form and shape.

Facts:

1. Para-1 of the appeal has been admitted by the Respondents.
2. Incorrect. The Respondents have clearly threatened the appellant to be transferred to the far-flung area in case of promotion and thus the appellant was ignored in his promotion.
3. Para-3 of the appeal has been admitted by the Respondents, therefore, they did not put any comments in their favour.
4. Incorrect. The Respondents have clearly violated the law on the subject and the appellant has been deprived of his right and the said Notification was issued with immediate effect instead of due date.
5. Para-5 of the appeal has been admitted as correct by the Respondents, therefore, they did not forward any comments in their favour.

Grounds:

- A. Incorrect. The appellant has not been dealt in accordance with law and Rules on the subject.
- B. Incorrect. The ground-B of the appeal is totally based on fact and law and the appellant has timely done all the required necessary actions.
- C. Incorrect. Ground-C of the appeal is totally based on facts.
- D. Incorrect. One Nisar Ahmad was promoted and posted in the same School and no such enquiry was conducted by the

Department on the application of the appellant.

- E. Ground-E of the appeal has been admitted as correct by the Respondents upto very extent, therefore, they did not forward any comments in their support.
- F. Incorrect. The appellant was deprived of his right just due to the negligence and error of the Department.
- G. The appellant seeks permission to raise additional grounds at the time of arguments.

It is, therefore, humbly prayed that the reply of answering Respondents may graciously be rejected and the appeal as prayed for may graciously be accepted with costs.


