JUDGMENT

AHMAD SULTAN TAREEN, CHAIRMAN:- The appellant named above has invoked the jurisdiction of this Tribunal through above titled appeal with the prayer as copied below:-

"On acceptance of this service appeal the impugned orders dated 18.05.2020 and 13.07.2020 may very kindly be set aside

and the appellant may not be transferred from GUI Saidu Sharif, Swat till completion of his normal tenure. Any other remedy which your good self deems fit that may also be awarded in favour of the appellant."

2. The factual account of the appeal in nutshell is that the appellant was inducted in the respondent department as Theology Teacher vide order dated 25.11.2006. During his service, he served at far-flung areas of District Swat and then promoted to the post of Senior Theology Teacher (BPS-16) vide notification dated 27.04.2016 and was posted in GHS Kanju District Swat. He was transferred from GHS Kanju and posted at Government Darul Uloom Islama (GDUI) Saidu Sharif, Swat vide order dated 19.03.2020 and in pursuance thereof, he submitted his charge report and started performing his duty efficiently. After lapse of two months, respondent No. 3 withdrew the order dated 19.03.2020 through the impugned order dated 18.05.2020 without any clear clarification. Feeling aggrieved from the impugned order, the appellant preferred departmental appeal before respondent No. 2 followed by Writ Petition No. 633-M/2020 before the Peshawar High Court, Dar-ul-Qaza Swat which was withdrawn later on with the request to approach the proper forum vide order dated 15.06.2020. The appellant also stated that during pendency of the departmental appeal, the respondent No. 3 issued the impugned order dated 13.07.2020 regarding posting of private respondent No. 4 in place of appellant at GDUI Saidu Sharif, Swat on the direction of Local MPA Fazle Hakeem Khan. The appellant being further aggrieved from the subsequent impugned order,

preferred departmental appeal before respondent No. 2 but having no response, preferred the present service appeal with several grounds including that the respondent department acted in arbitrary and malafide manner by issuing the impugned order dated 18.05.2020 and 13.07.2020; that the respondent No. 3 issued the impugned order on direction of local MPA to accommodate their blue eyed person i.e. respondent No. 4 namely Rahmât Ullah, TT; and that the impugned orders have not been issued in the public interest or in exigencies of public service.

3. On admission of appeal for regular hearing, notice was given to the respondents. The official respondents as well as private respondent turned up. The official respondents No. 1 to 3 submitted their parawise comments and the respondent No. 4 despite afforded with opportunity did not submit the comments but he relied upon the comments of respondents No. 1 to 3 during the course of arguments.


4. We have heard the arguments and perused the record.

5. The defence set up by the respondents in their written comments is that the appellant was transferred vide order dated 17.12.2013 to GHS Kanju Swat from GHS Gwalarai, Swat. He was promoted as Senior Theology Teacher (BPS-16) on seniority-cum-fitness basis. It was also admitted that the appellant was adjusted at GDUI vide order dated 19.03.2020 which was withdrawn vide order dated 18.05.2020. It was added that transfer/adjustment order of any civil servant by the competent authority is neither a penalty nor illegal. The competent authority can issue or withdraw any order in public interest. In fact,

the appellant belongs to village Barthana Tehsil Matta, District Swat. His old station i.e. GHS Kanju is comparatively nearer to his home address. Therefore, the impugned withdrawal order is not against his interest and also not against public interest. The respondents also stated in their reply given vide para-6 that the appellant was initially adjusted at GDUI Saidu Sharif vide order dated 19.03.2020 as STT BPS-16 but actually there was no vacant post at GDUI. Saddar/Head of GDUI submitted staff statement/details, wherein it was revealed that there was only one TT BPS-15 post was vacant. Therefore, adjustment order of the appellant was withdrawn and respondent No. 4 was adjusted at GDUI Saidu Sharif. It was also stated by the respondents that after adjustment of appellant at GDUI Saidu Sharif, the Saddar/Head and teachers of GDUI Saidu Sharif Swat approached the office of the Hon'ble MPA of PK-5/DDAC Chairman. The DDAC Chairman Swat furnished minutes of the meeting and recommended that respondent No. 4 may be adjusted at GDUI against the vacant post of TT BPS-15 with the consent of the Ulemas, students of the GDUI and in the best interest of GDUI Saidu Sharif Swat.

6. The crux of the claim of appellant is that his transfer through impugned order was politically motivated. However, the minutes of meeting regarding posting of TT at GDUI against the vacant post as annexed with the reply of respondents reveals that the meeting was chaired by MPA/PK-05/Chairman DDAC, District Swat and was attended by many others. According to the proceedings reflected in the minutes of meeting dated 30.06.2020, the posting of respondent No. 4 at GDUI Saidu Sharif is a matter of consensus and not

motivated by any political reason as purported by the appellant. Therefore, we find no force in the appeal of the appellant. However, it would be in fitness of things to direct with convenience of the appellant should also be considered by the respondents while posting him for duty and as such, they are directed to post the appellant within radius of 10 kms from his native town. The impugned order is maintained. The appeal stands disposed of accordingly. Parties are left to bear their own costs. File be consigned to the record room.

The respondent No. 4 namely Rahmatullah has submitted an application for transfer of appeal to Camp Court Swat. The reason noted in the application is to the effect that the appellant as well as respondents No. 3 & 4 are stationed at Swat and pursuing the case at Peshawar is highly inconvenient for the applicant.

The representative of respondents No. 1 to 3 supported the request of respondent No. 4.

Learned counsel for the appellant, while opposing the application, stated that the departmental appellate authority is stationed at Peshawar while the respondents No. 1 & 2 have meaningful role to be played in the case. For the said reasons the request of respondent No. 4 may be turned down.

I tend to agree with the submissions by respondent No. 4/applicant. At the cost of repetition it is noted that not only the appellant but respondents No. 3 & 4 hail from Swat. It is for the convenience of parties that Benches of this Tribunal are constituted to work at camp courts on three different stations. The application is, therefore, allowed and appeal in hand is transferred to Camp Court Swat for proceedings on 02.03.2021. Till next date of hearing, the operation of impugned order shall remain suspended.



- 3- That due to satisfactory service of the appellant the respondent Department promoted the appellant to the post Senior Theology Teacher (BPS-16) vide Notification dated 27.04.2016 and posted in GHS Kanju, District Swat. Copy of the promotion Notification is attached as annexure.....**D.**
- 4- That later on the appellant was transferred from GHS Kanju, Swat and posted at Govt: Darul Uloom Saidu Sharif, Swat vide office order dated 19.03.2020. That in pursuance of the order dated 19.03.2020 the appellant submitted his charge report and started performing his duty efficiently. Copies of the order, relieving chit & charge report are attached as annexure.....**E & F.**
- 5- That astonishingly just after the lapse of two months the respondent No.3 withdraw the transfer order dated 19.03.2020 through impugned order dated 18.05.2020 without any clear justification. Copy of the order dated 18.05.2020 is attached as annexure.....**G.**
- 6- That feeling aggrieved from the impugned order dated 18.05.2020 the appellant preferred Departmental appeal before the respondent No.2 followed by writ petition No.633-M/2020 before the Peshawar High Court Bench, Darul Qaza, Swat, which was withdrawn later on with the request to approach the proper forum vide order sheet dated 15.06.2020. Copies of the Departmental appeal & memo of writ petition alongwith order sheet are attached as annexure.....**H & I.**
- 7- That the appellate authority was duty bound to decide/dispose of pending Departmental appeal of the appellant in light of Clause-XIV of the transfer/posting policy promulgated by the Government of Khyber Pakhtunkhwa but during the pendency of the Departmental appeal of appellant the Respondent No.3 issued the impugned order dated 13.07.2020 regarding posting of the private respondent No.4 in place of appellant i.e. GDUI, Saidu Sharif, Swat on the directions of local MPA Mr. Fazal Hakeem Khan. Copies of the minutes of meeting and impugned order dated 13.07.2020 is attached as annexure.....**J & K.**
- 8- That appellant further aggrieved from the subsequent impugned order dated 13.07.2020 preferred Departmental appeal before the respondent No.2 but no response has been given to the appellant so far. GROUND:

- A-** That the impugned orders dated 18.05.2020 and 13.07.2020 are against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- B-** That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- C-** That the impugned orders dated 18.05.2020 and 13.07.2020 are against clauses I, II & IV of the transfer/posting policy of the provincial Government of Khyber Pakhtunkhwa. Copy of the transfer/posting policy is attached as annexure.....**M.**
- D-** That it is pertinent to mention that the private respondent is presently serving as TT in (BPS-15) while the post is of BPS-16 i.e. STT but inspite of that the respondent No.3 posted the private respondent against the post in question.
- E-** That the treatment meted out to the appellant is a clear violation of the Fundamental Rights of the appellant.
- F-** That the respondents acted in arbitrary and malafide manner by issuing the impugned orders dated 18.05.2020 and 13.07.2020.
- G-** That the respondent No.3 has been issued the impugned orders dated 18.05.2020 and 13.07.2020 on the directions of local MPA Mr. Fazal Hakeem Khan just to accommodate their blue eyed person i.e. private respondent No.4 (Mr. Rahmat Ullah, TT).
- H-** That neither the impugned orders dated 18.05.2020 and 13.07.2020 have been issued in the public interest nor have the same been issued in exigencies of public service.
- I-** That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of appellant may very kindly be decided in favor of the appellant as prayed far.

POSTING / TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT.

- i) All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- iv) The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
- v) While making postings/transfer from settled areas to FATA and vice-versa, specific approval of Governor, NWFP needs to be obtained
- vi) While making postings/transfers of officers/officials up to BS-17, from settled areas to FATA and vice-versa approval of the Chief Secretary NWFP needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor NWFP shall be obtained.
- vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for atleast eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.
- vii) Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and DPOs/Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thaana) of his area/residence is situated.
- viii) No posting/transfers of the officer's/officials on detailment basis shall be made.
- ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.
- x) All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.

Para-1(v) regarding months of March and July for posting/transfer and authorities for relaxation of ban deleted vide letter No. SOR-VI (E&AD) 1-4/2008/Vol-VI, dated 3-6-2008.

Consequently authorities competent under the NWFP Government Rules of Business, 1985, District Government Rules of Business 2001, Posting/Transfer Policy and other rules for the time being in force, allowed to make posting/transfer subject to observance of the policy and rules.

- xi) Officers/officials except DCOs and DPOs/SPs who are due to retire within one year may be posted on their option on posts in the Districts of their domicile and be allowed to serve there till the retirement.

¹ DCOs and DPOs who are due to retire in the near future may also be posted in the District of their domicile subject to the condition that such posting would be against non-administrative posts of equivalent scales;

- xii) In terms of Rule-17(1) and (2) read with Schedule-III of the NWFP Government Rules of Business 1985, transfer of officers shown in column 1 of the following table shall be made by the authorities shown against each officer in column 2 thereof:

1.	Officers of the all Pakistan Unified Group i.e. DMG, PSP including Provincial Police Officers in BPS-18 and above.	Chief Secretary in consultation with Establishment Department and Department concerned with the approval of the Chief Minister.

- xiii) While considering posting/transfer proposals all the concerned authorities shall keep in mind the following:

- a) To ensure the posting of proper persons on proper posts, the Performance Evaluation Report/annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned officers/officials be considered.
- b) Tenure on present post shall also be taken into consideration and the posting/transfers shall be in the best public interest.

xiv) Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.

- i) Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.
- ii) Serious and grave personal (humanitarian) grounds.

2. To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule – IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under:-

S. No.	Officers	Authority
1.	Posting of District Coordination Officer and Executive District Officer in a District.	Provincial Government.
2.	Posting of District Police Officer.	Provincial Government
3.	Other Officers in BPS-17 and above posted in the District.	Provincial Government
4.	Official in BPS-16 and below	Executive District Officer in consultation with District Coordination Officer.

3. As per Rule 25(2) of the Rules mentioned above the District Coordination Department shall consult the Government if it is proposed to:

- a) Transfer the holder of a tenure post before the completion of his tenure or extend the period of his tenure.
- b) Require an officer to hold charge of more than one post for a period exceeding two months.

4. I am further directed to request that the above noted policy may be strictly observed /implemented.

All concerned are requested to ensure that tenures of the concerned officers/officials are invariably mentioned in summaries submitted to the Competent Authorities for Posting/Transfer.

It has been decided by the Provincial Government that posting/transfer orders of all the officers up to BS-19 except Heads of Attached Departments irrespective of grades will be notified by the concerned Administrative Departments with prior approval of the Competent Authority obtained on the Summary. The Notifications/orders should be issued as per specimen given below for guidance.

All posting/transfer orders of BS-20 and above and Heads of Attached Departments (HAD) shall be issued by the Establishment Department and the Administrative Departments shall send approved Summaries to E&A Department for issuance of Notifications.

Parawise Comments on Behalf of the Respondent 1 to 3:

Respectfully Shewith

Preliminary objections

1. That the Appellant is not an aggrieved person within the meaning of Section 4 of the service Tribunal Act, 1974.
2. That the Appellant has no cause of action / locus standi.
3. That the Appellant has not come to this Honorable Court with clean hands.
4. That the Appellant has filed this instant service appeal just to pressurize the respondents.
5. The present service appeal is liable to be dismissed for non-joinder/miss joinder of necessary parties.
6. That the instant service appeal is against the prevailing law and rules.
7. That the Appellant has filed this instant Service Appeal on malafide motives.
8. That the instant appeal is badly time barred.
9. That the instant service appeal is not maintainable in the present form, and above in the present circumstances of the issue.
10. That the Appellant has estopped by his own conduct.
11. That the Appellant has concealed the material facts from this Honorable Tribunal.

FACTS:

1. That the Para No.1 is correct to the extent of appointment order of the Appellant. The rest of the para is incorrect and denied. The Appellant remained absent from his duty time and again and has been reported by the school head many times. His absent period I,e 27-03-2012 to 14-05-2013 was converted into leave without pay. He was also warned to be careful in future and not to repeat this practice again and was also transferred vide order dated 17-12-2013 to GHS Kanju Swat from GHS Gwalarai Swat. **(Order annexed as Annexure A)**
2. That the Para No.2 is irrelevant, hence no comments.
3. That the Para No.3 is correct to the extent of promotion of the Appellant to the post of Senior Theology Teacher BPS-16, however, promotion orders are issued on Seniority-cum-Fitness basis.
4. That the Para No. 4 is correct to the extent of adjustment order dated 19-03-2020 of the Appellant at GDUI at Saidu Sharif, the rest of the para is irrelevant, hence no comments.
5. That the para No. 5 is correct to the extent of withdrawn order dated 18-05-2020, the rest of the para is incorrect and denied. Transfer/adjustment order of any civil servant by the competent authority is neither a penalty nor illegal. The competent authority can issue and withdraw any order in public interest. In fact, the Appellant belongs to village Barthana Tehsil Matta, District Swat. His old station I,e GHS Kanju Swat is comparatively nearer to his home address. Therefore, the withdrawn order is not against his interest and also not against public interest.
6. That the para No. 6 is correct to the extent of departmental appeal and filing of writ petition. However, it is worth to mention here that the Appellant was initially adjusted at GHS Kanju Swat after his promotion to STT BPS-16 post as per provision of vacancy of the Principal concerned. His salary has been drawn w.e.f 27-04-2016 to 31-05-2020 at GHS Kanju Swat. The Appellant was adjusted at GDUI Saidu Sahrif Swat vide order dated 19-03-2020 as STT BPS-16. But, in fact, there was no vacant post of STT BPS-16 at GDUI Saidu Sharif Swat. The

Sadar of GDUI Saidu Sharif Swat submitted staff statement/details wherein it was revealed that there was only one TT BPS-15 post was vacant. Therefore, the adjustment order of the Appellant was withdrawn vide order dated 18-05-2020. And respondent no. 4 has been adjusted at GDUI Saidu Sharif Swat. It is also worth to mention here that after adjustment of the Appellant at GDUI Saidu Sahrif, the Sadar/Head and teachers of GDUI Saidu Sharif Swat approached the office of the Honorable MPA PK-5/DDAC Chairman. The DDAC Chairman Swat furnished minutes of the meeting and recommended that respondent No. 4 may be adjusted at GDUI Saidu Sharif Swat against the vacant post of TT BPS-15 with the consent of the Ulemas, students of the GDUI and in the best interest of GDUI Saidu Sharif Swat and students. Respondent No.4 is working as TT BPS-15. Therefore, respondent No.4 being agreed upon and proper TT BPS-15 teacher was adjusted at GDUI Saidu Sharif Swat. **(copies of Sadar Statement, Meeting Minutes, Student Statement annexed as Annexure B, C & D)**

- 7. That detail reply of this para has already been given in para No. 6 above.
- 8. That the para No. 8 is correct to the extent of filing departmental appeal of the Appellant. The rest of the para is incorrect and denied. The Appellant is not an aggrieved person within the meaning of Section 4 of the Service Tribunal Act, 1974.

Thus the instant service appeal of the Appellant is bereft of any merit, hence, liable to be dismissed inter alia following grounds.

GROUNDS


- A. That the Para No. A is incorrect and denied. The orders dated 18-05-2020 and 13-07-2020 are not against the law, facts and norms of natural justice.
- B. That the Para No. B is incorrect and denied. The Appellant has been treated in accordance with law and rules and the respondents cannot even think of violation of any article of the constitution of Islamic Republic of Pakistan.

- C. That the Para No. C is incorrect and denied. The impugned orders dated 18-05-2020 and 13-07-2020 are not against the transfer/posting policy of the provincial Government of Khyber Pakhtunkhwa.
- D. That detail reply of this para has already been given in para No. 6 of the facts above.
- E. That the Para No. E is incorrect and denied. No fundamental rights have been violated by the respondent department. Being a civil servant, the Appellant is bound to perform his duty at any station where the competent authority appoints him.
- F. That the Para No. F is repetition of the above paras, hence no comments.
- G. That detail reply of this para has already been given in the foregoing paras.
- H. That the Para No. H is incorrect and denied. The orders dated 18-05-2020 and 13-07-2020 were issued in the public interest.
- I. That the respondents also seek permission of this Honorable Tribunal to advance further grounds at the time of arguments.

It is, therefore, very humbly prayed that the instant service appeal of the Appellant may be dismissed with cost in favor of the respondents.

Respectfully shewith

Preliminary objections

1. That the instant COC of the Appellant is liable to be dismissed on the grounds of misjoinder and non joinder of the necessary parties.
2. That the instant COC is not maintainable in the present form, and above in the present circumstances of the issue as the respondents have not violated any order of the Honourable Tribunal.
3. That the instant COC has been filed just to pressurize the respondents.

FACTS

1. That the Para No.1 is correct.
2. That the Para No.2 is correct to the extent of the order sheet of the Honourable Tribunal, the rest of the Para is incorrect and misleading one. The Honourable Tribunal vide order dated 21.1.2021 granted interim relief in the following words, "Annexed with the memo of appeal is an application for interim relief. Notice of the said application be issued to the respondents. In the meanwhile, the operation of the impugned order shall remain suspended, if not acted upon earlier."

The impugned orders were issued on 18.5.2020 and 13.07.2020. The appellant was adjusted at GDUI Saidu sharif Swat vide order dated. 19.3.2020. Later on his adjustment order was withdrawn vide order dated 18.5.2020 with immediate effect. The appellant started his duty at GHS Kanju Swat w.e.f 14.9.2020 after the COVID-19 pandemic holidays, while the respondent No. 4 (Mr. Rahmatullah) was

adjusted at GDUI vide order dated 13.7.2020 and started his duty at GDUI Saidu sharif Swat w.e.f 13.7.2020 so it is very much clear that both the orders have already been acted upon/ implemented.


Moreover as far as salary of the appellant is concerned, the salary of the appellant has been stopped by the Principal of GHS Kanju Swat w.e.f 1.6.2020 very much earlier of the Honourable Tribunal order dated 21.1.2021. (Copies of attendance register, charge report, ^{and source} monthly statements attached as Annexure A, B, C, D)

3. That the Para No.3 is incorrect and not admitted. The respondents have not committed any contempt of any order of this Honourable Tribunal. The Honourable Tribunal orders dated 21.1.2021 has not been violated by the respondents. The Appellant as well as respondent No.4 have already complied the impugned orders of the department and have already started duties, before the Honourable Tribunal orders.

It is therefore , very humbly prayed that on acceptance of the above made submissions, the answering respondents have not committed any contempt of court and have not violated any order of this Honourable Tribunal and cannot even think of the same, therefore, the instant petition may very graciously be dismissed with cost.
