PARA-WISE COMMENTS ON BEHALF OF RESPONDENTS

Respectfully sheweth:-

- Preliminary objections:-
 - 1. That the service appeal of the appellant is badly time barred by law and limitation.
 - 2. That the service appeal is not maintainable in it's present form.
 - 3. That the appellant has not come to this honorable Tribunal with clean hands.
 - 4. That the appellant has concealed the material facts from this honorable Tribunal.
 - 5. That the appellant has been estopped due to his own conduct.
 - 6. That the Instant Service Appeal is bad due to miss-joinder and non-joinder of the necessary parties.
 - 7. That the appellant has got no cause of action and locus-stand to file the instant appeal.

FACTS

- 1. Para No. 01 relates to record. Hence need no comments.
- 2. Incorrect:- The service record of the appellant is tainted with several bad entries through out his career. (copy of the same are attached as Annexure "A")
- 3. Incorrect:- The appellant while posted at PS Jowar proceeded on 15 days approved casual leave w-e-f 11.05.2007 but he did not report his arrival after spending the approved casual leave. He was informed time and again at his home address as well as by publishing a notice in the daily news paper "Pakistan" dated 21.09.2007 and "Daily Express" dated 09.8.2007 through Director Information Peshawar, but no response was received therein. Therefore, the competent authority issued him, a charge sheet coupled with statements of allegations and departmental enquiry was initiated. The enquiry committee summoned the appellant time and again to defend himself but in vain. Hence the enquiry officer recommended him for major punishment/dismissal from service. The competent authority agreed with the recommendation of enquiry officer and awarded major punishment of dismissal from service to the appellant vide OB No.10 dated 29.01.2008 after fulfill all codal formalities. No violation of constitution has been committed by answering respondents. (Copies of the absence report DD No.10 dated 26.05.2007, news paper clipping, charge sheet coupled with statement of allegations, finding report with other enquiry papers are attached as Annexure "B", "C", "D","E" & "F" respectively).
- 4. That, the appellant filed departmental appeal before the Regional Police Officer, Malakand, Swat wherein he was called in orderly room on 08.08.2023 and heard him in person but he could not produced cogent reason in his defense. Therefore his appeal was rejected being time barred and meritless.
- 5. That the instant service appeal of the appellant is liable to be dismissed on the following grounds.

GROUNDS

- **A.** Incorrect: That the office order is legal, according to the law and issued by the lawful authority in accordance with law/rules.
- **B.** Incorrect: The office order is the result of material facts concluded on the part of appellant during the course of enquiry. The appellant was informed time and again to join the departmental proceedings but he willfully abstained to join the same.
- **C.** Incorrect, the appellant was issued notice/informed time and again to appear in his defense but to no avails.
- **D.** No violation of law/provision have been committed by the answering respondents. The appellant willfully absented himself after availing the approved causal leave. The act of appellant show that he was no more interested in performing his officials duties. Therefore he was proceeded departmentally by informing him through newspapers as well as his residential address but to no avail.
- **E.** Incorrect;- The appellant has not submitted application of Ex-Pakistan leave during that time and proceeded abroad without permission as he has admitted the same. Attached his travelling history (as attached annexure F).
- **F.** The appellant was summoned through different notices/newspaper clipping but he did not appear, so the competent authority issued him charge sheet and departmental enquiry was initiated. He had gone to abroad Malaysia as the same has already been admitted by himself in above para "E" of the grounds.
- G. Incorrect as explained above in various paras.
- **H.** Incorrect:- The appellant was rightly dealt according to the law.
- I. Incorrect as mentioned above the own mis-conduct of the appellant led him to the awarded punishment.
- J. Incorrect:- before issuing of office order, the appellant was informed time and again to appear before the enquiry committee as well as competent authority but he could not appeared, so he was awarded major punishment of dismissal from service.
- **K.** Correct to the extent that his departmental appeal was dismissed but it was badly time barred and also the appellant had not produced cogent reason in his defense.
- L. That other points/grounds will be presented at the time of arguments.

PRAYERS:-

In a view of the above detailed Para Wise comments/reply to the facts/grounds, it is most humbly prayed that the Instant Service Appeal of the appellant may graciously be dismissed with cost.


