Prayer in Appeal; To set-aside the order dated 17-02-2016 passed by respondent no.1 whereby departmental appeal of the appellant was dismissed which was filed against order dated 18.09.2015 passed by respondent no.2 and appellant be reinstated in service with all back benefits.

Respectfully Sheweth;

1. That the appellant was serving as Patwari in revenue department Nowshera and had rendered 13 years service as such in various Patwar Circles.

2. That appellant performed his duty to the entire satisfaction of his superior and never once any complaint has ever been filed against the appellant and has worked in the department with devotion, and to the best of his ability and honesty.

- 3. That one Zardin Khattak has filed baseless complaint against the appellant to Anti-Corruption establishment Nowshera alleging therein that in spite of receipt of Rs. One Lac from the appellant has delivered him fake documents of land bearing khasra no.1208 measuring 99 kanals and 2 marlas having no record. On the basis of this complaint FIR was also registered against the appellant.
- 4. That one another person namely, Shah Hawas Khan also filed complaint against the appellant alleging therein that the appellant has received Rs.16000\- and Rs.4000\- as bribe in the year 2009 on account of preparation of khasra girdawri of shamilat land bearing khsaras no.14, 44, and 326 of mouza Namal Sara Toya and 1350 of mouza Garu, but inspite of receipt of bribe prepared and delivered him fake documents of girdawari. An FIR was also registered in P.S Anti-Corruption, Nowshera against the appellant.
- 5. That on receipt of both the FIR respondent no.2 initiated enquiry proceeding against the appellant.
- 6. That the enquiry officer without adopting the procedure as required by the law conducted the enquiry without providing a chance of hearing or cross examining the witnesses and then submitted one sided report to respondent no.2.
- 7. That on receipt of enquiry report respondent no.2 issued Show Cause notice to the appellant which was replied accordingly but respondent no.2 without considering the reply dismissed the appellant from service through order dated 18.09.2015.
- 8. That the appellant preferred departmental appeal to respondent No. 1 which was rejected by the said respondent through order dated 17.02.2016 hence the present appeal inter alia on the following grounds;

Grounds

- A. That the respondents have not treated the Appellant in accordance with law and rules on the subject and acted in violation of article-4 and 25 of the constitution of Islamic republic of Pakistan, 1973 and unlawfully dismissed the appellant from service which is unjust, unfair hence not sustainable in the eye of law.
- B. That the order of removal of appellant from service by respondent no.2 is illegal, void-ab-initio, without lawful authority, against the facts and materials available

on record, law and rules on the subject and principles of natural justice, hence untenable.

- C. That the appellant has clearly termed the signatures available on all the documents so produced by the complainants being fake and forged and disowned the same, still said documents were not sent to laboratory for comparison with the signature of the appellant, hence the impugned order is not sustainable and liable to be set-aside.
- D. That the enquiry officer has conducted one sided proceeding and has not provided chance of cross examining the complainants or the witnesses.
- E. That the appellant has also moved application for comparison of his signature to commissioner but the same has not been decided by him
- F. That no proper and regular enquiry has been conducted in the matter and with a jerk of pen appellant has been removed from service for no good ground ignoring his 13 years of service to his credit thus respondents have violated mandatory law on the subject which resulted in the passing of harsh order of removal of appellant from service.
- G. That keeping in view the 13 years of service of the appellant and a large family members who are dependent upon the appellant, the punishment imposed does not commensurate with the charges leveled against the appellant.
- H. That the appellant has neither been served with charge sheet and statement of allegation nor proper and regular enquiry has been conducted as the whole edifice built there under is illegal and thus set-aside.
- I. That as for as attestation of mutation no.820 is concerned neither the buyer nor seller has complained against the appellant which is genuine mutation, but the enquiry officer has not considered this aspect of the case.
- J. That the appellant seeks leave of this honorable tribunal to argue additional grounds at the time of final hearing of this appeal.

It is therefore respectfully prayed that on acceptance of this appeal both the order dated 17-02-2016 18.09.2015 passed by respondent no.1&2 respectively may

- That FIR No:4 dated 23/2/2015 was lodged by Anti-corruption police Nowshera, with complaint of taking bribe of Rs.100,000/- from Mr. Zar Din Khattak s/o Islam u Din Khattak resident of Nizam Pur and prepared fake and false documents of land bearing Khasra No. 1208 measuring 99K-2M having no record.
- 2- That FIR No.5 dated 2/3/2015 was lodged by Anti-corruption police Nowshera with the complaint of taking bribe of Rs.16,000/- and 4,000/- from Mr. Shawas Khan s/o Abbas Khan and prepared fake and false documents of Girdawri of Shamilat land bearing Khasra No. 14,44,326 of mouza Namal Sara Toya and 1350 of mouza Garu having no record.

Whereas the inquiry officer, Mr. Tanveer Khan Khattak, Additional Assistant Commissioner-II Nowshera, has proved as guilty after consulting revenue record, false Fard, and copy of Girdawari issued by him, his statement, as well as statement of complainant. It has been proved that the Patwari misused official authority for his own interest by not taking signature/Thumb impression of seller, buyer and witness for mutation No.820 against Ripat No. 208 in Roznamcha Waqiati.

Whereas reply to show cause notice was found devoid of reason and sense. During personal hearing the accused patwari could not convince the undersigned being authority of this innocence.

Now therefore, I Zaka Ullah Khattak, being competent authority, keeping in view the above facts is pleased to agree with the inquiry report and therefore orders removal of services of the suspended patwari Muhammad Hassan (BPS-9) under section 4(1)(b) (iii) of Khyber Pakhtunkhwa, Government Servants (Efficiency and Discipline) Rules 2011, with immediate effect.

That zardin Khattak filed baseless complaint against appellant to Anti-corruption Establishment Nowshera alleging therein that in spite of receipt of Rs, one lac from the Appellant has delivered him (the complainant) fake and false documents of land bearing khasra No.1208 measuring 99 kanals and 2 marlas having no record. That one another person by the name of shah hawas khan also filed complaint against Appellant before anti corruption Establishment Nowshera alleging therein that the appellant has received Rs, 16000/- and 4000/- as bribe in the year 2009 on account of preparation of khasra girdawari of shamilat land bearing khasras No.14,44 of 326 of Mauza

Namal Sara toya and 1350 of Mauza Garu, but inspite of receipt of bribe, per averments of complainant , prepared and delivered him fake and false documents of girdawari. On this complaint too case FIR No.5 dated 02.03.2015 was registered in P-S Anti-corruption , Nowshera against the Appellant (copys of FIR is annexed herewith)

- 6. That on the receipt of copies of the above mentioned two FIRs Respondent / Authority initiated Departmental proceedings against Appellant ,through enquiry officer for the conduct of enquiries against him.
- 7. That without adopting the procedure as required for the conduct of enquiry against a government official and without waiting for the fate of cases registered against the Appellant in Anti Corruption police station Nowshera which are yet to be decided, enquiry reports based on no evidence submitted by enquiry officer to the Respondent/Authority recommending major penalty for him (the appellant). (Attested copies of enquiry report and other documents are attached herewith).
- That on the receipt of enquiry report the Respondent /Authority also did not consider this aspect of the matter and issued show cause notice to appellant, the reply whereof was submitted by him.

(Photo copies of show cause notice and reply are attached herewith).

9. That the Appellant on his own desire, was provided a chance of personal hearing, wherein he satisfied the Respondent/Authority that he is innocent in the whole episode having been involved in the cases with malafide

intention and that too after six years, still the Appellant was illegally removed from service vide order dated 18/09/2015.

(Attested copy of the order is enclosed herewith). 10. That aggrieved from the order date 18/09/2015 passed by the Respondent/Authority the Appellant is preferring the instant departmental appeal inter-alia on the following grounds amongst others:-

<u>GROUNDS</u>

- A. That the order of removal from service of the Appellant passed by the Respondent/Authority is illegal, void-ab-initio, whiteout lawful authority, against facts and materials available on record, Law and Rules on the subject and principles of natural justice, hence untenable
- B. That the appellant has clearly termed the signatures available on all the documents, so produced by complainants being fake and forged and disowned the same, still said documents were not sent to the laboratory/signature expert for comparison with the signature of Appellant, hence the impugned order is not sustainable and liable to be set-aside.
- C. That Appellant though has disowned the signature available on the fake and false documents so produced before Anticorruption police Nowshera in his reply to show cause notice and his statement, still he once again requests the Appellate authority that the signatures available on the said fake documents may be sent to the laboratory/ signature expert for comparison with his signatures. In this respect separate application is being filed. (Application is annexed).

- D. That when the complainant Zardin khatak realized the fact that he had charged an innocent person having no hand in the matter , so he filed an affidavit with the enquiry officer and also recorded his statement to the effect that he does not want to proceed with the proceedings further against Appellant. On this the proceedings against Appellant should have been stopped / filed but it is very astonishing that this affidavit and statement of complainant was based the recommendation and award of major penalty i-e removal from service of appellant, by enquiry officer which is totally against the norms of justice as such the impugned order, is liable to be set-aside.
- E. That the enquiry officer should have given an opportunity of cross examination to the Appellant on witnesses of complainant but he deprived him of this right, as such the order being void ab-initio and illegal is liable to be set-aside.
- F) That no proper and regular enquiry have been conducted in the matter and with a jerk of pen Respondent removed the appellant from 13 years of service for no good ground, thus respondent has violated mandatory law on the subject which resulted in the passing of harsh order of removal of appellant from service, as such the order impugned is liable to be setaside.
- G) That the Appellant has rendered 13 years service in the department and a large family members are dependent upon him, therefore such like harsh punishment should have not been awarded to him ,rather the matter should have been stayed till the disposal of cases registered against him or filed and in this way the respondent has erred in law to



award him harsh punishment as such the impugned order on this score too is liable to be set-aside

H) That the Appellant neither has been served with charge sheets and statements of allegation nor proper and regular enquiry has been conducted as such the impugned order being only based on improper and irregular enquiry is no order in the eye of law and also is not in accordance with the norms of justice, hence untenable.

I) That as for as attestation of mutation number 820 is concerned neither the buyer nor seller has complained against Appellant which is a genuine mutation, but the enquiry officer was done the job beyond his duty so assigned to him by the Respondent/ Authority, hence impugned order is liable to be set aside.

J) That statements of complainant and their witnesses were not recorded during enquiry proceedings per Rules and also Appellant was deprived of his right to cross examined him/ them.

K) That other gourds do exist in favor of the appellant which will be agitated at the time of arguments with the permission of your honor.

It is therefore, humbly prayed that this departmental appeal may very graciously be accepted, order dated 18/09/2015 regarding removal of service of appellant may kindly be set aside and appellant re instated in service with all back benefits.

ORDER

My this order will dispose of the departmental appeal filed by the above named appellant against the order dated 18.09.2015 whereby the appellant was removed from service u/s 4(1)(b)(iii) of the Khyber Pakhtunkhwa (Efficiency & Disciplinary) Rules-2011. Aggrieved of the same, the instant departmental appeal was filed before this court challenging the impugned order of the Deputy Commissioner Nowshera as illegal, unlawful and prayed for setting aside of the same and reinsttement.

Facts leading to filing of the instant departmental appeal are that 02 separate complaints were received to the Deputy Commissioner Nowshera through Anti-Corruption Estt: Nowshera by Mr. Zadin Khattak and Mr.Shawas Khan against the appellant in which FIRs were also registered against him for receing illegal gratification and issuing fake documents.

Complaint No.1.

Complaint was made by Mr. Zardin Khattak r/o Garu, Nizampur before the Anti Corruption Estt:Nowshera complaining that the appellant received Rs. 100,000/-and prepared a fake and false document/Fard of his land measuring 99 Kanals in Khsra No. 1208, hence the Anti-Corruption Estt: registered FIR against the appellant on 2.3.2015 and forwarded the case to the Deputy Commissioner Nowshera for further necessary action.

The Inquiry Officer, in his detailed enquiry report held that though the complaintant has deviated from his previous statement as in his complaint before the Anti-corruption deptt: the complainat has clearly mentioned the allegations while in his statement before the Inquiry Officer,he has deviated from his statement/complaint and produced an affidavit that he has made "razi nama" with the appellant. However, the Inquiry Officer compared the previous fard issued to the complainant with the "Zere-kar fard" and found visible difference as in both fardats. The complainant's name was shown in "Khana-Kasht" in column in the fard issued earlier. while in the instant fard, the complainant's name was not mentioned. Hence according to the Inquiry Officer, the appellant has committed fraud and thus recommended him for major penalty.



Complaint No.2

Complaint was made by Mr.¹ Shawas Khan before the Anti-Corruption Estt:Nowshera that the appellant received Rs. 16000/- and Rs. 4000/- as bribes in the year 2009 on account of documents of girdawari of shamilat land bearing Khasra No. 14,44,326 of mauza Namal Sara toya and in Khasra No. 1350 of mauza Garu which later-on proved false and fake having no record.An FIR was registered against the appellant on 06.2.2015

The Inquiry Officer reported that the complainant purchased 06 kanals land through mutation No. 820 at mauza Namal Sara Toya. The appellant received Rs. 16000/- for conducting girdawari in the name of the complainant in Khasra No. 14 & 44 and as per revenue record the said Khasra Nos are shamilat land and entered as "maqbooza Malikan" in khana kasht colomn of the register khasra girdawari. Similarly, Khasra No. 1350 is situated in moza Garu whereas Khasra 326 falls in maza Namal Sara Toya and are shamilat deh. Upto the year 2015 (Rabi) Girdawari was entered in the name of Gulab shah etc. The complainant submitted application for correction of girdawari on 31.12.2014 accordingly, girdawari was made in his name.Hence the Inquiry Officer has concluded that fard girdawari issued by the appellant was false and bogus as it neither mention crops of Rabi or Kharif, neither any cogent reasons of change of girdawari, hence stating that if change of girdawari in Khasra No. 326 had occurred during the period of posting of the appellant, there would have been no need of re-conduct of girdawari. He has further stated in his report that that girdawari in Khasra No. 1350 has been conducted in the name of the complaint back in the year 2013 which testifies that that the pert girdawari in mauza Garu issued by the appellant is fake. Thus the appellant was held guilty in issuing false and bogus fard of girdawari to the complainant and recommended him for major penalty.It is however, observed that proceedings in both the complaints are going on in the Anticorruption court.

Appellant as well as representative of the Deputy Commissioner Nowshera Mr. Abdul Jabar, Girdawar Cricle along-with record present and heard. Parawise comments requisitioned from the Deputy Commissioner Nowshera also received and examined. The appellant produced nothing in his defence though he was given ample opportunity except disowning the signatures affixed on documents as well as stating that the cases are under-trial before the Anti-corruption court. However, the Inquiry Officer in his separate reports in both the enquiries has proved him guilty on the basis of which major penalty of removal from service was awarded to him by the competent authority.Based on the reasons mentioned above, the appeal is dismissed and order of the Deputy Commissioner Nowshera dated 18.09.2015 upheld. Subsequent to arrest of appellant Vide FIR No. 05 dated 02/03/2015 by Anti- Corruption Establishment Nowshera in complaint of Mr.Shawas khan, inquiry was also entrusted to Additional Assistant Commissioner –II Nowshera, Mr. Tanveer Khan to probe the allegations, where the appellant was also found guilty of issuance of fake and false documents of girdawari to Mr.shawas khan, by misusing official authority in his own interested. (Annexure-B)
 - Correct. After receiving copy of Fir/arrest of appellant, his services were placed under suspension and Mr. Tanveer khan Additional Assistant Commissioner-II Nowshera was appointed inquiry officer to probe the allegations. (Annexure-C)

6. Incorrect. Both the inquiries were held as per law and rules and appellant was dealt as per law. No illegality has been Committed.

7. Incorrect. On receiving inquiry reports a show cause notice was issued upon the appellant along with inquiry report according to khyberpakhtunkhwa Civil Servants (Efficiency and Discipline) rules,2011. Whereas the inquiry officer, Mr. Tanveer Khan Khattak, Additional Assistant Commissioner-II Nowshera, has proved as guilty after consulting revenue record, false Fard, and copy of Girdawari issued by him, his statement, as well as statement of complainant. It has been proved that the Patwari misused official authority for his own interest by not taking signature/Thumb impression of seller, buyer and witness for mutation No.820 against Ripat No. 208 in Roznamcha Waqiati.

Whereas reply to show cause notice was found devoid of reason and sense. During personal hearing the accused patwari could not convince the undersigned being authority of his innocence.

Now therefore, 1 Zaka Ullah Khattak, being competent authority, keeping in view the above facts is pleased to agree with the inquiry report and therefore orders removal of services of the suspended patwari Muhammad Hassan (BPS-9) under section 4(1)(b) (iii) of Khyber Pakhtunkhwa, Government Servants (Efficiency and Discipline) Rules 2011, with immediate effect.

ORDER

IN THE COURT OF THE COMMISSIONER PESHAWAR DIVISION PESHAWAR

Muhammad Hassan, Ex Patwari, District Nowshera VS The Deputy Commissioner, Nowshera.

Appellant Respondent

My this order will dispose of the departmental appeal filed by the above named appellant against the order dated 18.09.2015 whereby the appellant was removed from service u/s 4(1)(b)(iii) of the Khyher Pakhtunkhwa (Efficiency & Disciplinary) Rules-2011. Aggrieved of the same, the instant departmental appeal was filed before this court challenging the impugned order of the Deputy Commissioner Nowshera as illegal, unlawful and prayed for setting aside of the same and re-institument.

Facts leading to filing of the instant departmental appeal are that 02 separate complaints were received to the Deputy Commissioner Nowshera through Anti-Corruption Estt: Nowshera by Mr. Zadin Khattak and Mr.Shawas Khan against the appellant in which FIRs were also registered against him for receing illegal gratification and issuing fake documents.

In pursuance of the above 02 complaints, the competent authority (Deputy Commissioner Nowshera) ordered an enquiry into each complaint through AAC-II, Nowshera which are as such:-

Complaint No.1.

Complaint was made by Mr. Zardin Khattak r/o Garu, Nizampur before the Anti Corruption Estt:Nowshera complaining that the appellant received Rs. 100,000/-and prepared a fake and false document/Fard of his land measuring 99 Kanals in Khsra No. 1208, hence the Anti-Corruption Estt: registered FIR against the appellant on 2.3.2015 and forwarded the case to the Deputy Commissioner Nowshera for further necessary action.

The Inquiry Officer, in his detailed enquiry report held that though the complaintant has deviated from his previous statement as in his complaint before the Anti-corruption deptt: the complainat has clearly mentioned the allegations while in his statement before the Inquiry Officer, he has deviated from his statement/complaint and produced an affidavit that he has made "razi nama" with the appellant. However, the inquiry Officer compared the previous fard issued to the complainant with the "Zere-kar fard" and found visible difference as in both fardats. The complainant's name was shown in "Khana-Kasht" in column in the fard issued earlier, while in the instant fard, the complainant's name was not mentioned. Hence according to the Inquiry Officer, the appellant has committed fraud and thus recommended him for major penalty.



Complaint No.2

Correlation Estt:Nowshera that the appellant received Rs. 16000/- and Rs. 4000/- as bribes in the year 2009 on account of documents of girdawari of shamilat land bearing khasra No. 14,44,326 of mauza Namal Sara toya and in Khasra No. 1350 of mauza Garu which later-on proved false and fake having no record.An FIR was registered against the appellant on 06.2.2015

The Inquiry Officer reported that the complainant purchased 06 kanals land through mutation No. 820 at manza Namal Sara Toya. The appellant received Rs. 16000/- for conducting girdawari in the name of the complainant in Khasra No. 14 & 44 and as per revenue record the said Khasra Nos are shamilat, land and entered as "maqbooza Malikan" in khana kasht colomn of the register khasra girdawari. Similarly, Khasra No. 1350 is situated in moza Garu whereas Khasra 326 falls in maza Namal Sara Toya and are shamilat deh. Upto the year 2015 (Rabi) Girdawari was entered in the name of Gulab shah etc. The complainant submitted application for correction of girdawari on 31.12.2014 accordingly, girdawari was made in his name.Hence the Inquiry Officer has concluded that fard girdawari issued by the appellant was false and bogus as it neither mention crops of Rabi or Kharif, neither any cogent reasons of change of girdawari, hence stating that if change of girdawari in Khasra No. 326 had occurred during the period of posting of the appellant, there would have been no need of re-conduct of girdawari. He has further stated in his report that that girdawari in Khasra No. 1350 has been conducted in the name of the complaint back in the year 2013 which testifies that that the pert girdawari in mauza Garu issued by the appellant is fake. Thus the appellant was held guilty in issuing false and bogus fard of girdawari to the complainant and recommended him for major penalty.It is however, observed that proceedings in both the complaints are going on in the Anticorruption court.

Appellant as well as representative of the Deputy Commissioner Nowshera Mr. Abdul Jabar, Girdawar Cricle along-with record present and heard. Para-Nowshera Mr. Abdul Jabar, Girdawar Cricle along-with record present and heard. Parawise comments requisitioned from the Deputy Commissioner Nowshera also received and examined. The appellant produced nothing in his defence though he was given ample opportunity except disowning the signatures affixed on documents as well as ample opportunity except disowning the signatures affixed on documents as well as stating that the cases are under-trial before the Anti-corruption court. However, the Inquiry Officer in his separate reports in both the enquiries has proved him guilty on the basis of which major penalty of removal from service was awarded to him by the competent authority.Based on the reasons mentioned above, the appeal is dismissed and order of the Deputy Commissioner Nowshera dated 18.09.2015 upheld.
