- That the appellant has got no cause of action locus standi to file the instant appeal.
- That the appellant has not come to this honorable tribunal with clean hands.
- That appellant concealed material facts from this honorable tribunal.
- That the appellant is estopped by his own to bring the present appeal.
- · That the appeal is bad due to mis-joinder and non-joinder of necessary parties
- That the appeal is barred by law.

ON FACTS.

- 01 The appellant was appointed on June 19, 2020 as PST at GPS Bara Kas Landi Kotal District, Khyber. Meanwhile, the appellant was booked by EMA for proxy or impersonate teacher Mr. Arman Ali since 01/12/2020 and reported accordingly, which ultimately resulted in the termination of his contract being contract employee by then DEO Mr. Nisar Muhammad as competent authority vide DEO Office Khyber Endst. No. 2702-08 dated March 28, 2022. ANX-A
- 02.Incorrect, hence denied. The than DEO Khyber as a competent authority cancelled/withdrew the termination order and restored his services with certain conditions in interest of public service. **ANX-B**
- 03 Incorrect. Hence denied. Being contract employee he was bound to serve in accordance with the terms and condition of his appointment as contract employee. Every contract employee is also legally bound to follow laws, rules, regulations, and policies related to government servants, therefore, office concerned called from the appellant an undertaken/affidavit to perform his duty regularly and avoid using proxy or impersonation. Proxy or impersonation in all conditions is illegal. The conditions are mentioned in withdrawal order. **Annexure-B.**
- 04. Incorrect denied. The respondent 01 had only required report regarding the issue.

 ANX-C
- 05 Incorrect denied. The appellant continued with flouting the law and rules and persistently used Mr. Arman Ali CNIC No.21203-31182131-1 as proxy in his place at GPS Bara Kass BZK Landi Kotal.

06. Departmental inquiry was initiated vide order Endorsement NO. 1216-22 dated 05/09/2022 against the appellant Ex-PST GPS Bara Kas Landi Kotal wherein he was proved for using proxy teacher in the garb of Mr. Arman Ali CNIC No.21203-31182131-1. ANX- D

Ground:

- A. Incorrect. Hence denied. The respondent department has treated the appellant in accordance with laws and rules. The appellant was involved in corrupt practices and used a proxy or impersonate teacher (Arman Ali) instead of himself. The impersonating teacher (Arman Ali) was presented with an affidavit detailing his involvement in corrupt practices, revealing that he received a sum of Rs.15000/-each month from march 2021 till to date from Karam Shah (the appellant) for his services as proxy teacher in his stead. (ANX-E) The appellant himself never performed his duty personally.
- B. Incorrect, hence denied. The respondent department withdrew the termination order in the best interest of public but the appellant continued with his illegal conduct, refused to perform duty personally by sticking to deceitful practices.
- C. Incorrect, hence denied. As elucidated in para 6 above facts.
- D. Incorrect, hence denied. Proper opportunity was given to the appellant, but he failed to mend his illegal behavior.
- E. Incorrect, hence denied. As elucidated above, the appellant could not mend his conduct and continued with fraudulent engagement of impersonated teacher in his place, and thus ultimately proved for guilty of misconduct and violation of rules.
- F. The appellant was deceiving the education department by keeping the proxy attendance through impersonate teacher, and wasted precious time of the students. The identity card, signature, and picture of the impersonated teacher are attached as ANX-F
- G. Incorrect, hence denied. As elucidated in para D in above ground.
- H. No comments.
- I. The respondent department also seeks permission of this Honorable Tribunal to advance other grounds at the time of hearing the instance case.

Pray:

In light of the above stated facts, it is submitted that the case of the appellant may be ordered as dismissed with cost.

Reference your office letter Endost: No. 1216-22 Dated: 05-09-2022 regarding inquiry against Mr. Karam Shah PST GPS Ayub Shah Killi Bara Kas BZK Landi Kotal for using proxy teacher instead of himself.

BACKGROUND HISTORY

GPS Ayub Shah Killi Bara Kas is located in Bazar Zakha Khel Landi Kotal. The mentioned official is only working teacher there. Total enrollment is 125 as per attendance registers. According to EMA report the said teacher was reported absent from his duties time and again, and that he is using another proxy teacher named Mr. Arman Ali (CNIC# 21203-3118213-1).

The said teacher was terminated by District Education office as a major penalty reported as using proxy teacher by EMA, termination order Endost: No. 2702-08 Dated. 28-03-2022, which was cancelled by the Office order Endost: No. 3418-24 Dated. 26-04-2022. (copies of both orders are attach for ready reference).

PROCEDURE ADOPTED

The inquiry officer visited the said school on 07-10-2022 during school timings. It found that Mr. Karam Shah PST was absent from his duty and another person named Arman Ali was performing teaching process in the school. He was also signing for Mr. Karam Shah PST in the attendance register. During inquiry process the proxy admitted that he is performing duties since March 2021 for Rs.15000/- per month (written statement attached).

Furthermore, the inquiry officer tried to contact with Mr. Karam Shah PST through his cell number and send him messages but got no feedback/response.

FINDING

From inquiry process and termination order it very is clear that proxy is being used at GPS Ayub Shah Killi Bara Kass BZK from the day first.

RECOMENDATIONS

The following recommendations are submitted for further necessary action.

- 1. Reinstatement order of the mentioned PST may be cancelled.
- 2. The period (March, 2021 till October, 2022) in which he has used proxy teacher salary of this duration may be recovered from him.
- Another regular teacher or PTC hired teacher must be provided to the school as soon as possible to avoid the closure of school.


