Respectfully Sheweth:

### **PRELIMINARY OBJECTIONS:**

- 1. That the Appellant has got no locus standai for filing this Service Appeal.
- 2. The Appeal is wrong and based on illegal and unlawful presumptions.
- 3. The Appellant has got no cause of action to file the present Appeal.
- 4. The Appeal is not maintainable in this present form.
- 5. That the Appeal is bad for mis-joinder and non-joinder of parties.
- 6. That the instant Appeal is badly time barred.

### **FACTS**

- 1. Correct to the extent that the appellant has been appointed as Chowkidar- cum- Behishti in the office of District Director Livestock Swat on 10/03/2010 (Annexure-A).
- 2. Correct to the extent that as per service recruitment rules of the Department, 33% reserved quota of Class-IV employees having requisite qualification for promotion against the post of Junior Clerk (BPS-11) subject to seniority cum fitness (Annexure-B). It is pertinent to mention here that the appellant is neither on the top of seniority list nor he is fit for promotion to the post of Junior Clerk being illiterate in typing skill. (Annexure-C).
- 3. Correct to the extent that all the Class-IV of the Department are eligible for promotion to the post of Junior Clerk, subject to seniority cum fitness and having the requisite qualification.
- 4. Incorrect. The appellant is lacking the ability of typing skill, which is mandatory for the post of Junior Clerk (BPS-11).
- 5. Incorrect. The appellant has not requested for seniority list, however, the appellant was called for typing test on 17/08/2022, wherein he was unable to qualify the said test and he submitted a departmental appeal No. 3101 dated 09/05/2023 (Annexure-D), after the lapse of 10 months which is badly time barred as per rules, however it was still responded to the appellant with cogent reason by the respondent No. 01 through letter No. 7604 dated 26/05/2023 by annexing the updated seniority list. (Annexure-E).
- 6. Incorrect. The claim of the appellant that he was not aware from the promotion process is ridiculous as all the Class-IV employees along with the appellant were called for an interview, wherein their typing skills were tested. However, the appellant once again failed the typing test. Moreover, all the successful candidates were promoted to the post of Junior Clerk on 02/01/2023. (Annexure-F).

- 7. Incorrect. The departmental appeal of the appellant was responded as mentioned in Para No. 05.
- 8. Incorrect. The appellant was considered in the promotion process, wherein he failed the typing test, it is worth to mention here that no verbal commitment was made by the respondents with the appellant and he was dealt as per Service Recruitment rules of the department.
- 9. Incorrect. The act and omission of the respondents are quiet legal and based on service recruitment rules of the Department.

### **Grounds**

- A. Incorrect. The action of respondents is based on facts and law and the Appellant's opinion regarding violation of his secured rights is totally biased and based on false presumptions.
- B. Incorrect. The respondents have acted in accordance with the service recruitment rules provided under the Law.
- C. Incorrect. The respondents are duty bound to treat the appellant in accordance with service rules. Furthermore, all the promotions have been made without any discrimination.
- D. Correct to the extent that all the Class-IV employees were promoted as per service recruitment rules, wherein the Appellant was not consider for Promotion as he was lacking the requisite qualification.
- E. The Appellant has been dealt as per rules laid down for the said promotion.
- F. The respondents are duty bound to deal with all the citizens in accordance with law.
- G. Incorrect. Any Article of the constitution of Pakistan has not been violated and the Appellant has been treated as per rules.
- H. Incorrect. The appellant cannot be promoted without having the typing speed of 30 words per minute, which is mandatory for the post of Junior Clerk.
- I. It is the duty of appellant to perform his duty as per terms and condition of his service.
- J. The statement of appellant is wrong and misleading as none of the employee has been promoted against the post of junior clerk without passing typing test. Therefore the statement of the appellant being similarly placed is out of question.
- K. The respondents seek permission to raise additional grounds at the times of arguments.

In view of the above, it is, therefore, most humbly prayed that the instant Appeal may kindly be dismissed in favor of the respondents with cost.




