Written Reply/Para wise Comments for & on behalf of Respondents No. 1, 2 & 3

Respectfully Sheweth

Preliminary Objections

- 1. That the service appeal is also badly barred by time and hit by the doctrine of laches, hence not maintainable.
- 3. That the service appeal is wholly incompetent, misconceived and untenable.
- 4. That the service appeal is wrong, baseless and not maintainable, it shows no strong cause to be taken for adjudication, therefore, the same service appeal is liable to be rejected/ dismissed.
- 5. That the service appeal is unjustifiable, baseless, false, frivolous and vexatious. Hence the same is liable to be dismissed with the order of special compensatory cost in favour of respondents.
- 6. That no constitutional or legal right of the appellant has been violated, therefore, the appellant is not entitled to invoke the constitutional jurisdiction of this honourable Service Tribunal.
- 7. That the appellant has not come to the Court/Tribunal with clean hands.
- 8. That the appellant has concealed the material facts from this Honourable Tribunal.
- 9. That the appeal is bad for misjoinder and non-joinder of the necessary party.
- 10. That the appellant has filed the instant appeal just to pressurize the respondents.
- 11. That the appellant has no cause of action to file the instant appeal.
- 12. That the appeal is not maintainable in the eye of law.
- 13. That the instant appeal is not maintainable in the present form and also in the present circumstances of the issue.

FACTS:

1. The first part of the para pertains to the record. However, as far as the case of respondent No. 4 and 5 is concerned, the scrutiny committee checked all the

documents of candidate and found them ineligible for appointment against the DM post because of not having one year Drawing master certificate. They had Integrated Drawing Examination (IGDE) certificate. The certificate of the appellant was sent to DCTE for guidance. The directorate of DCTE conveyed the guidance to the competent authority vide letter No 4310/DD(TRG) Abbottabad dated 22-04-2014, stating that the same certificate is not equivalent of the certificate mentioned in the advertisement, therefore, declared the appellant ineligible for recruitment to the post of DM. (The guidance of the Director DCTE is Annexed as A)

- 2. That after the issuance of appointment order of the appellant and other meritorious candidates, the respondent No. 4 and 5 filed writ petitions No. 159/2011 and 2288/2011 respectively, which were allowed by the court. (The judgment is attached is Annexure "B"). Against the judgment, the department filed a CPLA No. 456/2012 and the Honourable Supreme Court upheld the judgment of the Peshawar High Court. (The judgment is attached is Annexure "C"). Thus in light of the court judgments, the respondent department issued appointment orders of the respondent No. 4 and 5.
- That after issuance of appointment order, respondent No. 4 and 5 filed service appeal 85/2014 and 90/2014 respectively for their back benefits; however, the honourable service tribunal decided their appeals in the following words;

"In view of the above, we hold that the appellants are entitled to be considered as appointees with effect from the dates when other similarly placed candidates were appointed. The appellants would however not be entitled to any financial back benefits. The respondent department is to prepare their seniority list according to rules. The appeals are accepted in the above terms, leaving the parties to bear their own costs." (The judgment is attached is Annexure "D").

- 4. That in the mentioned writ petition, the honourable high court directed the department to appoint the petitioners against the posts applied for by the petitioners from 26-02-2011 without any financial back benefits.
- 5. That as per the decisions of the honourable service tribunal in Service Appeal No. 90/2014, 85/2014 and Writ petition No. 148-M/2011, the respondent department prepared seniority list in accordance with Section- 8 of Khyber Pakhtunkhwa Civil Servants Act, 1973 read with rules 17(1)(a) of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989. (Joint Seniority list is attached as Annexure "E").
- 6 That after issuance of joint seniority in accordance with court judgements in service appeal 85/2014 and 90/2014 and Section- 8 of Khyber Pakhtunkhwa Civil Servants Act, 1973 read with rules 17(1)(a) of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989, some candidates submitted applications against the seniority.
- 7. That in response to the applications, the respondent department constituted an inquiry committee vide endorsement No. 3753-56/8F. senior cadre-pro-2023 dated

07-08-2023. After conducting the detailed inquiry, the committee unanimously recommended the seniority of the appellants and respondents in the following words:

"Keeping in view, the service tribunal judgment dated 07-11-2016 in S.A. No. 90/2014 and S.A. No. 85/2014 under the Government of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) rules 1989, Section 17(a), it is recommended that the seniority list of DMs dated 30-04-2023 may be corrected in case of given teachers as follow;"

- 8. That before the mentioned inquiry proceedings in para 7 of the facts, in light of a number of appeals against the seniority issued on 30-04-2023, another inquiry was also conducted vide notification dated 10-06-2023 bearing endorsement No. 2793-96. However, the respondent department was not satisfied with the recommendations of the inquiry proceedings as the same did not elaborated the matter in a comprehensive manner. Thus, another inquiry mentioned in para 7 and the report of which is attached as annexed as G was conducted. In light of the recommendations of the committee, the respondent department accordingly issued a joint seniority. (Seniority list issued after the recommendations of the inquiry committee is attached as Annexure "H")
- 9. That the appeals of the appellant and other candidates are already decided in accordance with the recommendations of the inquiry committee and Section- 8 of Khyber Pakhtunkhwa Civil Servants Act, 1973 read with rules 17(1)(a) of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.

GROUNDS:

- 1. Incorrect hence denied. Respondents have treated appellant in accordance with law, rules and policy. Furthermore, the joint seniority dated 30-04-2023 was altered with seniority dated 30-08-2023 in light of a comprehensive inquiry which is just, fair and in accordance with law, rules and policies, hence is sustainable in the eye of law.
- Incorrect, hence strongly denied. The seniority list is rightly prepared strictly in accordance with Section- 8 of Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 17(1)(a) of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989, which is just, fair and in accordance with law, rules and policies.
- 3. Incorrect, hence strongly denied. As directed by the Honourable Service Tribunal in Judgments of Service Appeal No 85/2014 and 90/2014 filed for back benefits by respondent No. 4 and 5 respectively. Thus the joint seniority of the appellant, respondent No. 4 and 5 is accordance with Section- 8 of Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 17(a) of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- 4. Incorrect, hence denied. The rules, he refers to, has no relevancy to the instant matter. "Eligibility/ qualification mentioned in advertisement for post, candidates were required to meet the criteria mentioned in the advertisement on the date of submission of their applications. Respondent who was selected for the post, did not possess the requisite qualification on the said date and as such was not qualified to be considered for appointment." Same is reported in 2020 SCMR 568. In the advertisement the criteria for DM recruitment was Bachelor degree with one year DM certificate from a recognized institution, but the DM certificate of the appellant was not of one year duration. However, the respondents earned their right of appointment through judgment in writ petition No. 159/2011 and 2288/2011 and seniority as per judgments in Service Appeal No 85/2014 and 90/2014 in which the court directed the department to prepare seniority list accordance with the rules.
- 5. Incorrect, hence denied. The seniority list is prepared in accordance with law, rules and policy in field and as such the violation of anyone right to promotion cannot arise.
- 6. Incorrect, hence denied. The respondent department has issued the seniority list in accordance with law, rules and policy and the appellant was placed at his right place in the seniority list.
- 7. Incorrect, hence strongly denied. The seniority list is rightly prepared strictly in accordance with Section- 8 of Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 17(1)(a) of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989, which is just, fair and in accordance with law, rules and policies.
- Incorrect, hence denied. In light of a number of appeals against the seniority issued on 30-04-2023, another inquiry was also conducted vide notification dated 10-06-2023 bearing endorsement No. 2793-96. However, the respondent department was

not satisfied with the recommendations of the inquiry proceedings as the same did not elaborated the matter in a comprehensive manner. Thus, another inquiry mentioned in para 7 and the report of which is attached as annexed as G was conducted. In light of the recommendations of the committee, the respondent department accordingly issued a joint seniority.

9. That the respondents seek permission of Honourable service tribunal to raise/ argue other points/ grounds on the day of hearing the case.

It is earnestly requested that the appeal in hand may very graciously be dismissed with special compensatory cost in favour of respondents.



KHALID MAHMOOD, J.- This judgment shall dispose of writ petitions No.2093, 1896 of 2007, 294 of 2008, 3402 of 2009, 3620 & 4378 of 2010, 2288 & 159 of 2011, as same question of law is involved in all these petitions.

2. The brief facts of the case are that in response to advertisement for different posts of teachers in the Education Department, petitioners applied for the same. After conducting the test and interview for the said posts, the petitioners were ignored in the matter of appointment and the appointment orders dated 22.8.2007 etc, issued by the respondents department are illegal, without lawful authority and of no legal effect. According to petitioners, they were not invited for interview, rather vide impugned order dated 22.8.2007, appointment of respondents No.5 to 13 was made. Petitioners have prayed for directing the respondents concerned to appoint the petitioners being trained and qualified for the saic posts.

3. On 23.02.2012, during course of hearing, this Court come to the conclusion that all the certificates produced by the pet tioners with regard to their professional qualification should be examined by Secretary Education, th : Province of Sindh as to whether the same are genuine and have been issued by the concerned Institution and also to verify that the certificates produced by the petitioners are equivalent to Drawing Master. The petitioners were also directed to submit their original certificates with the Additional Registrar of this Court within a week time for sending for the above-said purpose. Prior to that comments and rejoinder were filed by the parties concerned.

<u>4.</u> Counsel for petitioners argued that impugned order issued by respondent No.1/ department is against law, withou jurisdiction and of no legal effect; that the petitioners were trained drawing masters; that respondent concerned had totally ignored the petitioners while making the impugned order of appointment in spite of the fact that they were placed at high pedestal of merit and qualified for the appointment.

On the other hand, it was argued on behalf of respondents that all the appointments were made in accordance with law and policy of the Government governing the subject.

5. With the valuable assistance of the counsel for the parties, the record perused.

The main grievances of all б. the petitioners in the present case that all the petitioners had submitted their requisite qualification along with certificate of Drawing Master before the respondent for their appointment. After test and interview, the merit list was prepared by the respondent concerned wherein the petitioners were declared highe. in merit but later on instead of appointment of petitioners, the other candidates were appointed on the ground that the Drawing Master certificate obtained by the petitioners from Institutions. situated in Jamshoru and Karachi are not equivalent to the certificate which was prerequisite for the post of Drawing Master. Counsel for the petitioners referred to the recruitment policy. He also referred to the advertisement published on 11.02.2007 in which the required qualification was F.A/F.Sc. with certificate of Drawing Master fron any recognized institution. According to the recruitment policy as well as said publication petitioners on the patch-

Enamination Peshawar High Court is Mingora/Dar-ul-O wise criteria had passed their examined on 31.5.1997. In the first merit list displayed by the respondents, the petitioners had qualified and stood first in the merit list. The respondents on the pretext that the certificate of Drawing Master is not obtained from the recognized institution, who were ignored in the said appointment and the case of the petitioners remained pending after verification of the Drawing Master certificate. Thereafter, the concerned institution where from the petitioners had obtained the D.M. certificate were asked for the verification of the said certificate. This Court too, had directed the concerned institution for the verification of the certificate.

7. In the similar nature case wherein the D.M. certificate was obtained from Jamshoru verified in a case by Abbottabad Bench of this Court, in WP No. 66 of 2009 titled "Muhammad Banaris vs. Govt. of Khyber Pakhtunkhwa" wherein it is held that the D.M. certificate by Jamshoru is competent and the recognized one.

<u>8.</u> In the present case, the D.M. certificate qualify from all corners as a genuine certificate issued by the recognized institution, which was the requirement of the recruitment policy as mentioned above. We have gone through the merit list which clearly indicates that the

petitioners have been deprived on lame excuse on the ground of delaying tactics regarding the verification of D.M. certificate obtained by the that petitioners, It was pointed out also respondent in subsequent appointment had also appointed other candidates who had obtained DM certificates from the same Institutions whereas, petitioners has been deprived though they have also qualified from the same Institutions, hence act of respondents is discriminatory and is utter violation of Article 25 of the Constitution. Instead of petitioners who were at better pedestal in the merit list, the other candidates who were below at the merit list as compared to the petitioners have been appointed which apparently shows the mala fide on the part of respondents. After thrashing the entire record, we have come to he conclusion that petitioners have wrongly been deprived for appointment against the post o. D.M. which requires interference by this Court.

Nasir-ul-Mulk, J.- These petitions for leave to appeal have been filed by the Executive District Officer, Schools of three Districts, Dir Lowe - Dir. duringselection attained required merits the but their appointments were declined on the ground that they had obtained plie requisite qualifications from the institutions situated in Jamshoro and Karachi. The petitions were accepted by the High Court on the ground that distinction could not be drawn between the award of degrees or services by the institutions of Jamshoru and Karachi and that of this Province. Thus on the ground of discrimination the writ petitions of respondents were allowed and the petitioners were directed to appoint the respondents to the said posts. We find no merits in these petitions as apparently no reasonable classification axists between the qualificatio is obtained from the said institutions and from those in Province of K.P.K since the respondents selection was made way back in the year 2007 and therefore directed the petitioners to issue appointment orders of the respondents. Today the said order have been produced before us. The respondents, except for one Lazim Khan, in Civil Petition No.07-P of 2013 has been duly appointed. 

MUHAMMAD AZIM KHAN AFRIDI, CHAIRMAN:-

Counsel for the appellant and Mr. Muhammad Zubair, Senior Government Pleader alongwith Mr. Fayazud Din, ADO for respondents present.

2. This judgment shall dispose of the instant service appeals No. 51/2014 as well as connected service appeals No. 52/2014 to 73/2014 and service appeals No. 84/2014 to 90/2014 as identical questions of facts and law are involved therein.

3. Brief facts of the afore-stated cases are that the appellants were declined appointments against posts advertised by the respondents constraining them to prefer Writ Petitions No. 1896, 2093 of 2007, 294 of 2008, 3402 of 2009, 3620 and 4378 of 2010, 159 and 2288 of 2011 before the august Peshawar High Court, Mingora Bench (Dar-ul-Qaza) Swat which were allowed vide worthy judgment dated 28.06.2012 and respondents were directed to appoint the appellants against the said posts. The said worthy Judgment of the Hon'ble hor Court was challenged before the august Supreme Court of Pakistan in Civil Petitions No. 456-P of 2012, 7-P to 11-P of 2013 and 19-P & 20-P of 2013. The said appeals were dismissed vide worthy judgment of the appellants against of the appeals were appointed and their

appointments orders were produced before the august corporation Pakistan. There-after Review Petitions were preferred by certain petitioners in the said Writ Petitions before the Peshawar High Court, Mingora Bench (Dar-ul-Qaza) Swat which was allowed vide worthy judgment dated 22.10.2013 and the petitioners seeking relief were allowed to be considered as appointees from the dates when other candidates were appointed, without any financial benefits.

4. Learned counsel for the appellants has argued that the appellants are also entitled to similar treatment as extended to similarly placed employees by the Hon'ble High Court in Review Petition No. 7-M/2012 in Writ Petition No. 3620/2012(D).

5. In support of his stance he placed reliance on case-laws reported as 2009-SCMR-1 (Supreme Court of Pakistan), 1998-SCMR-2472 (Supreme Court of Pakistan) and 1999-SCMR-988 (Supreme Court of Pakistan).

6. Learned Senior Government Pleader has argued that the appellants are not entitled to the relief claimed as they have not preferred any Review Petition against the judgment and appointment orders before the Hon'ble High Court.

7. We have heard arguments of learned counsel for the parties and perused the record.

Contration -

8. The august Supreme Court of Pakistan in the reported cases referred to above, had ruled that if a Tribunal or the Supreme Court decides a point of law relating to the terms and conditions of a civil servant who litigated, and there were other civil servants, who may not have taken any legal proceedings, in such a case, the dictates of justice and rule of good governance demand that the benefit of the said decision be extended to other civil servants also, who may, not be parties to that litigation, instead of compelling them to approach the Tribunal or any other legal forum.

9. Though the appellants have not preferred any review petition before the Hon'ble High Court but in view of the case-laws as discussed above, appellants are entitled to the benefits of the decision of the Hon'ble High Court as they are similarly placed civil servants.

10. In view of the above, we hold that the appellants are entitled to be considered as appointees with effect from the dates when other similarly placed candidates were appointed. The appellants would however not be entitled to any financial back benefits. The respondentdepartment is to prepare their seniority list according to rules. The appeals are accepted in the above terms, leaving the parties to bear their own costs. File be consigned to the record room.

THE ¹KHYBER PAKHTUNKHWA CIVIL SERVANTS (APPOINTMENT, PROMOTION & TRANSFER) RULES, 1989

PART-I

GENERAL

1. Short title and commencement: - (1) These rules may be called the ²[Khyber Pakhtunkhwa] Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.

(2) They shall come into force at once.

2. **Definitions:-(1)** In these rules, unless the context otherwise requires:-

- (a) "Appointing Authority" in relation to a post, means the persons authorized under rule 4 to make appointment to that post;
- (b) "Basic Pay Scale" means the Basic Pay Scale for the time being sanctioned by Government, in which a post or a group of posts is placed;
- (c) "Commission" means the ³[Khyber Pakhtunkhwa] Public Service Commission;
- ⁴(d) "Departmental Promotion Committee" means a committee constituted for making selection for promotion or transfer to such posts under a Department, or offices of Government, which do not fall within the purview of the Provincial Selection Board;
- ⁵(dd)"Departmental Selection Board" means a Board constituted for the purpose of making selection for initial recruitment /appointment to posts under a Department or office of Government in Basic Pay Scale 17 not falling within the purview of the Commission:

Provided that more than one such committees may be constituted for civil servants holding different scales of pay".

- (e) "Departmental Selection Committee" means a committee constituted for the purpose of making selection for initial appointment to posts under a department, or office of Government [in Basic Pay Scale 17 and below not falling within the purview of the Commission];
- (f) "Post" means a post sanctioned in connection with the affairs of the Province, but not

PROBATION AND CONFIRMATION

⁴⁷15. <u>Probation.</u> ----- (1) Persons appointed to posts by initial recruitment, promotion or transfer shall be on probation for a period of one year.

(2) The appointing authority, if considers necessary, may extend the probation period for one year as may be specified at the time of appointment.

 $^{48}(3)$ On the successful completion of probation period, the appointing authority shall, by specific order terminate the probation of the officer or official concerned within two months after the expiry of probation period prescribed in sub-rule(1):

Provided that if no specific order regarding termination of the probation period of the official or officer concerned is issued within two months, the period of probation shall be deemed to have been extended under sub-rule (2):

Provided further that if no specific order is issued on the expiry of the extended period of probation, the period of probation shall be deemed to have been successfully completed."

16. **Confirmation:**-After satisfactory completion of the probationary period, a civil servant shall be confirmed; provided that he holds a substantive post, provided further that a civil servant shall not be deemed to have satisfactorily completed his period of probation, if he has failed to pass an examination, test or course or has failed to complete successfully a training prescribed within the meaning of sub-section (3) of Section 6 of the ⁴⁹[Khyber Pakhtunkhwa] Civil Servants Act, 1973.

PART-VI

SENIORITY

17. Seniority :-(1) the seniority inter se of civil servants 50 (appointed to a service, cadre or post) shall be determined:-

- (a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission ⁵¹[or as the case may be, the Departmental Selection Committee;] provided that persons selected for appointment is post in an earlier selection shall rank senior to the persons selected in a later selection; and
- (b) in the case of civil servants appointed otherwise, with reference to the date of their continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post,

Explanation-I:- If a junior person in a lower post is promoted to a higher post temporarily in the public interest, even though continuing later permanently in the higher post, it would not adversely effect the interest of his seniors in fixation of his seniority in the higher post.

Explanation-II:- If a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted the person promoted first shall rank senior to the person promoted subsequently; provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for the time being for want of certain information or for incomplete record or for any other reason not attributing to his fault or demerit.

Explanation-III:- A junior person shall be deemed to have superseded a senior person only if both the junior and the senior persons were considered for the higher post and the junior person was appointed in preference to the senior person.

(2) Seniority in various cadres of civil servants appointed by initial recruitment vis-à-vis those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that cadre; provided that if two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment.

⁵³(4) The inter-se-seniority of civil servants in a certain cadre to which promotion is made from different lower posts, carrying the same pay scale shall be determined from the date of regular appointment/promotion of the civil servants in the lower post.

Provided that if the date of regular appointment of two or more civil servants in the lower post is the same, the civil servant older in age, shall be treated senior.

18. General Rules: - In all matters not expressly provided for in these rules, civil servants shall be governed by such rules as have been or may hereafter be prescribed by Government and made applicable to them.

19. Repeal:- The ⁵⁴[Khyber Pakhtunkhwa] Civil Servants (Appointment, Promotion and Transfer) Rules, 1975, are hereby repealed.

Unlike, the two DM,s Mr. Sherin Zada and Mr. Gul Rasool khan have been appointed on 20-06-2013 and have been considered for seniority w.e.f 24-02-2011 in the light of court judgement. But Taj Akbar, Irshad Ali and Ashbar Ali impugn the seniority position of Mr. Sherin Zada and Gul Rasool Khan. While Muhammad Ayaz DM transferred from Distt Charsadda on 05-11-2012 also impugns the seniority position of Mr. Sherin Zada etc.

To find out the factual position and determination of Inter-se-seniority, the committee visited DEO (M) Buner Office on 24-08-2023 with prior information to all concerned.

All the applicants present as mentioned below, were heard and the record was perused.

Facts:

(A) Mr. Sherin Zada DM

1. Mr. Sherin Zada DM, has been appointed against DM post on 20-06-2013 in light of High court verdict upheld by August Apex Court of Pakistan.

2. In SA.No.85/2014 Dated: 07-11-2016, the service Tribunal Peshawar accepted appeal of the appellant with the direction to the department which is reproduced as:

"The appellant is entitled to be considered as appointees w.e.f the dates when other similarly placed candidates were appointed. The appellants would however not be entitled to any financial back benefits. The respondent department is to prepare their Inter-se-seniority according to rules."

3. He was appointed vide order Endstt No. 15587-94 Dated: 20-06-2013 and was placed at seniority No 73 in the final seniority list issued by the DEO (M) Buner on 30-04-2023 in light of the above said court decision as per rules, w.e.f 24-02-2011,

4. His batch/session is 31-05-1997 with score 47.35.

(B) Mr. Gul Rasool Khan DM

1 Mr. Gul Rasool Khan DM, has been appointed against DM post on 20-06-2013 in light of High Court verdict upheld by August Apex Court of Pakistan.

2 In SA NO. 90/2014 Dated 07-11-2016, the Service Tribunal Peshawar accepted appeal of the appellant with direction to the department which is reproduced as:

"The appellant is entitled to be considered as appointees w.e.f the dates when other similarly placed candidates were appointed. The appellants would however, not be entitled to any financial back benefits. The respondent department is to prepare their Inter-se-seniority list according to rules.

3. He was appointed Vide order Endst No. 15587-94 Dated: 20-06-2013 and was placed at seniority No 74 in the final seniority list issued by the DEO (M) Buner on 30-04-2023 in light of the above said court decision, w.e.f 24-02-2011.

4. His batch/session is 16-05-2005 with score 52.46.

DID

(C) Irshad Ali DM

1. Mr. Jrshad Ali was appointed against DM Post vide order Endstt No. 8529-37/DA Dated: 24-02-2011 in 25% open merit.

2. His batch/session is 31-12-2008 with score 58.92

3. His number in the current seniority list is 76.

(D) Ashbar Ali DM

1. Mr. Ashbar Ali was appointed as DM vide order Endstt No. 8529-37 Dated 24-02-2011 in 25% open merit.

2.°His batch/session is 31-12-2008 with score 57.77.

3. His number in the current seniority list is 75.

(E) Taj Akbar DM

1. Mr. Taj Akbar was appointed against DM post vide Endstt No. 8529-37 Dated 24-02-2011 in 25% open merit.

2. His batch/session is 31-12-2008 with score 53.17.

3. His number in the current seniority list is 78.

Note:

Noor Rahim appointed against DM post vide order Endstt No.8529-37/DA Dated 24-02-2011 under 75% Batch wise/year wise, his batch/session is 28-12-2006 with score 51.66 and his seniority number is 77.

(F) Muhammad Ayaz DM

1. Mr. Muhammad Ayaz has been transferred from Distt charsadda to Distt Buner and took over charge on 07-11-2012. His number in seniority list is 87.

RULES FOR DETERMINATION OF SENIORITY

The rules in field for the determination of Inter-se-seniority of Khyber Pakhtunkhwa civil servants (Appointment, Promotion and Transfer) Rules, 1989, the operative sections are reproduced as follows 17(a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the commission [or, as the case maybe, the departmental selection committee;]

Provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection; and

(b) In the case of civil servants appointed otherwise, with reference to the dates of their continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post retain their Inter-se-seniority as in the lower post.

Explanation I

If a junior person in lower post is promoted to higher post temporarily in the public interest, even though continuing later permanently in the higher post, it would not adversely affect the interest of his seniors in fixation of his seniority in the higher post.

Explanation II

If a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted, the person promoted first shall rank senior to the person promoted subsequently; provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is differed for the time being for want of certain information or for incompletion of record, or for any other reason not attributing to his fault, or de merit.

Explanation III

A junior person shall be deemed to have superseded a senior person only if both the junior and the senior persons were considered for the higher post and the junior person was appointed in preference to the senior person.

2. Seniority in various cadres of civil servants appointed by initial recruitment vis-à-viz those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that cadre; provided that if

two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment.

3. In the event of merger/restructuring of the departments, attached departments or sub ordinate office, the Inter-seseniority of civil servants affected by the merger/restructuring as aforesaid shall be determined in accordance with the date of their regular appointment to a cadre or post.

4. The Inter-se-seniority of civil servants in a certain cadre to which promotion is made from different lower posts, carrying the same pay scale shall be determined from the date of regular appointment/promotion of the civil servant in the lower post.

Provided that if the date of regular appointment of two or more civil servants in the lower post is the same, the civil servants older in age, shall be treated senior. The most important note for the determination of Inter-se-seniority:

- For the purpose of seniority, the score of the person shall be considered only in the batch/session. The lowest in merit in one batch shall be senior than the highest scorer in the next batch.
- Vide NO SO (PE) 4-5/SSRC/Meeting/2012/ teaching cadre dated November 13,2012, the rules of batch wise recruitment were ceased and converted into initial recruitment on merit.
- It is settled law that change of cadre is promotion while change of grade not cadre is upgradation. It is held by the August Supreme Court of Pakistan in 2009 SCMR 82.

"Both the incumbents were selected and appointed in the same batch. Mere fact one of them assumed the duties earlier would not adversely affect the seniority position of the one who assumed the duty later."

Conclusion

In the instant case, Mr. Noor Rahim appointed in 75% batch wise/year wise merit vide order Endstt No. 8529-37 Dated 24-02-2011, his session is 28-12-2006 with score 51.66 and seniority No 77 clearly indicates that the similarly placed candidates related to Mr. Sherin Zada session 31-05-97 and Mr. Gul Rasool Khan session 16-05-2005 have been appointed prior to 24-02-2011 order as mentioned. According to batch/session, Mr. Sherin Zada dserves to be placed in the seniority list 30-04-2023 at seniority No 73 and Gul Rasool Khan at S.No 74 while Irshad Ali may be placed at S.No 75, Ashbar Ali maybe placed at S.No. 76 and Taj Akbar may be placed at S.No 77, Noor Rahim comes on Seniority position 78 and for determination of seniority position of Mr. Muhammad Ayaz, the court judgement in r/o Mr. Said Fareen Khan, Alam Khan, Muhammad Tahir, Haider Ali, Muhammad Ghafoor, Javaid Shah and Sher Zamin Khan must be provided. Due to non-provision of record and absence from appearing before inquiry committee, the seniority of Mr. Said Fareen Khan, Mr. Alam khan, Muhammad Ghafoor, Javaid Shah and Sher Zamin Haider Ali, Muhammad Ghafoor, Javaid Shah and Sher Zamin khan and so as Muhammad ayaz still remains disputed.

RECOMMENDATION

Keeping in view, the Service Tribunal Judgement Dated 07-11-2016 in SA No 90/2014 and \$A No.65/2014 under the rules Govt of Khyber Pakhtunkhwa civil servants (Appointment, promotion & Transfer) rules 1989, section 17(a), it is recommended that the seniority list of DM, s dated 30-04-2023 may be corrected in case of given teachers as follows.

All these teachers sented their selves from appearing before the inquiry committee due to unknown reason. If court dgement mentioning appointment of the above candidates against the post applied by them from 26-02-11 without any financial back benefits, then maybe placed after Noor Rahim Seniority No. 78 and so on cordingly and after that Muhammad Ayaz be placed just after them as per following detail.


