





**PRAYER:** ON ACCEPTANCE OF INSTANT APPEAL, RESPONDENTS MAY BE DIRECTED TO MAKE PAYMENT OF SPECIAL ALLOWANCE 2021 TO THE APPELLANT ALONGWITH ARREARS FROM THE DATE OF INCEPTION TILL DATE AND REIMBURSE THE AMOUNT ALREADY RECOVERED AFTER JUNE 2022 FROM THE APPELLANT. ANY OTHER RELIEF WHICH HONOURABLE TRIBUNAL DEEM FIT AND APPROPRIATE IN THE CIRCUMSTANCES OF THE CASE MAY ALSO BE GRANTED.

Respectfully Sheweth: -

1. That the appellants as serving in prosecution department as Assistant Public Prosecutors and presently posted at District Public Prosecutor office in District Haripur. Copy of order is annexed as Annexure "A".
2. That the appellant served the department with due diligence and ever remained in front line of action as and when required by the Department for the betterment of criminal justice system.
3. That the government of Khyber Pakhtunkhwa announced special allowance for all government servants for the year 2021 vide notification No.FD(SO SR-II 2-5/2021-22/Special Allowance: dated 11/08/2021. (Copies of notification is annexed as Annexure "B").
4. That as per notification, the special allowance 2021 is admissible to those employees in BPS 17 & above who are not

in receipt of allowance equal to or more than 100% of basic pay (whether frozen or otherwise). It will also not be admissible to those employees who are in receipt of allowance like Teaching Allowance vide No.FD(SOSR-II)2-5/2021-222/11 Professional Allowance, Risk Allowance and Health Professional Allowance etc, All the Allowances mentioned above are more than 150% of their basic pay put despite of the fact appellant were refused special allowance of 2021. It is pertinent to mention that initially the same was given to appellant but from June 2022 and the same was stopped and District Account Officer started making recovery from the appellant. (Copies of salary slips of the appellant are annexed as Annexure "C").

5. That appellant approached the concerned authorities through application/representations for redressal of grievance but the issue was not redressed and humble request of appellant was not entertained so far. The respondent No. 06 without

justification turned down the representation  
vide impugned order

'E"). Hence, the instant service appeal is  
filed inter-alia, on the following grounds:-

**GRUNDS:-**

- a. That the impugned letter issued by Assistant Director Finance, is against the law and facts, hence, liable to be set-aside. The impugned order dated 17/10/2023 is against the spirit of the Notification No. FD(SOSR-II)2-5/2021/Special Allowance dated 11/08/2021.
- b. That the respondent No.7, whenever contacted by the petitioner showed his inability to allow special allowance due to the so-called reason that Prosecution Officers are getting Special Allowance. The lame excuse of respondents is based on mala fide.





against the law because, prosecution allowance was never mentioned in Notification No. FD(SOSR-11)2-5/2021/Special Allowance dated 11/08/2021 and the special allowances mentioned in notification such as Teaching Health and IT allowance are more than 150% of basic pay of the incumbents on the other hand prosecution allowance is only 25% of basic pay, therefore, cannot be equated with the kind of special allowance mentioned in notification. Copies of notifications are annexed as Annexure "F".

- c. That as per Article 25 of Constitution of Pakistan respondent department is supposed to adopt one yard stick, as the same allowance is being paid to other similar employees like Government pleaders, police and judiciary employees. Hence, similarly on the same analogy the appellant is entitled for same relief in all fours.

- d. That no other efficacious, speedy and adequate remedy is available to appellant except to the file instant appeal.
- e. That the other points shall be urged at the time of arguments.

It is, therefore, humbly prayed that on acceptance of instant appeal respondents may be directed to make payment of special allowance 2021 to the appellant alongwith arrears thereof from the date of inception till date and reimburse the amount already recovered after June 2022 from the appellant. Any other relief which Honourable tribunal deem fit and appropriate in the circumstances of the case.





- iii. It will be subject to Income tax.
- iv. It shall not be treated as part of emoluments for the purpose of calculations of pension/gratuity and calculation of House Rent etc.
- v. It will not be admissible to the Officers/Officials who are on earned leave, extra ordinary leave and study leave, except casual leave.
- vi. All Autonomous/Semi-Autonomous/Medical Teaching Institutions/other Institutions and Authorities under Provincial Government shall be notified within their respective resources.

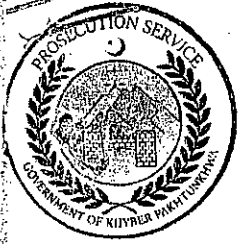

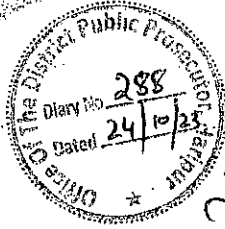

2. That as per contents of notification NO:FD(SO SR-II )2-5/2021-22/special Allowance: Dated 11-08-2021 special Allowance 2021 is to be paid @ 20% of initial basic pay scale of 2017 to the civil servants in BPS 17 & above with effect from 01.06.2021 in the best public interest.

The above allowance will be admissible subject to the following conditions:

- (i) It will be admissible to those employees in BPS 17 & above who are not entitled for allowance equal to or more than 100% of basic pay (whether frozen or otherwise).
- (ii) It will also not be admissible to those employees who are in receipt of allowance like Teaching Allowance vide NO.FD(SOSR-II)2-5/2021-222/Teaching Allowance dated 07.07.2021, IT Professional Allowance vide NO.FD(SOSR-II)2-5/2021-222/IT Professional Allowance, Risk Allowance and Health Professional Allowance etc.

2. That the applicant is serving as Assistant Public Prosecutor in Prosecution Department and posted at District Haripur but unfortunately had not received special allowance 2021 till date due to reluctance of District

Account office Haripur. It is pertinent to mention that prosecutors are neither getting any Allowance equal to 100% of their basic pay nor they fall in any category of allowance mentioned above in Para No (ii) of ibid Notification, as these allowances are more than 150% of their basic Pay, hence, refusal of Special Allowance 2021 w.e.f 01.06.2021 by District Account officer Haripur is unjustified and liable to be rectified.

3. That as per notification the employees who are not in receipt of professional allowances mentioned therein are entitled to get special allowance 2021 and decline of special allowance to the applicant on that analogy is against the spirit of fundamental rights as envisaged in the constitution of Pakistan 1973 and amount to discrimination against the applicant. For clarification your attention is derived to the fact that similar special allowance is being received by other stake holder of Criminal Justice System i.e. Judiciary as well as police, District Attorney and fellow colleagues in other Districts.

4. That it is worth mentioning that right from the date of inception, till June 2022 Special Allowance 2021, was given to undersigned and to all the Prosecutors of district Haripur, but after that District Account Officer started deduction and recovery. This act of District Account Officer was not warranted by law and shows biasness on his part which needs redressal from your good office.

It is therefore, most humbly prayed that District Account Officer Haripur may please be directed to act in accordance with law and special allowance 2021 may be given to applicant and prosecutors of District Haripur w.e.f 01.06.2021 along with arrears.

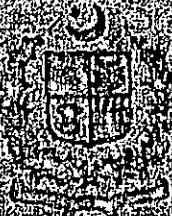
