PRELIMINARY OBJECTIONS

- 1. That the appellant is <u>not a civil servant</u> for her appointment was on <u>contract/adhoc basis</u> only for one year w.e.f 22.08.2014 and that her services haven't been regularized by the respondents (for the Regularization Act was commenced in 2018, which does not shelter the appellant).
- 2. That the present appeal is badly hit by *Doctrine of Latches*.
- 3. That the Appellant is not aggrieved in light of the terms of conditions of her appointment order or service rules.
- 4. That the appellant was illegally appointed, depriving a meritorious candidate, Mst Shafqat Noreen, as detailed in a departmental inquiry (dated 05.8.2015) by Principal Mr. Qaisar Anwar et. al. which recommended that "Extension may not be granted to Arshia Latif being below merit"

- 5. That, On 02.9.2015, another enquiry by Mrs. Amatullah Tasneem et al. recommended on "Extension may not be granted to Arshia Latif being below merit"
- 6. That the deprived meritorious candidate, <u>Mst. Shafqat Noreen</u>, with NTS Score 114.06, has already been appointed dated 16.9.2015 vide No. 5722-26, <u>in place of this Appellant</u> when inquired into the matter by the inquiry committee.

- 7. That this Service Appeal may please be dismissed being infructuous for the appointment of the Appellant has already been set aside/ nullified vide this office Order No. 5583-89, dated 27.4.2017 and the place has been duly filled with another meritorious candidate Mst. Shafqat Noreen, NTS score 114.06. Hence **contract** of the Appellant, if claimed, shall be considered terminated.

- 10. That the Appellant was mistakenly appointed vide a piecemeal Order, dated 22.8.2014, mistakenly, due to rush of work, and her contract was not extended / regularized.
- 11. That the clerical mistake in the order dated 22.8.2014 was corrected well in time.
- 12. That the service appeal filed by the Appellant is a prima facie case of Below-Merit, contract employee and not a civil servant; hence finds no grounds to be litigated in this Honorable Tribunal.
- 13. That the Appellant has filed the instant appeal just to pressurize the respondents and achieve a job without merit.
- 14. That the Appellant is stopped by own malafide conduct to file the time bared appeal.
- 15. That the appeal of the Appellant was illegal and without merit. Hence, is liable to be dismissed with cost.
- 16. Learned Council of the respondent may seek permission for additional grounds during the course of arguments.






