Respectfully Sheweth:-

The Appellant most respectfully submits as under:-

### **BRIEF FACTS:**

- That the appellant was appointed as Driver Constable in the incumbency of respondents/authority on 18/07/2007 in the District Police Tank after observing all the legal and codel fulfillments and was allotted Belt No. 231. Copy of the service card is annexed as <u>Annexure-A</u>.
- 2. That during the performance of duties with full satisfaction of superiors the appellant received on 12/06/2023 the charge sheet vide letter No. 3170/PA dated 06/06/2023 along with letter of statement of allegation which was properly replied by the appellant on 17/06/2023. Copies of charge sheet and its reply are annexed as <u>Annexure-B & C</u>.
- 3. That the appellant was on emergency duty in District Kurram and received a massage from Line Police on 31/07/2023, that you have been dismissed from service, then the appellant was not permitted for two days and respondents taken duties from him. As the appellant was not in knowledge of any proceeding therefor the appellant submitted an applications to procure the impugned order along with any other relevant documents (if any). In response the said applications the respondents handed over (قيما ولل المعالية) the impugned order No. 4560 dated 31/07/2023 of 'dismissal from service along with alleged finding report No. 233 dated 19/07/2023. Copies of impugned order, finding report dated 19/07/2023 are annexed as Annexure-D & E and the application in respondent.
- 4. That after receiving the impugned order the appellant filed departmental appeal to the respondent#2 (appellate

authority) on 16/08/2023. Copies of the departmental appeal along with postal receipt are annexed as **Annexure-F**.

5. That the learned respondent#2 (appellate authority) uptill now not decided the appeal of appellant within stipulated period, hence, the instant appeal is being filed, inter alia, on the following ground.

#### **GROUND**:

- a. That the impugned order No. 4560 dated 31/07/2023 issued by the respondent#3 is against law, facts, natural justice, void ab initio, hence, liable to be set aside and the order of the respondent#2 (if any) on the departmental appeal may also be set aside.
- b. That impugned order No. 4560 dated 31/07/2023 is against law, principle of service laws, policy, rules, regulations and also against the Police Rules, 1934 as amended in 2014 and is also not in the commence of EASTA,Code.
- c. That the allegations in the charge sheet, and in statement of allegations are false and the appellant has no relevancy whatsoever with the allegations as alleged against the appellant in respect of loading of cartridges of 30 bore because there is no proof including recording of message.
- d. That no initial show cause notice, final show cause notice issued to the appellant and no inquiry whatsoever has been conducted including statements of the witnesses and an opportunity of cross examination by the respondents authority and the appellant has been made an escape goat for the alleged allegations as the colleagues of the
  - appellant namely Aleem Khan Gonstable and Inam Ullah Constable have been exonerated from the allegations. The appellant has been clear cut discriminated on the presumption, speculation, conjectures and surmises, although the appellant could not think out such an act, and the appellant was nor in the knowledge of alleged taking and handing over of ammunition as alleged against him.

- e. That the whole proceedings (although not admitted) whatsoever has been done by the respondents/authority in slipshod manner expeditiously.
- f. That the appellant is a poor fellow having family with children and there is no earning hand except the service of appellant, hence, the service of appellant is liable to be reinstated along with all back benefits.
- g. That counsel for appellant may kindly be allowed to raise additional grounds at the time of arguments.

It is therefore, humbly prayed that on acceptance of the instant Service Appeal the impugned order dated 31/07/2023 issued by the DPO Tank may please be set aside and the order of the appellate authority (if any) passed on the departmental appeal of appellant may also be set aside and the appellant may kindly be reinstated into service with all back benefits including salaries from August 2023 till the reinstatement and onwards.

2. For the above, serious/professional misconduct of the accused officer, he was served with charge sheet/statement of allegations. An enquiry was conducted into the matter through Mr. <u>Masir Khan SP</u> <u>Investigation Tank</u> under Police Rules-1975, ammended-2014. The Enquiry Officer submitted his finding report in which he stated that Driver Constable Muhammad Ali No.231 called Driver Inam Ullah No.489 to brought 400 rounds of 30 bore from his friend at Dara. Adam Khei, While bringing the ammunition, he was caught red-handed by the Kohar police. The police challan party did not care about the reputation and defame for police department, in which driver constable Muhammad Ali is the main character. Therefore, Driver Constable Muhammad Ali No.231/MT staff is found guilty of the charges leveled against him and recommended for Major punishment.

3. Keeping in view of the finding and recommendations of the Enquiry Officer, the undersigned came to the conclusion that the charge leveled against the accused official has been established beyond any shadow of doubt.

4. Nevertheless, in the light of above, I, WAQAR AHMED, DISTRICT POLICE OFFICER, TANK, in exercise of the powers conferred upon me under section 4 (b) clause (iv) of the Police Rules 1975, hereby award him Major Punishment of DISMISSAL FROM SERVICE, with immediate effect, being found guilty.
