





03. The meeting commenced with recitation from the Holy Qur'an. Mr. Speaker welcomed all participants for attending the meeting and directed the Director (Fin: & Acc), Provincial Assembly Sectt. for presentation of the Agenda item wise.

04. The Agenda was discussed item-wise and the following decisions were arrived:-

ITEM NO. 01.**RESTRUCTURING AND STRENGTHENING OF VARIOUS CADRES OF PROVINCIAL ASSEMBLY SECRETARIAT THROUGH UPGRADATION, REDESIGNATION AND CREATION OF POSTS ON NEED BASIS.**

05. The Secretary Provincial Assembly the Committee that after enhancement of strength of the Assembly's Members from 124 to 145, it demands on one side the restructuring of existing staff and on the other side creation of new posts in different sections of the Assembly's Sectt. is also a dire need of the Sectt. to fulfill the requirements. Moreover, these cases have already been discussed in Parity Committee and forwarded for considerations of the Finance Committee.

[06.] [After detailed discussion the Committee approved proposed restructuring of various designations along-with up-gradations of different cadres/posts from S.NO.01 to S.NO.08 mentioned in the enclosed Annexure-A, however, regarding the Creations of new posts mentioned vide S.NO.09, the Committee approved the same after few amendments on the basis of rationalization.]

ITEM NO.02:**RESTRUCTURING AND STRENGTHENING OF VARIOUS CADRES OF MPA HOSTEL, PESHAWAR CREATION OF NEW POSTS ON NEED BASIS.**

07. It was told to the Committee that despite operational & administrative control of the MPAs Hostel, Peshawar, presently Staff of Works & Services Department Khyber Pakhtunkhwa is working in the Hostel and the Assembly's Sectt. has no administrative authority on them with respect to their rewards & punishment when needed.


