OBJECTION OVER IMPLEMENTATION /EXECUTION REPORT ON THE
JUDGMENT DATED: 26-03-2019 IN SERVICE APPEAL NO 1187/2014 IN
ITS TRUE LETTER & SPIRIT REGARDING SENIORITY OF PETITIONER

Brief facts of the case are that;

1. That the Hon'ble KP Service Tribunal, Peshawar decided the Service Appeal in favour of the Petitioner on dated 26/03/2019 at Camp Court, Dera Ismail Khan and accepted the appeal by set aside the impugned Seniority list.
2. That the Petitioner has filed an application to the respondent No. 1 through proper channel for implementation of the aforesaid order but the same was filed in light of the decision of the Scrutiny Committee of Law Department wherein the Case of Petitioner was approved for lodging CPLA in the August Supreme Court of Pakistan.
3. That the CPLA No 416-P/2019 was instituted on 17/06/2019 by the Department before the August Supreme Court of Pakistan along-with CMA No 984-P/2019 to maintain the status quo but the same was not entertained.
4. That in light of the above, the Departmental Selection Committee of Central Police Office, Peshawar has examined the implementation petition of the Applicant in its meeting held on 24/09/2019 and recommended the Judgment of the Service Tribunal may be sent to RPO (Respondent No 2) for further necessary action because the issue of Seniority in List 'E' is the legal mandate of the DIG/RPO. It was further directed that once this issue was settled by the RPO, the Seniority in List 'F' shall be rectified by the Departmental Selection Committee. (Annexure-I)
5. The Sub-committee of Departmental Selection Committee of Central Police Office, Peshawar held on 08.05.21 vide letter No CPO/CPB/211 dated 21/05/2021 directed the Respondent No 2 to respond to the instant Execution Petition.(Annexure-II)
6. That in light of the directions of the Central Police Office letter issued vide No 317/CPB dated 08/12/2022 and No CPO/CPB/329 dated 30/12/2022, the Respondent No 2 has revised the confirmation of all the Officers of the Range in substantive rank of ASI from date to appointment including the Petitioner by placing him below the Private Respondents. (Annexure-III)

7. That the Execution Report submitted by the Respondents in the Tribunal on 09/01/2023 is just an eye wash of this august Tribunal until and unless the judgment of the Tribunal is not implemented in toto and this honorable is has the power to ask the delinquent respondents with iron hands to implement the judgment without any further delay as justice delayed justice denied.
8. That the Service Appeal of the appellant purely pertains to the controversy of "Seniority" and error at one place, runs afterwords. Thus, if the point of error is desired to be rectified, then, rectification must go further i.e in case of appellant till the rectification of list "F".
9. That the Respondents are legally bound to implement the judgment passed by this honourable Tribunal in its true letter and spirits without making any pick and choose.
10. That the Respondents are legally bound to issue the revised Seniority List rectifying the placement of the petitioner but they are hesitating to implement the judgment of this Honorable Court.

PRAYERS:

In view of the above, it is, most respectfully prayed that Implementation Report may graciously be brushed aside and may be set at naught being devoid of legal footings and merits also imposing heavy cost and the judgment may kindly be implemented in letter and spirit.

- I. It is further prayed that Respondent No 2 may be directed for due rectification by revising the promotion of the Petitioner as Officiating Sub Inspector and confirmation as Sub Inspector above the name of private Respondents in Seniority Promotion List 'E' maintained by the Respondent No 2 and ex-post facto recommendation roll may also be forwarded to CPO for further necessary correction in Seniority List "F" of the Inspectors as directed by the DSC in its meeting dated 24/09/2019.
- II. Consequently, the Seniority in List-F of the Inspectors shall be rectified by placing the Petitioner above the name of Syed Sagheer Abbass Shah D/23 and below the name of Mohammad Imran D/26 in place of Private Respondent Fazal Rahim D/24 in order to save him from mental as well as financial agony besides further litigation.

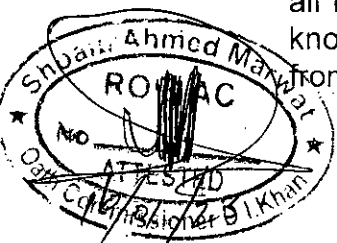



DECISION

The DSC examined his case and recommended that he may wait till the final outcome of the CPLA lodged in Supreme Court of Pakistan. In the meanwhile, AIG Legal may expedite process of early hearing for the CPLA.

2. APPLICATION OF INSPECTOR MINHAI SIKANDAR YAR KHAN

Minhaj Sikandar Yar Khan Inspector has lodged Service Appeal No. 1187/2014 for seniority against 21 promotee Sub-Inspectors. He has challenged the Seniority List vide Notification No. 883-89/ES, dated 12.03.2014 issued by DIG/D.I.Khan in which appellant was shown junior. The Police Department and Respondents officers have contested the case. The appellant was confirmed from date of appointment i.e. 07.03.2009 on completion of 03 years probation as PASI vide order dated 22.03.2012 and name brought on List "E" with immediate effect. Whereas Respondents were confirmed after 02 years probation period w.e. from 01.07.2009. Their names were brought on list "E" with immediate effect. (before the appellant).

The Khyber Pakhtunkhwa Service Tribunal, Camp Court DI Khan an Appeal No.1187/2014 dated 26.03.2019 has accepted the service appeal and impugned Seniority list dated 12.03.2014 set aside. The Respondents were directed to assign seniority to appellant from the due date.

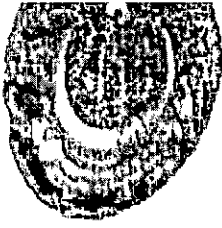
Request for CPLA was made to Scrutiny Committee Law Department. The case was discussed in the Scrutiny Committee on 24.04.2019 and was declared fit for lodging CPLA. Now the appellant has lodged Execution Petition before Camp Court D.I.Khan.

DECISION

The DSC examined his case and recommended that the judgment of Khyber Pakhtunkhwa Service Tribunal may be sent to RPO DI Khan for further necessary action in accordance with the law/rules because the issue of seniority in List-E is the legal mandate of the DIG/DI Khan. The RPO may decide the case as per facts and law within one week. Once this issue is settled by RPO DI Khan, the seniority in List-F shall be rectified by the Departmental Selection Committee.

3. APPLICATION OF DSP ZAHID-UR-REHMAN

Applicant Zahid-ur-Rehman DSP was confirmed as SI w.e. from 06.04.2006. He submitted representation to Worthy Inspector General of Police, Khyber Pakhtunkhwa


