- That the petitioners in separate Writ Petitions bearing No. 138-B of 2014, 408-B of 2013 and 387-B of 2015 dated 10/12/2015 and 10/09/2015 had approached this Hon'ble Court for the redressal of their grievances wherein this Hon'ble Court very much pleased issued directions to the respondents and the same were disposed off. - 3) That the petitioners have been kept on wait for indefinite period but very astonishingly respondents floated a fresh



advertisement in respect of the said posts of different categories for which the petitioners were interviewed and short listed .

- That respondents being habitual are not ready to comply with the clear-cut directions of this Hon'ble Court and are bent upon frustrating directions of this Hon'ble Court by publishing advertisement in the daily newspaper "Mashriq". (copy of the advertisement is annexed as annexure B).
- That since the petitioners are very much entitled to be appointed on the basis of their eligibility and merit list and if their appointments are not made in the near future, the petitioners would not only be deprived of their fundamental rights but it will also make spice.
- That respondents by publishing a fresh advertisement are trying to create troubles for the petitioners as well as the new candidates in response to the said advertisement. Hence this Contempt of Court Petition inter alia the following grounds.

**GROUNDS:** 

- A) That the case of the petitioners has already been strongly established and base on facts.
- B) That respondents reluctant to make appointment of the deserving petitioners on the bases of merit list.
- C) That afresh advertisement, interview and appointments will create troubles for the petitioners and new candidates in response to the said advertisement.
- D) That if, operation of the advertisement / proceeding on the said advertisement is not stayed/stopped it will create further









complication for the petitioners and the expected candidates in response to the said advertisement.

E) That respondents in the light of the clear-cut directions of this Hon'ble Court dated 10/12/2015 and 10/09/2015 have not been bother about the making a single appointment from the petitioners, therefore, on the grounds mentioned above and other to be submitted at the time of arguments, it is, most humbly prayed that on acceptance of this Contempt of Court Petition, the relief prayed for may please be extended.

Any other relief not specifically prayed for and deemed appropriate by this Hon'ble Court in circumstances of the case, may also be granted to the petitioner.
