

4. That on 10.03.2014 the competent authority on the recommendation of PSB promoted the appellant as Associate Professor (BPS-19) on acting charge basis against vacant post in GGDC (Hangu).
5. That appellant took charge and performed her duty to the entire satisfaction of their superior.
6. That on 09.08.2017 the appellant was promoted on regular basis in BPS-19 as Associate Professor and stood on Serial No.17 in the notification.
7. That when the tentative seniority list was prepared has been shown as Serial No.164 and appellant is seriously aggrieved from the impugned seniority list dated 20.11.2018 and filed departmental appeal on 13.02.2019, which was replied on 04.03.2019 and 24.09.2019, hence this service appeal is filed on the following grounds:-

GROUND S:

- A. That the department has not followed the law in preparation of seniority list and fundamental right of the appellant is violated.
- B. That impugned order dated 04.03.2019 and 24.09.2018, 20.11.2018 are illegal.
- C. That appellant has got unblemished record and there is no stigma in the service record of the appellant but appellant

has been shown junior to the others, which were junior to the appellant in the same cadre as well as in the date of promotion and appointment.

- D. That in the seniority list Serial No.34 (2012 promotion) 56, (2009 promotion), 95-104 (2009 promotion), 105 (promotion 2012), 106-122 (2009 promotion) 123 (2012 promotion) 124-129 (2009 promotion), 131-145 (2009 promotion), 146 (initial recruitment 20.11.2011) and 147 (initial recruitment 06.05.2010).
- E. And few others, which were promoted in BPS-18 latter in time from the appellant, while appellant was directly inducted in BPS—18 in 2008 but even then appellant has been shown junior from those who were promoted and selectees in 2012, 2009, 2010-2011.
- F. That it is discrimination with appellant and appellant is senior in all respect, date of appointment, date promotion and other basic rules of seniority, which is not followed by the department.
- G. The promotion is the discretion of department/ competent authority but seniority is the fundamental right of the appellant.
- H. The department is required to fix seniority in accordance with the rule-17 of Khyber Pakhtunkhwa Appointment, Promotion & Transfer Rules 1989 (E).

It is, therefore, prayed that on acceptance of this service appeal the impugned seniority list dated 20.11.2018 may be revised and appellant may be placed in the senior part of seniority list against the others shown in Serial No.34,56,95,129,131-147 and reply of departmental appeal dated 04.03.2019 may also be set aside.



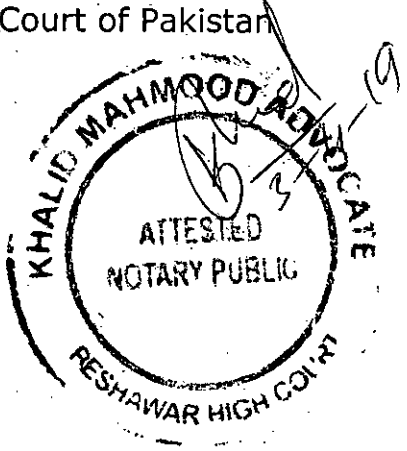

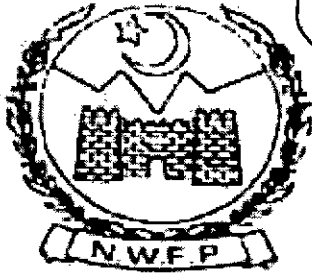
