





Learned counsel has produced today a copy of office order dated 01.04.2019 issued by Medical Superintendent, DHQ Hospital at Khar whereby the service of appellant was regularized from the date of his appointment i.e. 20.08.2003. The document is placed on record.

While referring to the notification dated 02.08.2017 issued by Elementary & Secondary Education Department it is contended that through amendment in the rules Daftaris, Generator Operators, Qasids and Naib Qasids including other equivalent posts in the attached departments were held eligible for promotion on the basis of seniority cum fitness having SSC qualification. The appellant duly fell within the category of other equivalent posts and is a holder of a Master Degree, hence fully qualified for consideration for promotion as Junior Clerk against 33% quota.

In view of available record and arguments of learned counsel, instant appeal is admitted for regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents. To come up for written reply/ comments on 10.10.2019 before S.B.

Alongwith the appeal there is an application for restraining the respondents from filling up the vacant posts of Junior Clerk/House Keeper till disposal of the appeal. Notice of the application be also given to the respondents for the date fixed. Till then at least one vacancy of Junior Clerk/House Keeper shall not be filled.



**PRAYER:**

That on acceptance of this appeal the appellant may very kindly be promoted to the post of Junior Clerk (BPS-11) under the 33% quota reserved for class-IV employees. Any other remedy which this august Court deems fit that may also be awarded in favor of the appellant.

**R/SHEWETH:**

**ON FACT:-**

- 1- That the appellant was appointed as Chowkidar (BPS-2) in the respondent Department vide order dated 20-8-2003. That after appointment till date the appellant performed his duty quite efficiently and upto the entire satisfaction of his superiors. Copy of the appointment order is attached as annexure ..... **A.**

- 2- That appellant is serving the respondent Department as Chowkidar since 2003 and has the qualification of M.A. That according to the seniority list of class-iv employees the appellant is at serial No.1 of the seniority list. That according to rules the appellant is entitle for promotion to the post of junior clerk/House Keeper under the 33% quota but the respondents are not willing to do the same. Copies of the Educational testimonials, seniority list and Notification are attached as Annexure ..... **B, C & D.**
- 3- That appellant feeling aggrieved from the inaction of the respondents filed Departmental appeal before the appellate authority for promotion to the post of Junior clerk/House Keeper (BPS-11) in the light of above mentioned 33% quota reserved for the class-iv employees but in response has been un-responded. Copies of the list & departmental appeal are attached as Annexure ..... **E & F.**
- 4- That there are four posts of junior clerk (BPS-11) and one post of House Keeper are lying vacant in the respondent Department but inspite of that the respondent Department is not willing to promote the appellant against the post of Junior Clerk/House Keeper (BPS-11) under the 33% quota reserved for Class-IV employees. Copy of record regarding vacant posts is attached as annexure.....**G.**
- 5- That feeling aggrieved and having no other remedy the appellant filed this appeal on the following grounds amongst the others.

**GROUND:**

- A- That not promoting the appellant to the post of junior clerk/House Keeper (BPS-11) by the respondents inspite of eligibility and seniority is against the law, facts and norms of natural justice.
- B- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondent Department acted in arbitrary and malafide manner by not promoting the appellant to the post of junior clerk/House Keeper (BPS-11) despite of having eligibility and the seniority.
- D- That according to the service structure and promotion orders already issued by the respondent No.3 and the appellant is

- A- fully entitled to be promoted to the post of junior clerk (BPS-11).
- B- That appellant is at the top of the seniority list of class-4 employees working at the office of the respondent No.4, therefore, the appellant has the right to be promoted to the post of junior clerk/House Keeper (BPS-11) under the 33% quota reserved for class-iv employees.
- C- The appellant seeks the permission to advance other grounds and proofs at the time of hearing.

It is therefore humbly prayed that the writ petition of the appellant may be accepted as prayed for.

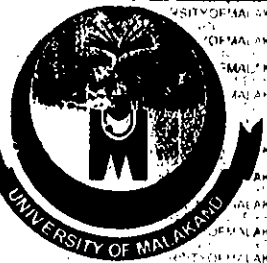

I am directed to refer to the subject noted above and to convey the judgment of Peshawar High Court Peshawar in Writ Petition No. 2334-P/2014 announced on 08.12.2015 in case of Mr. Niaz Muhammad Ward Orderly v/s. Chief Executive LRH & 05 others regarding his promotion under 33% quota.

"The Hon'able Court has declared null & void and are set aside the respondent No.1 and 2 and other over helms of affairs are directed to reconstitute the Selection and Promotion Committee afresh, who shall made approval for promotion strictly in accordance with the seniority list. The promotion would be deemed w.e.f 17.05.2013 and petitioner will be entitled for back benefits also from the said date. It is further directed that the judgment of this Court be implemented within one month according to law".

It is further clarified that the following quota should be observed in accordance with laid down rules/ policy of the Government:

1. Observance of 100% quota for deceased/permanantly incapacitated on medical board.
2. 25% quota for Class-IV employees who retired on the age of superannuation, who retired on sixty years of age according to matriculate seniority list.
3. 33% quota for promotion of Class-IV to Ministerial cadre only.

The Muslim Sweepers should be converted into Ward orderly or other Class-IV posts in accordance with two separate judgments of Peshawar High Court Peshawar in W.P 293-P/13 dated 2009 SCMR-I as well as Govt. of Khyber Pakhtunkhwa Health Department letter No. SOH-(Lit-I) 1-1/2017(Gen:Misc) dated 16.02.2017.

You are requested to please implement the above mentioned quota's in letter and spirit to avoid further complications faced by the above mentioned employees including MTIs.



4. That, the Honorable Tribunal has no jurisdiction to adjudicate the matter under S. 4(b)(i) of the KP Service Tribunal Act 1974.


### FACTS

The complete seniority list of all Class-IV employees working in DHQ Hospital Bajaur is attached at **Annex-A** wherein the position of the appellant can be seen at S. No. 69 which means he is not entitled for promotion as Junior Clerk BPS-11 and will for his turn.
3. Incorrect, the appellant did not submit appeal for the purpose and as per attached seniority list, the appellant is not coming under the ambit of 33% quota.
4. Incorrect, there is only one post of Junior Clerk is available in DHQ Hospital Bajaur while the appellant is at S. No. 69 in the seniority list, is not entitled for promotion. He will wait for his turn.
5. Incorrect, in light of the attached seniority, the appellant has no right to file the instant appeal. He will wait for his turn.

- A- Incorrect, as per attached seniority list, the appellant is not entitled for promotion and will wait for his turn.
- B- Incorrect, as stated above.
- C- Incorrect, as stated in Paras.
- D- Incorrect, there is no such order on the record.
- E- Incorrect, as per attached seniority list, the position of the appellant can be seen at S. No. 69, hence, is not entitled for promotion.
- F- No comments.

In light of the attached seniority list, the appellant is not entitled for promotion, therefore, it is humbly prayed that the appeal may please be dismissed.
