Preliminary Objections:

(1-6) All objections raised by the respondents are incorrect and baseless. Rather the respondents are estopped to raise any objection due to their own conduct.

So the appellant is entitled for seniority and other relief with his colleagues.

- 6. Admitted correct by the respondents needs no comments.
- 7. Incorrect. While Para-7 of the appeal is correct. Moreover, the appellant was confirmed as S.I and promoted to the rank of Officiating Inspector in the Year 2015 and confirm as Inspector in the Year 2017.
