# Respectfully Sheweth:

#### **FACTS OF THE CASE**

- 1. That the appellant joined the Police Force as Constable on 01-03-2020 and from day one of his service, he performed his statutory duties to the entire satisfaction of his superiors and about with full devotion and honesty.
- 2. That on 12-01-2023, the appellant while posted as constable at police post Mazanga Haved Bannu had a serious health emergency while leaving for his daily duty and was not able to perform his services for a day..

- 3. That unfortunately on 18-01-2023 the respondent No-3 passed the impugned order and imposed the major penalty of Dismissal from service upon the appellant on the pretext of absence from duty, disregard of the rules and procedure provided under the law. (Copy of the notification and dismissal are attached as annexure A and B).
- 4. That feeling aggrieved the appellant filed his departmental appeal before the respondent No-2 but the appellate authority (respondent No-2) rejected the departmental appeal of the appellant vide impugned final order dated 20-04-2023. It is strange and surprising that after the impugned order of dismissal from service dated 18-01-2023 a show cause notice dated 19-01-2023 was served upon the appellant, which is illegal and a blatant violation of the law, procedure and rules. (Annex C, D and E)
- 5. That the appellants revision petition regarding reinstatement has been communicated to respondents no 01 on 08/06/2023 but no reply or response till this date with in statutory period.

Hence the present appeal is being filed inter alia on the following grounds:

#### **GROUNDS:**

- A. That both the impugned orders are passed without due process of law, therefore, illegal and void.
- B. That the impugned order dated 18-01-2023 passed by respondent No-3 is based on malafide as the Authority passed the impugned order, ibid on 18-01-2023 while served the show cause notice dated 19-01-2023 upon the appellant after the issuance of impugned order, thus entire proceeding is illegal, void and unsustainable under the law.
- C. That before passing the impugned order dated 18-01-2023 no inquiry was conducted through inquiry committee/inquiry officer to dig out the truth and impugned order was passed in a haphazard manner in haste, therefore, all proceedings and impugned orders are arbitrary and liable to be set- aside.
- D. That before issuance of impugned order dated 18-01-2023 and final order dated 20-04-2023 by competent authority and appellate authority, no chance of personal hearing was afforded to the appellant, thus the appellant was condemned unheard in clear violation of the rules and principles of natural justice. The action of the respondents is in utter violation of Article 10-A of the Constitution of Islamic Republic of Pakistan, 1973 which reads as under:

"Right to fair trial. For the determination or his civil rights and obligations or in any criminal charge against him a person shall be entitled to a fair trial and due process.

- E. That it is pertinent to mention here that his fellow colleagues (constables) who were dismissed along with him on the same date were reinstated in the services by this Hon'ble Court. (attested copies of the order is attached)
- F. That both the impugned orders passed by respondents are harsh and not proportionate to guilt of the appellant. The august Supreme Court of Pakistan time and again reiterated that the penalty should proportionate to the guilt of the delinquent civil servant. (2006 SCMR-443)
- G. That the appellant seeks the permission of this Honourable Court for further additional grounds at the time of arguments.

In view of the aforesaid facts and circumstances of the case it is humbly prayed that the impugned order dated 18-01-2023 passed by respondent No-3 and Final order dated 20-04-2023 passed by respondent No-2 both may graciously be set aside being illegal and void, directing the respondents to reinstate the appellant into service with all back benefits.

Any other relief if this court deems appropriate in the circumstance of the case may also be granted in favour of appellant.

## ORDER:

This order will dispose of departmental appeal, preferred by Ex-Cook constable Rizwan Khan No. 2291 of District Bannu, wherein he has prayed for setting aside the order of major punishment of "Dismissal from service", imposed upon him by DPO Bannu vide OB No. 58 dated 18.01.2023 for committing of following misconduct:

 That as reported by SDPO Rural-I, Bannu, the appellant was found absent without any sanctioned leave or prior permission from the competent authority. The appellant did not perform his duty efficiently. He did not pay attention to the directions issued by he DPO Bannu and did not mend his way. He is habitual absentee.

Comments, service record and other relevant papers were received from DPO Bannu vide his office letter No. 968/SRC, dated 21.02.2023 and perused in detail. The DPO Bannu has reported that the appellant was issued Show Cause Notice vide No. 18/SRC dated 17.01.2023 but his reply was found unsatisfactory. The appellant being habitual absentee, his further retention in service would be determental and burden over the shoulder of the department. In the current situation of terrorism his absence has put other officials of the concerned Police Post at risk. His plea was not found convincing. He had recruited an "Iwazi" at a rate of Rs; 10,000/- per month to perform duties in his place while he himself was doing private business. The introduction of his dirty culture is extremely dangerous in police department and cannot be allowed to go unchecked.

Therefore, I Syed Ashfaq Anwar PSP, Regional Police Officer, Bannu Region Bannu, in exercise of the powers vested in me under Khyber Pakhtunkhwa Police Rules, 1975 (amended in 2014) hereby reject his appeal and endorse the punishment awarded to him by DPO Bannu vide OB No. 58 date 18.01.2023.

This order will dispose of departmental appeal, preferred by Ex-Cock constable Rizoran Khan No.2291 of District Bannul, wherein he has prayed for selling aside the order of major punishment of "Dismissal from service", imposed upon him by DPO Bannu vide OB No.58 dated 18.01.2023 for committing the following misconducts

That as reported by SDPO Rural-1, Dannu, the appellant was found absent without any sanctioned leave or prior permission from the competent authority. The appellant did not perform his duty efficiently. He did not pay attention to the directions issued by the DPO Bannu and did not mend his way. He is habitual absence.

Comments, service record and rober relevant papers were received from DPO Banou-vide his office letter No.968/SRC, dated 21.02.2023 and perused in detail. The DPO Banou has reported that the appellant was issued Show Cause Notice vide No.18/SRC dated 17.01.2023 but his reply was found unsatisfactory. The appellant being habitual absence, his further retention in service would be detrimental and burden over the shoulder of the department. In the current situation of terrorism his absence has put other officials of the concerned Police Post at risk. Therefore, the competent authority (DPO Banou) has awarded the appellant major punishment of "Dismissal from Service" vide OB No. 58 dated 18.01.2023. The appellant was beard in person in orderly room held in RPO Office Banou on 06.04.2023. This plea was not found convincing. He had recruited an "Iwazi" at a rate of Rs:16.000/- per month to perform duties at his place while he himself was doing private business. The introduction of this dirty culture is extremely dangerous in police department and cannot be allowed to go unchecked.



## JUDGEMEN'T

FAREEIIA PAUL, MEMBER (E): Through this single judgment, we intend to dispose of instant appeal as well as connected Service Appeal No. 980/2023 titled "Navab Khan Versus Province of Khyber Pakhtunkhwa through Inspector General of Police, Peshawar and others", as in both the appeals common questions of law and facts are involved.

The service appeal in band has been instituted under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the order dated 18.01.2023, passed by respondent No.3, whereby the appellant was awarded the major penalty of dismissal from service and his departmental

appeal was repeated by respondent No. 2 vide impugned final order dated 20.04.2023 in disregard of the rules and principles of natural justice, with the prayer to set uside both the impugned orders and reinstate the appellant into service with all back benefits, alongwith any other relief which the Tribunal deemed appropriate.

- Brief facts of the case, as given in the memorandum of appeal, are that the appellant joined the Rolice Force as Constable on 01.01.2015. On 18.01.2023, the respondent No.3 passed the impugned order and imposed the major penalty of dismissal from service upon the appellant on the pretext of absence from duty. Feeling aggrieved, the appellant filed his departmental appeal before the respondent No. 2 but the appellate authority rejected his departmental appeal vide impugned final order dated 20.04.2023. After the impugned order of dismissal from service dated 18.01.2023 a show cause notice dated 19.01.2023 was served upon the appellant, which was illegal and a blatant violation of the law, procedure and rules; hence the instant service appeal.
- 3. Respondents were put on notice who submitted their reply/comments on the appeal. We heard the learned counsel for the appellant as well as the learned District Attorney for the respondents and perused the case file with connected documents in detail.
- 4. Learned counsel for the appellant, after presenting the case in detail, argued that impugued orders were passed without due process of law and hence they were illegal and void. He further argued that the impugued order was was passed on 18.01.2023 while the show cause notice was served

making the entire proceedings illegal, void and unsustainable under the law. He further argued that before passing the impugned order, no proper inquiry was conducted to dig out the truth and that the order was passed in a haphazard manner. No chance of personal hearing was afforded to him and he was condemned unheard. According to him, the impugned order was in violation of Article 10-A of the Constitution of Islamic Republic of Pakisian. He requested that the appeal might be accepted as prayed for.

Learned District Attorney, while rebutting the arguments of learned counsel for the appellant, argued that the appellant was appointed as a Cook Constable but he did not perform his duty regularly and was a habitual absentee. According to him on 13,01.2023, SDPO Rural-I found him absent from the official day and it was found that he had hired a private person for cooking, in his place. He further argued that punishment was imposed after observing all the codul formalities and his departmental appeal was rejected being decend of merit. He referred to Section 5, sub section (3) of the Khyber Pakhtunkhwa Police Rules, 1975 and stated that as per the said rule, the punishment proceedings would be of two kinds, (a) Summary Police Proceedings and (b) General Police Proceedings. He read out sub-section 3 that if the amborny decided that the misconduct or act of emission or commission should be dealt with in general police proceedings, it should determine it in the light of facts of the case or in the interest of justice, a departmental enquiry, through an enquiry officer was necessary. He further stated that if the authority decided that it was not necessary then he should,

by order in writing intorm the accused of the action proposed to be taken and give him a reasonable opportunity of showing cause against that action.

The requested that the appeal might be dismissed.

- Arguments and record presented before us shows that the appellant ά. was appointed as cook constable in provincial police in 2015. Through the impugued order dided 18.01.2023, he, along with five other constables, was diamissed from acroise on the charge of absence from duty by the District Police Officer, Banqu. Later on, a show cause notice was issued to him. alongwith four other consubles, under rules 5(3) of Police Rules 1975, on 19.01.2023 and he was directed to submit reply within seven days of the ruccipi of that notice, failing which ex-parte action would be taken against him. It has been noted that the DPO Banua did not bother to give any heed to the rules under which he had to proceed against the appellant. He issued the order of dismissal first and later on, as an afterthought, issued a show gange notice on the next day. The rule to which he was referring in the show cause notice, i.e Rule 5(3) of the Khyber Pakhtunkhwa Police Rules 1975, clearly mentions that a reasonable opportunity of showing cause had to be given to the appellant before passing any order of punishment, which was not done in this case. It has been further noted that the charge of absence is also not specified in the dismissal order.
- The dismissed from service without following the due process. He had been awarded a major punishment without giving him any opportunity of defence, which is highly against the spirit of fair trial. The service appeal in
