#### **JUDGMENT**

MUHAMMAD AMIN KHAN KUNDI, MEMBER: - Appellant alongwith his counsel and Mr. Anwar-ul-Haq, Deputy District Attorney alongwith Mr. Khawas Khan, S.I (Legal) for the respondents present. Arguments heard and record perused.

2. Brief facts of the case as per present service appeal are that the appellant was serving in Police Department as Head Constable. He was imposed major penalty of removal from service vide order dated 03.12.2018 on the allegation

of having illicit relation with wife of one Umer Bacha who was mother of three children. The appellant filed departmental appeal on 12.12.2018 which was not responded hence, the present service appeal.

- 3. Respondents were summoned who contested the appeal by filing written reply/comments.
- 4. Learned counsel for the appellant contended that the appellant was serving in Police Department as Head Constable. It was further contended that the appellant was imposed major penalty of dismissal from service vide order dated 03.12.2018 on the aforesaid allegation. It was further contended that neither charge sheet, statement of allegation was served upon the appellant nor proper inquiry was conducted nor the appellant was associated during the inquiry proceeding therefore, the appellant was condemned unheard which has rendered the whole proceeding illegal and liable to be set-aside and prayed for acceptance of appeal.
- On the other hand, learned Deputy District Attorney for the respondents opposed the contention of learned counsel for the appellant and contended that the appellant was serving in Police Department as Head Constable. It was further contended that the appellant was imposed major penalty of removal from service vide order dated 03.12.2018 on the aforesaid allegation. It was further contended that a proper inquiry was conducted and the inquiry officer has stated in the inquiry report dated 25.01.2019 that after preliminary inquiry it was found that the appellant was having illicit relation with the wife of Umer Bacha and the wife of complainant Umer Bacha also lodged report against her husband and was sent to Dar-ul-Aman. It was further contended that the inquiry officer has also stated in the inquiry report that the minor daughter of the Umer Bacha also stated that the appellant was having illicit relation with her mother and used to contact her mother with mobile phone and on the basis of

inquiry report the appellant was rightly removed from service after fulfilling all the codal formalities and prayed for dismissal of appeal.

6. Perusal of the record reveals that the appellant was serving in Police Department as Head Constable. The record further reveals that the appellant was imposed major penalty of removal from service vide order dated 02.12.2018 on the allegation of having illicit relation with the wife of Umer Bacha who was mother of three children. The record further reveals that charge sheet, statement of allegation was framed and served upon the appellant and proper inquiry was also conducted. The record further reveals that it was stated by the inquiry officer in the inquiry report that the appellant was having illicit relation with the wife of Umer Bacha who was mother of three children. The record further reveals that the wife of Umer Bacha also lodged a report against her husband due to her illicit relation with the appellant. The record further reveals that the wife of Umer Bacha also filed dissolution against her husband due to illicit relation of appellant. The inquiry officer has also stated that the appellant was proved guilty of misconduct and had ruined the house of complainant Umer Bacha and recommended him for major punishment. Meaning thereby that the appellant was found guilty by the inquiry officer in the inquiry proceeding therefore, he was rightly imposed major penalty of removal from service after fulfilling all the codal formalities. As such, the appeal has no force which is hereby dismissed with no order as to costs. File be consigned to the record room.

Respectfully Sheweth:

Facts arising to the present appeal are as under;

1) That appellant was initially recruited in police department as Constable in 2009 and after



qualifying various courses, the appellant was promoted to the rank of Head Constable.

- 2) That the appellant has performed his duty with honesty, great zeal and enthusiasm.
- That on 20/08/2018 the respondent No.2 issued a 3) charge sheet to the appellant vide No. 86/PA, in which the allegations leveled against the appellant as "whereas, one namely Umar Bacha S/o Zarkash Mian R/o Salanda Manglawar, had lodged an application alleging you of having illicit relation with her wife, who is mother of three children and employing ways to lower her for maintaining the relations." applicant had further complained that you had ruined his house and trying to turn his wife against (applicant). The complainant was enquired through Additional SP Swat. the enquiry revealed preliminary the applicant's complain is based on truth and you are ruing his house despite being the father of three children. You are having an illicit relations with a married girl which is against discipline and warrants strict departmental

action. You are therefore, issued this charge sheet and statement allegations. (Copy of charge sheet along with better copy of charge sheets are annexed herewith as annexure "A")

- the charge sheet, issued by respondent No.3 but without conducting proper enquiry and without reaching to the real facts and without giving opportunity of hearing to the appellant.

  The respondent No.3 straight away dismissed the appellant from service vide OB No. 195 dated 03/12/2018. (Copy of dismissal order is attached herewith as annexure "B")
- 5) That the appellant submitted the respondent No.4 application to obtaining photocopies of the mentioned above for the purpose to file departmental appeal before respondent No.2, but in vain. The respondent No.4 straight away denied. the appellant Then moved application before respondent No. 10/12/2018 to the extent that respondent No.3 may kindly be directed to issue complete



documents of the mentioned enquiry but in vein. This fact has already been brought in the notice of respondent No.2 in Para No.3 of the departmental appeal. (Copy of application to respondent No.2 is annexed herewith as annexure "C")

- appeal before respondent No.2, which is still pending before him and the stipulated period prescribed for the disposal of departmental appeal has been lapsed, hence, the instant service appeal. (Copy of departmental appeal is annexed herewith as annexure "D")
- 7) That no proper opportunity of being fairly heard, was given to appellant by respondent No. 3 and illegally dismissed the appellant from service which is against law and service rules and norms of natural justice.

Hence the present appeal is submitted on the following amongst other grounds.

### **GROUNDS: -**

i. That the appellant was not treated in accordance with law and rules on the



subject and the impugned order has been passed in flagrant violation of law and rules tainted with mala-fide intention and is therefore not sustainable and is liable to be set aside.

- ii. That the allegations leveled against the appellant are baseless, frivolous and not sustainable and untenable under the law and rules on the subject.
- iii. That neither proper inquiry of the appellant was conducted nor proper opportunity of hearing was given to the appellant.
- iv. That the universal cannon of natural justice

  have been set aside and no ample

  opportunity of presenting the delinquent

  stance / version has been given.
- v. That no opportunity of cross examination have been given to the appellant so that the appellant may cross examined the so called applicant namely Umar Bacha.
- vi. The impugned order is unreasonable, arbitrary and is liable to be set aside.



vii. That other important points will be raised during the course of arguments with prior permission of this Honorable Tribunal.

It is therefore, humbly prayed that on acceptance of this service appeal, the impugned order of respondent No. 2 may graciously be set aside and appellant may be reinstated in service with all back benefits.

Any other relief as deemed appropriate in the circumstances of the case and not specifically asked for may also be granted to appellant.

#### ORDER

This order will dispose of Departmental Enquiry against Head Constable Muhammad Ali No. 2122 of this District Police. He while posted to Police Lines Kahal was alleged of gross misconduct as one namely Umar Bacha s/o Zarkash Mian r/o Salanda Manglore had lodged an application, alleging him of having illicit relations with his wife, who is mother of three children, and employing ways to lure her for maintaining the relations. The applicant had further complained that he had ruined his house and trying to turn his wife against him (applicant). Addl: SP Swat initially probed the complaint and reported that the applicant's complaint was based on truth and the delinquent Head Constable was having illicit relations with his wife. The Enquiry Officer recommended departmental enquiry against the respondent Head Constable.

No. 86/PA, dated 20-08-2018 and SP Investigation, Swat was appointed as Enquiry Officer to conduct proper departmental enquiry against the delinquent Head Constable. The Enquiry Officer carried out regular enquiry against the Police Officer and submitted his findings. The Enquiry Report revealed that the Head Constable under enquiry enjoyed illicit relations with the applicant's wife which resulted into separation between the applicant and his wife. The Enquiry Officer held the Head Constable guilty of misconduct and recommended major punishment for hun.

Constable under enquiry had illicit relations with a married girl which ruined the applicant's house and resulted into dissolution of his marriage. By doing so the Head Constable has stagmatised Police Department and harmed sanctify of the Force. His conduct is detrimental to discipline and his further retention in Police is bound to affect the conduct of other personnel of the Force. Hence, in exercise of the powers vested in the undersigned under Rules 2 (iii) of Police Disciplinary Rules — 1975, I Syed Ashfaq Anwar, PSP. District Police Officer, Swat being competent authority, am constrained to award him major punishment of removal from service with immediate effect.

## PRELIMINARY OBJECTIONS.

- 1. That the appeal is badly barred by Law & limitation.
- 2. That the appellant has got no Cause of action and locus standi to file the present appeal.
- 3. That the appeal is bad due to misjoinder and nonjoinder of necessary parties.
- 4. That the appellant has not come to the Tribunal with clean hands.
- .5. That the instant appeal is not maintainable in its present form.
- 6. That the appellant has concealed the material facts from this Hon'ble Tribunal.

## **FACTS:**

- 1. Correct that the appellant was enlisted as constable in the year 2009 and has not regularly promoted to the rank of Head Constable and was drawing pay in the rank of Constable before removal from service. Copy of pay slip enclosed as annexure "A"
- 2. Incorrect. During service his performance was not satisfactory, besides the charges of illicit relation with a married woman he was awarded 07 minor punishments for wilfull absence from official duty. List enclosed as annexure "B".
- 3. Pertain to record, hence needs no comments.

- 4. Correct to the extent the reply of the appellant to the charge sheet was found unsatisfactory. Proper enquiry through Addl: SP, Swat and SP Investigation Swat was conducted, wherein all the opportunities of self defense were provided to the appellant. Copy of finding reports enclosed as annexure "C" & "D".
- 5. Incorrect. Respondent No.04 has provided all the relevant public documents record to the appellant and on the basis of the same documents appellant has filed the departmental appeal to the respondent No.02
- 6. Incorrect. The departmental appeal of the appellant is not based on cogent reasons and liable to be filed after hearing of appellant and going through complete record.
- 7. Incorrect. All the opportunities of self defense were provided to the appellant during the course of enquiry and after conducting proper enquiry through competent Enquiry Officer, wherein the charges were proved and the appellant was awarded punishment in accordance with facts and rules.

### **GROUNDS:**

## FINDINGS

This report relates to the Departmental Enquiry against LHC Muhammad Ali No.2122 JIS Police Line Kabal who has been charge sheeted vide District Police Officer, Swat in the light of allegations leveled in the application moved by one Umar Bacha s/o Zarqaish Mian r/o Salanda Manglor to the effect that the said LHC has illicit relations with his wife Mst. Sajida who is mother of three minor Kids and due to this act of LHC Muhammad Ali the applicant's house has been destroyed.

In order to probe into the matter, preliminary enquiry was entrusted to Addl: SP Swat, who thereof has declared LHC Muhammad Ali as defaulter of the allegations leveled against him. Accordingly he was issued Charge Sheet and the undersigned has been appointed as Enquiry Officer for conducting Departmental Enquiry.

Synopsis of the departmental enquiry reveals that:-

- 1. Mst: Sajida who is residing at Darul Aman Saidu Sharif has denied the allegations leveled against LHC Muhammad Ali by her husband Umar Bacha, however disclosed that she has instituted a civil suit for Nikah Dissolution "KHULA").
- 2. LHC Muhammad Ali was heard in person who described the allegations leveled against him as baseless and concocted but disclosed Mst. Sajida as one of his far relatives nothing else.
- 3. The applicant Umar Bacha in his statement has supported the contents of his application with little bit addition that his wife has now been carried away from Darul Aman Saidu Sharif by the respondent (LHC Muhammad Ali).
- 4. Statements of Fazal Wahid and Abdul Wahid (brothers of Mst. Sajida) were also recorded which revealed that their sister now a days has left Darul Aman and is living with one of her relatives elsewhere.

#### BRIEF CIRCUMSTANCES:-

Muhammad Ali it has been surfaced that Mst: Sajida D/O Abdul Halleem r/o Salanda Manglor presently residing at Darul Aman Saidu Sharif was married to one Umar Bacha (applicant) and she gave birth three children (one boy & two girls) are alive. The applicant Umar Bacha being a poor person is laboring to drive a Suzuki van owned by his maternal uncle. Due to strained relations between the couple they usually used quarrelling with harsh words to each other. Ultimately on 22/02/2018 Mst. Sajida instituted civil suit in the Court of Senior Civil Judge / Alla Illaga Qazi Swat for dissolution of "Nikah" and requested for residing in Darul Aman Saidu Sharif which was accepted by the Court and she started living there. During trial of the civil suit, despite of repeated notices from the concerned court.

John party (Umar Bacha) did not bother to appear before the Court for the lawful proceedings, which resulted into extparte decision of Degree Juding "Nikah" dissolution in favour of Mst. Sajida by the Court.

During the course of enquiry two different versions have come to

Motice:

1. The applicant Umar Bacha has blamed LHC Muhammad Ali for abetment of his wife Mst: Sajida which resulted into disturbance of his house atmosphere.

2. Mst: Sajida has urged that she has sought dissolution of married life from her husband Umar Bacha because of his ill reputation and repeated misbehavior.

As per statement of child Hamida Bibi 11/12 years old, she has 4 times witnessed LHC Muhammad Ali while coming to their house and having conversation with her mother Mst. Sajida. Similarly, a report of LHC Muhammad Ali has also been entered into Daily Diary No.88 dated 04/05/2018 for misplacement of his SIM No.0342-9835672, which indicates concealment of his relations and contacts with the said lady. Furthermore, Mst. Sajida instituted an application in the Court of AAC Swat requested therein that she has completed her normal duration of "Divorce" and wants to be remarried with LHC Muhammad Ali who has also shown his willingness in this regard through an affidavit rendered by him. However, the AAC Swat being not the authorized forum for Court marriage declined the request. For the purpose, on 03/08/2018 she resorted to the Court of ASJ-VI in this regard but when she came to know about the departmental proceedings against LHC Muhammad Ali ultimately withdrawn her application and again requested to leave to elsewhere from Darul Aman. Her request was accepted by the Court and she accordingly left Darul Aman. The whole episode ultimately indicates, close relations between LHC Muhammad Ali and Mst. Sajida,

CONCLUSION:-

From the facts so far verified, I have reached to the conclusion that actually there were close relations between LHC Muhammad Ali and Mst: Sajida, which resulted into dissolution of Nikah with her husband applicant Umar Bacha. Due to which the bright future happy family husband, wife and their three children has gone towards darkness. Respondent LHC Muhammad Ali being member of a discipline force of Police Department who is considering well, responsible to ensure peace, tranquility and harmony amongst the general masses as well as to protect and secure life, prosperity and property of citizen has misused his lawful responsibility by indulging himself in doubtful interaction.

## ECOMMENDATION:

with the verdict of the preliminary Enquiry Officer Addl: SP Swai and recommend. LHC Muhammad Ali to be awarded major punishment, please.
